We the residents of Mand Ram Park F-Block bring the following points for your kind consideration and favourable early action pl. :

1. A list of 1071 unauthorised Colonies of Delhi was issued by Urban Development Deptt. and sent to D.V.B. for electrification of these colonies. Our colony Mand Ram Park F Block, Uttam Nagar is a very old colony and existing for more than thirteen years. For getting NOC of this colony office of Town Planner was approached several times and all necessary documents were submitted long back. But all our efforts in this regard yielded no results. In the records of Town Planning our colony is listed at Sl. No. 262.

2. In the list under reference due to oversightness instead of Mand Ram Park F Block and Mand Ram Park G Block, Mand Ram Park G Block was listed at two different serial numbers. Actually at One place it should be Mand Ram Park F Block.

3. Due to this error it became very difficult for the residents of Mand Ram Park F Block to deposit the development charges for the electrification of this colony well in time.



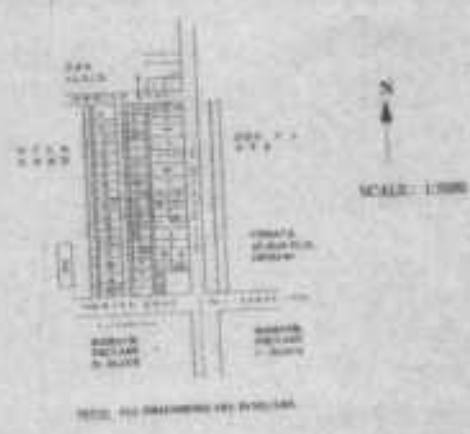

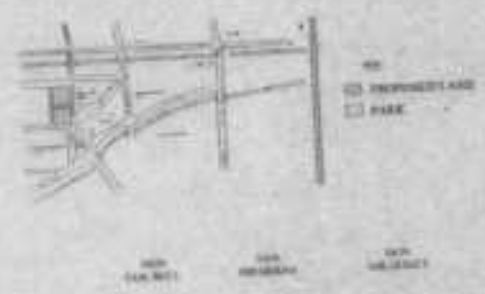
