Alleged Breach: Without the benefit of planning permission, the unauthorised change

of use of agricultural land to storage of skips and containers

Type of Notice issued: Enforcement Notice

**Reasons Issued:** 

- a) The presence of the skips, metal containers and consolidated surface fails to conserve or enhance the character and local distinctiveness of the rural landscape, contrary to policy NE.1 of the Bath and North East Somerset Local Plan (including minerals and waste policies) adopted October 2007.
- b) The increased use of the existing sub-standard access together with the generation of additional conflicting traffic movements, resulting from the proposed development, would be prejudicial to road safety. The horizontal alignment of the existing access is likely to result in excessive manoeuvring on the highway, with consequent risk of additional hazard to all users of the road. Contrary to policy T.24 of the Bath and North East Somerset Local Plan (including minerals and waste policies) adopted October 2007.
