

Water level increasing in several lakes thanks to bountiful rain

Chennai, Nov 15: Many waterbodies in Chennai's three neighbouring districts getting filled up due to bountiful rain.

In Kancheepuram and Chengalpattu districts, nearly 187 of the 909 lakes have storage between 76% and 99%.

A large number of waterbodies in these districts are already filled to 50% of their capacity.

Officials said many major lakes in Kancheepuram and Chengalpattu districts, including Thenneri, Sriperumbudur and Kolavoy, are either fast filling up or already filled to their capacity.

The Palar has been in full flow this monsoon and Vayalur check dam in the tail-end of the river was filled up on Sunday.
