5.5	Submission of Technical Compliance Statement (ANNEXURE-A) for the tendered item is a pre-requisite for evaluation. Therefore the same must be enclosed with the technical part. Any falsification / suppression of facts in the compliance statement would lead to the rejection of the quote.
5.6	In case the Purchase Order is placed on the Principal Manufacturer through their authorized Resellers/System Integrators/Partners and in the event the authorization of the Indian authorized Resellers/System Integrators/Partners is withdrawn from the Principal Manufacturer, then it shall be the responsibility of the Principal Manufacturer to continue providing the services and support to C-DOT either directly or through their newly appointed Indian authorized Resellers/System Integrators/Partners.
5.7	If, at any time, during the performance of the Purchase Order, the Bidder encounters conditions impeding timely rendering of AMC Services, then they should promptly notify C-DOT, in writing, of the fact of the delay, the cause of delay and its likely duration. C-DOT shall evaluate the situation and at its discretion, decide to extend the Bidders, time for performance. C-DOT's decision will be final and binding
5.8	The specifications & scope of AMC are not exhaustive. If any Technical services which are not included in tender but are essential for performance of AMC, then such services shall also be deemed to be included in the specifications & Scope of AMC.
5.9	C-DOT reserves the right to obtain feedback from the clients / customers of the bidder regarding rendering / undertaking of AMC Services. The feedback of the clients will be one of the decisive factors to technically shortlist the bidders quote
5.10	Financial Bids of only the technically qualified bidders will be opened, after receipt of technical evaluation report from the Committee / User Group.
5.11	L1 Tenderer will be decided as per the total value of all the lines based on the Total cost provided in the BOQ [i.e total value for all the lines referred in clause 4.1 (a,b) & clause 4.2 (a,b)]. Bidders have to quote for all the lines indicated in BOQ.
5.12	FORCE MAJEURE shall mean and be limited to War hostilities, riot or civil commotion, earthquake, flood or other natural physical disaster and restriction imposed by the Government or their statutory bodies which prevents or delays the execution of the contract. In the event of delay lasting over one month, if arising out of cases of Force Majeure, C-DOT will still reserve the right to cancel the order/contract.
