### **NOTICE OF HEARING (AUTOMATIC FINE)**

A hearing will be held in this case before the Florida Elections Commission on, February 28, 2017 at 11:00 am, or as soon thereafter as the parties can be heard, at the following location: Senate Office Building, 404 South Monroe Street, Room 110-S, Tallahassee, Florida 32399

Failure to appear in accordance with this notice will constitute a waiver of your right to participate in the hearing. Continuances will be granted only upon a showing of good cause.

This hearing will be conducted pursuant to Section 106.25, Florida Statutes, which governs your participation as follows:

If you are the Respondent, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission. However, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless you request to be heard or the Commission requests that your case be considered separately on the day of the hearing, your case will *not* be individually heard.

If you are the Complainant, you may attend the hearing, but you will *not* be permitted to address the Commission. In addition, some cases (including those in which consent orders or recommendations for no probable cause are being considered) may be decided by an *en masse* vote and, unless the Respondent requests to be heard or the Commission requests that the case be considered separately on the day of the hearing, the case will *not* be individually heard.

If you are an Appellant, and you have requested a hearing, you may attend the hearing, and you or your attorney will have 5 *minutes* to present your case to the Commission.

Please be advised that both confidential and public cases are scheduled to be heard by the Florida Elections Commission on this date. As an Appellant, Respondent or Complainant in one case, you will *not* be permitted to attend the hearings on other confidential cases.

The Commission will electronically record the meeting. Although the Commission's recording is considered the official record of the hearing, the Respondent may provide, at his own expense, a certified court reporter to also record the hearing.

If this is a hearing to consider **an appeal from an automatic fine**, the Filing Officer has imposed a fine on you for your failure to file a campaign treasurer's report on the designated due date and, by filing an appeal, you have asked the Commission to consider either (1) that the report was in fact timely filed; or (2) that there were unusual circumstances that excused the failure to file the report timely. You are required to prove your case. If the Commission finds that the report was filed timely or that there were unusual circumstances that excused the failure, it may waive the fine, in whole or in part. The Commission may reduce a fine after considering the factors in Section 106.265, Florida Statutes. If the Commission finds that the report was not timely filed and there were no unusual circumstances, the fine will be upheld.

If this is a hearing to consider a **consent order before a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed and become public. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the case will remain confidential, unless confidentiality has been waived.

If this is a hearing to consider a **consent order after a determination of probable cause has been made**, the Commission will decide whether to accept or reject the consent order. If the Commission accepts the consent order, the case will be closed. If the Commission rejects the consent order or does not make a decision to accept or deny the consent order, the Respondent will be entitled to another hearing to determine if the Respondent committed the violation(s) alleged.

If this is a **probable cause hearing**, the Commission will decide if there is probable cause to believe that the Respondent committed a violation of Florida's election laws. Respondent should be prepared to explain how the staff in its recommendation incorrectly applied the law to the facts of the case. *Respondent may not testify, call others to testify, or introduce any documentary or other evidence at the probable cause hearing.* The Commission will only decide whether Respondent should be *charged* with a violation and, before the Commission determines whether a violation has occurred or a fine should be imposed, Respondent will have an opportunity for another hearing at which evidence may be introduced.

If this is an **informal hearing**, it will be conducted pursuant Sections 120.569 and 120.57(2), Florida Statutes; Chapter 28 and Commission Rule 2B-1.004, Florida Administrative Code. At the hearing, the Commission will decide whether the Respondent committed the violation(s) charged in the Order of Probable Cause. The Respondent will be permitted to testify. However, the Respondent may not call witnesses to testify.

Respondent may argue why the established facts in the Staff Recommendation do not support the violations charged in the Order of Probable Cause. At Respondent's request, the Commission may determine whether Respondent's actions in the case were willful. The Respondent may also address the appropriateness of the recommended fine. If Respondent claims that his limited resources make him unable to pay the statutory fine, *he must provide the Commission with written proof of his financial resources* at the hearing. A financial affidavit form is available from the Commission Clerk.

#### DATE FIRST NOTIFICATION WAS SENT:

SUMMARY: Firefighter FACT PAC is a political committee (PC) registered with the State of Florida. The PC's chair is Mr. Jose Gonzalez and its treasurer is Mr. Angelo D'Ariano.

The PC is appealing the fine claiming that unusual circumstances caused the 2016 P1 Report to be untimely filed. According to Mr. Bielecky, Executive Vice President, "Upon my election to the Treasurer position in March 2016, there had not been anybody in the position for approximately 10 months. My predecessor had been out on medical leave until the expiration of his term. On my election to the Treasurer position I assumed all of the responsibilities of the position, including the reporting of our PAC Funds. I basically taught myself how to file the electronic reports, replace the Treasurer position by filing DSE6 forms, and determine filing dates. I was aware that at some point a more frequent filing period was indicated but I didn't know the date that would begin. I did receive emails from the Division of Elections reminding me to start the P1 and following reports. However, at the same time, I was doing an annual MUC report that was due at the same time. I believed that the reminders were for that report. I was able to complete and submit the MUC report on time, but it wasn't until approximately 10:00 am on July 2, 2016 that 1 received the email regarding the P1 report stating that it was due by midnight of July 1, 2016. I immediately completed and submitted the report. However, July 2 was a Saturday and Monday, July 4 was a holiday so it was not received by the Division of Elections until Tuesday, July 5. As this was going on, I was elected to a different position in the office and I was involved in trying to keep with two positions at once since we have not elected a new Treasurer as of this time".

- The 2016 P1 Report covers the time period from 6/1/16 through 6/24/16. .
- The 2016 P1 Queued-Transaction Report reflects that this report was created on 7/2/16 at approximately 10:26 am, before being filed on 7/2/16 at approximately 10:27 am.<sup>2</sup>
- In a 10/26/16 email with Kristi Reid-Bronson, FEC staff was informed, "The committee filed a notice of no activity (waiver) on 7-2-16. A waiver is not a report. On 7-5-16, the committee filed a report showing \$3698 of activity. The fine of \$650 is based upon the daily fine imposed on a report that is 4 days late. (\$50 per day for the first 3 days and \$500 for the 4<sup>th</sup> day.)

PRIOR CASES: This PC has been involved in two prior FEC investigations. #05-075; NUC found for a violation of 106.07(8)(b)/paid \$671.75 fine. #06-349; NUC found for a violation of 106.07(8)(b)/paid \$500.00 fine.

As this was going on, I was elected to a different position in the office and I was involved in trying to keep with two positions at once since we have not elected a new Treasurer as of this time.

For the above reasons, I respectfully request that you remove the fine that has been assessed. We will be electing a new Treasurer shortly and I have now been through the cycle of PAC reporting and understand how and when the filings need to be reported. Therefore, I do not anticipate any problems with timely report submittal in the future.
