## **Euro Medium Term Note Programme**

This Base Prospectus has been approved by the Central Bank of Ireland, as competent authority under Directive 2003/71/EC, as amended (the "Prospectus Directive"). The Central Bank of Ireland only approves this Base Prospectus as meeting the requirements imposed under Irish and EU law pursuant to the Prospectus Directive. This Base Prospectus comprises a Base Prospectus for the purposes of Article 5.4 of the Prospectus Directive. Application has been made to the Irish Stock Exchange for notes ("Notes") issued under the Euro Medium Term Note Programme described herein (the "Programme") within twelve months after the date hereof to be admitted to the Official List of the Irish Stock Exchange (the "Official List") and trading on its regulated market (the "Main Securities Market"). The Main Securities Market is a regulated market for the purposes of Directive 2004/39/EC (the "Markets in Financial Instruments Directive"). Such approval relates only to the Notes which are to be admitted to trading on a regulated market for the purposes of the Markets in Financial Instruments Directive and/or which are to be offered to the public in any Member State of the European Economic Area. The Programme also permits Notes to be issued on the basis that they will not be admitted to listing, trading and/or quotation by any competent authority, stock exchange and/or quotation system or to be admitted to listing, trading and/or quotation by such other or further competent authorities, stock exchanges and/or quotation systems as may be agreed with the Issuer.

Ferrovie dello Stato Italiane S.p.A. (the "**Issuer**" or "**FS**") may issue Notes under the Programme to one or more of the Dealers named on page 128 and any additional Dealer appointed under the Programme from time to time (each a "**Dealer**" and together the "**Dealers**"). References in this Base Prospectus to the "**relevant Dealer**" shall be, in the case of an issue of Notes to more than one Dealer, to the lead manager of such issue and, in the case of an issue of Notes to one Dealer, to such Dealer. Pursuant to the Programme, the Issuer may issue Notes denominated in any currency agreed with the relevant Dealer, subject to any applicable legal or regulatory restrictions. The Notes will be issued in such denominations as may be agreed between the Issuer and the relevant Dealer save that the minimum denomination of each Note will be  $\in 100,000$  (or, if the Notes are denominated in a currency other than euro, the equivalent amount in such currency). The aggregate nominal amount of all Notes from time to time outstanding under the Programme will not exceed  $\notin 4,500,000,000$  (or its equivalent in other currencies calculated as described herein).

As at the date of this Base Prospectus, the Issuer has the following ratings assigned to it: BBB by Fitch Italia S.p.A. ("**Fitch**") and BBB- by Standard & Poor's Credit Market Services Europe Limited ("**Standard & Poor's**"). The Programme has been rated BBB by Fitch Italia S.p.A. and BBB- by Standard & Poor's Credit Market Services Europe Limited. Each of Fitch Italia S.p.A and Standard & Poor's Credit Market Services Europe Limited is established in the EEA and is registered under Regulation (EC) No. 1060/2009, as amended (the "**CRA Regulation**"). As such each of Fitch Italia S.p.A and Standard & Poor's Credit Market Services Europe Limited is included in the list of credit ratings agencies published by the European Securities and Markets Authority on its website (at *https://www.esma.europa.eu/page/List-registered-and-certified-CRAs*) in accordance with the CRA Regulation.

A security rating is not a recommendation to buy, sell or hold securities and may be subject to suspension, reduction or withdrawal at any time by the assigning rating agency.

Investing in Notes issued under the Programme involves certain risks. The principal risk factors that may affect the abilities of the Issuer to fulfil their respective obligations under the Notes are discussed under "Risk Factors" below.

## **Programme limit**

The maximum aggregate principal amount of Notes outstanding at any one time under the Programme will not exceed  $\textcircled$ ,500,000,000 (and for this purpose, any Notes denominated in another currency shall be translated into euro at the date of the agreement to issue such Notes (calculated in accordance with the provisions of the Dealer Agreement)). The maximum aggregate principal amount of Notes which may be outstanding at any one time under the Programme may be increased from time to time, subject to compliance with the relevant provisions of the Dealer Agreement as defined under "Subscription and Sale".

## Certain definitions and language of Base Prospectus

In this Base Prospectus, unless otherwise specified, references to a "**Member State**" are references to a Member State of the European Economic Area.

In this Base Prospectus, references to "**U.S.\$**" or "**USD**" are to United States dollars, references to "**Sterling**" or "**£**" are to the lawful currency of the United Kingdom and references to "**EUR**" or "**euro**" are to the currency introduced at the start of the third stage of European economic and monetary union, and as defined in Article 2 of Council Regulation (EC) No 974/98 of 3 May 1998 on the introduction of the euro, as amended.

Certain figures included in this Base Prospectus have been subject to rounding adjustments; accordingly, figures shown for the same category presented in different tables may vary slightly and figures shown as totals in certain tables may not be an arithmetic aggregation of the figures which precede them.

The language of this Base Prospectus is English. Certain legislative references and technical terms have been cited in their original language in order that the correct technical meaning may be ascribed to them under applicable law.

## Ratings

Tranches of Notes issued under the Programme will be rated or unrated. Where a Tranche of Notes is rated, such rating will not necessarily be the same as the rating(s) described above or the rating(s) assigned to Notes already issued. Where a Tranche of Notes is rated, the applicable rating(s) will be specified in the relevant Final Terms. Whether or not each credit rating applied for in relation to a relevant Tranche of Notes will be (1) issued by a credit rating agency established in the EEA and registered under the CRA Regulation, or (2) issued by a credit rating agency which is not established in the EEA but will be endorsed by a CRA which is established in the EEA and registered under the CRA Regulation or (3) issued by a credit rating agency which is not established in the EEA but which is certified under the CRA Regulation will be disclosed in the Final Terms.

## Non-IFRS Financial Measures

This Base Prospectus contains certain non-IFRS (International Financial Reporting Standards) financial measures (including those which are considered alternative performance measures within the meaning of Article 12 of Commission Delegated Regulation (EU) 2016/301), including EBITDA, EBIT, Net operating working capital, Other assets, Net non-current assets, Other provisions and Net Financial Debt.

- EBITDA (or gross operating profit) is an indicator of the performance of operations and reflects the group's core business only. It is calculated as the difference between revenue and operating costs;
- EBIT (or operating profit) is an indicator of the performance of operations and is calculated as the algebraic sum of EBITDA (gross operating profit) and amortisation and depreciation, impairment losses (reversals of impairment losses) and provisions;
- EBITDA Margin (or gross operating profit margin) is a profitability indicator and is calculated as the ratio of gross operating profit to operating revenue;
- EBIT Margin (or operating profit margin ROS (return on sales)) is a sales profitability indicator and is calculated as the ratio of operating profit to revenue;
- Net operating working capital is the algebraic sum of inventories, construction contracts, current and non-current trade receivables and current and non-current trade payables;
- Other assets, net reflect the sum of receivables and advances from the Ministry of the Economy and Finance for grants, deferred tax assets, other current and non-current assets and other current and non-current liabilities;
- Net non-current assets reflect the sum of property, plant and equipment, investment property, intangible assets and equity investments;
- Other provisions reflect the sum of post-employment benefits and other employee benefits, the provision for litigation with employees and third parties, the provisions for other sundry risks and deferred tax liabilities; and
- Net Financial Debt is a financial indicator calculated as the algebraic sum of bonds, non-current bank loans and borrowings and the current portion thereof, current bank loans and borrowings, current and non-current loans and borrowings from other financial backers, financial assets with the Ministry of the Economy and Finance for current fifteen-year grants, cash and cash equivalents and current and non-current loan assets.

It should be noted that the above mentioned measures are not recognised as measures of performance or liquidity under IFRS and should not be recognised as alternative to operating income or net profit or any

other performance measure derived in accordance with IFRS or any other generally accepted accounting principles. The management finds them useful in monitoring the Group's (as such term is defined in the "Terms and Conditions of the Notes") performance and believes they reflect the results of operations and financial trends of its business segments. Accordingly the Issuer believes that the above measures provide useful information to investors for the purposes of evaluating the financial condition and results of operations of the Group, the quality of its assets and the fundamentals of its business.

## GENERAL DESCRIPTION OF THE PROGRAMME

## **RISK FACTORS**

The Issuer believes that the following factors may affect its ability to fulfil its obligations under Notes issued under the Programme. Most of these factors are contingencies which may or may not occur and the Issuer is not in a position to express a view on the likelihood of any such contingency occurring. In addition, factors which are material for the purpose of assessing the market risks associated with Notes issued under the Programme are also described below.

The Issuer believes that the factors described below represent the principal risks inherent in investing in Notes issued under the Programme, but the inability of the Issuer to pay interest, principal or other amounts on or in connection with any Notes may occur for other reasons which may not be considered significant risks by the Issuer based on information currently available to it or which it may not currently be able to anticipate. Accordingly, the Issuer does not represent that the statements below regarding the risk of holding any Notes are exhaustive.

Prospective investors should also read the detailed information set out elsewhere in this Base Prospectus and reach their own views prior to making any investment decision.

Words and expressions defined in the "Terms and Conditions of the Notes" below or elsewhere in this Base Prospectus have the same meanings in this section. Prospective investors should read the entire Base Prospectus.

# Factors that may affect the Issuer's ability to fulfil its obligations under the Notes issued under the Programme

#### Risks relating to macroeconomic conditions

The turmoil affecting the global financial markets and banking system has significantly limited the availability of credit and resulted in a low level of liquidity and a widespread withdrawal of investment funding. In several countries (including Italy), overall demand for goods and services has been adversely affected by spending cuts and other austerity measures and this has had an adverse effect on economic growth and the employment rate. The persisting financial crisis has also adversely affected Italy and the current negative economic situation is not expected to end in the near future. It is currently unclear what effect the exit of the United Kingdom from the European Union (so called 'Brexit') will have on the macroeconomic environment in Europe. FS is affected by the economic downturn, market crisis or period of instability could have a negative impact on the Group's business. For example, weak economic conditions and prolonged instability could result in stagnation or a decrease in demand for transport businesses in which FS and its Group operate, adversely affecting the services of FS. This in turn may give rise to a decrease in prices and profitability levels, which may have an adverse effect on the financial condition and result of operations of FS.

## The sovereign debt crisis and the downgrading of the Republic of Italy

Large sovereign debts and fiscal deficits in European countries have raised concerns regarding the financial condition of Eurozone financial institutions and their exposure to such countries. In particular, the Issuer's credit ratings closely reflect the rating of the Republic of Italy and are therefore exposed to the risk of reductions in the sovereign credit rating of Italy. Accordingly, on the basis of the methodologies used by rating agencies, further downgrades of Italy's credit rating may have a consequential effect on the credit rating of Italian issuers, such as the Issuer.

### Downgrading of the Issuer's ratings

The Issuer has the following ratings assigned to it: BBB by Fitch Italia S.p.A. and BBB- by Standard & Poor's Credit Market Services Europe Limited. Any significant deterioration or downgrading of those ratings may adversely affect the Issuer's access to alternative sources of funding and may increase the cost of funding, all of which could have an adverse effect on the Issuer's financial condition or results of operations.

### Liquidity and Financing risks

The Group may need to raise further debt from time to time to, among other things, finance future capital expenditure and enable it to refinance its existing indebtedness in the ordinary course of business. FS adopts asset/liability management techniques in raising debt capital and financing for the Group and maintains continuous control of Group funding needs and ensures ongoing funds availability, also by recourse to consistent cash holdings and committed lines. There can be no assurance that the Group will be able to raise future debt on terms that are economically viable or at all and this may have an adverse effect on the Issuer's business and results of operations.

### Interest Rate risks

The Group is mainly exposed to interest rate risk related to loans which bear variable rates of interest. In particular, as of 31 December 2016, 63 per cent. of the Group's loans bore variable rates of interest. The Group companies which are most exposed to this risk (including Trenitalia and Rete Ferroviaria Italiana S.p.A. ("**RFI**")) have entered into hedging transactions on the basis of specific risk management policies approved by the respective Boards of Directors and implemented with the technical and operating support of FS, with the aim of managing the exposure to changes in interest rates. The Group does not enter into derivatives for speculative purposes. There can be no assurance that the Group will be able to further implement transactions to hedge interest rate risk related to new debt issues and this may have an adverse effect on the Issuer's business and results of operations.

#### Procurement risks

Procurement prices for commodities, energy and transport services may shift depending on the market situation. As such, it may not be possible (or may only be possible to a limited extent) to pass on higher costs to customers. Consequently, this could have a negative effect on profits.

#### Project risks

The investments of the overall rail system require high amounts of capital expenditures and involve complex projects. Changes in the legal framework, delays in deliveries of such projects or technical adjustments during the frequently multi-year project terms can result in increasing costs. As such, changes listed above could lead to increased costs and/or have an adverse effect on the Issuer's business and results of operations.

#### Risks relating to the Group's relationship with the Republic of Italy

The nature of FS' business, as a contractor for activities of public interest, implies that, in addition to the risks connected with the terms of renewal upon the expiry of agreements, such as the Contratto di Programma which regulates the funding of rail infrastructure development and concessions, FS bears the risks associated with its special relationship with the Italian government, which is FS' client and sole shareholder, and therefore exercises a significant influence over FS' operations. Moreover FS bears the regulatory risk as it operates in a sector regulated by a recently constituted independent authority. FS' results of operation and financial condition may be adversely affected by the failure to extend upon expiry any long standing agreements or concessions with Italian governmental bodies. Similarly, FS' results of operations and financial condition may be adversely affected by any changes in law or regulation in FS' areas of business adopted by the Italian State and the transport authority. The Italian State owns 100 per cent. of the Issuer's paid up capital. The Italian State, acting through the Ministry of Economy and Finance ("MEF"), controls the Issuer and has the power to elect and remove its directors, as constituted from time to time, or committees thereof. A large part of FS' debt is serviced by State transfers arising from specific State laws. The State influences the Issuer's operations through its various departments and policies and FS' independent regulator determines criteria for infrastructure charge and path allocation and defines tender schemes to award public service contracts. Given the importance of the Italian railway sector to the national economy, the State could require the Issuer to take actions designed to serve the public interest in Italy which may not necessarily be designed to maximise FS' profits. See also "The Council of Ministers starts FS Italiane privatization process".

## Risks relating to the structure of the Group

The majority of the Group's debt is held by FS, RFI and Trenitalia (which together, held 91 per cent. of total debt as of 31 December 2016). Generally, any claims in respect of indebtedness incurred, and guarantees issued, by a subsidiary of the Issuer, and claims of preference shareholders (if any) of such

subsidiary, will rank prior with respect to the assets and earnings of such subsidiary to any claims of the creditors of its parent company, the Issuer. The subsidiaries have no obligations, contingent or otherwise, to pay any amounts due under the Notes or to make funds available to the Issuer to pay any amounts due under the Notes. The Notes, therefore, will be effectively subordinated to creditors (including trade creditors) and preference shareholders (if any) of the Issuer's direct and indirect subsidiaries. The proceeds from any issue of Notes finance Group's capex via *intercompany loans* signed between the Issuer and the relevant subsidiary, reflecting the main contractual conditions of the bonds in terms of parties' commitments and covenants.

#### Risks related to Litigation and Contracts

FS may be involved in disputes and litigation arising from claims for damages and/or from legal disputes. Provisions are made for legal and contractual risks after estimating the respective probability of occurrence. The actual utilization of these provisions depends on whether the risks materialize to the extent set forth in the Group's current estimates. A negative outcome resulting from such disputes could have an adverse effect on the Issuer's business and results of operations. For proceedings currently considered to involve material risks relating to the Issuer, see also "*Description of the Issuer – Litigation*".

# Risks related to the European Commission procedures SA. 32953 and SA. 32179 relating to the implementation of the competition policy

If the Commission finds, at the end of the procedure of formal investigation on assumed State aid measures on behalf of Trenitalia and FS Logistica, described in "*Description of the Issuer – Litigation – Proceedings before the Italian and EU authorities*", that the abovementioned measures constitute an unlawful State aid incompatible with the internal market, it shall adopt a negative decision with the recovery of the State aid, that will oblige the Italian State to take all necessary measures to recover, without delay, the aid from Trenitalia and FS Logistica. A negative outcome resulting from such investigation and a timely action by the Italian State to recover of such aid could therefore have an adverse effect on the Group's results of operations.

## Business risks

High speed lines have allowed the railway sector to compete with other means of transport (for example, airplane and car), mainly as a result of the reduction in travel times, combined with the comfort of the journey and easy access to the urban centres of major cities. In this market segment, the Issuer believes that the crucial factor for maintaining competiveness will increasingly be the maintenance of and improvement in the quality of the service offered and of the rapid adaptation to trends in market demand. Since 2012, the railway sector has been affected by the change in market equilibriums following the entry of new private operators that operate on high speed routes. This increasing competition on high speed routes may have a negative impact on the Group's business and profitability.

#### Regional transportation risks

In respect of the Italian regional transport segment, since 2012, there have been several developments in the applicable legislative framework and FS cannot rule out the introduction of further legislative amendments in the future. In Judgement 199/2012, delivered in July 2012, the Italian Constitutional Court declared the constitutional illegality of art. 4 of Law 148/2011, converting Legislative Decree n.138/2011 into law, which provided for the obligation to launch tenders for the regional transport service upon the expiry of the contracts in place with the Group.

The Group has entered into contracts with the Regional Governments which do not depend on the procedures through which the Regional Governments themselves may find the necessary sources of financing. These processes could have a negative impact on the mobility needs expressed by local areas and on planning criterion imposed by the railway sector in relation to the time required for the implementation of any investment plans. Although safeguards for investments have been provided for in executing the service contracts, there remains uncertainty in respect of the future developments in the legislative framework. This uncertainty may have a negative impact on the Group's results of operations,

specifically in relation to the contracts it entered into with Regional Governments. For further detail see also "*Description of the Issuer – Regional Public Service Contracts*".

#### **Operational** risks

Major operational risks may arise from the Group's failure to comply with the contractual functional specifications of new rolling stock being delivered by its manufacturers. The Group constantly monitors the different issues reported on important job orders that have generated disputes, in particular operational difficulties and significant service disruptions that have arisen in rare cases. In this regard, particularly severe actions have been taken against suppliers and in some cases the Group has used different procedures for the entry into service of rolling stock, providing for the full involvement of the manufacturer for long trial periods, without taking delivery of the rolling stock. In other cases, contracts were terminated due to non-compliance by the suppliers themselves, activating the enforcement of the sureties given to secure contracts. The general crisis of the credit markets also affected railway subsuppliers, thus creating, in some cases, increased pressure on the manufacturers which are also small/medium businesses. An additional risk may arise from the management of cleaning service contracts that could have an impact on the quality of the service rendered by the Group company that has sub-contracted out such service. There can be no assurance that the above-mentioned risks will not lead to operational difficulties that may have an adverse effect on the Group's business and results of operations.

#### IT risks

The Group relies heavily on its telecommunications network and computer systems for coordination of scheduling and other aspects of its railway operations as well as accounting, ticket sales for passenger trains, tracking cargo deliveries and numerous other functions. Hardware and software used by the Group may be damaged by human error, natural disaster, power loss and other events. In order to ensure continuous availability of IT operations, the Group has in place a redundancy methodology for operations and data backup as well as a *fail-safe* network coupling. These measures safeguard critical business and IT processes and prevent serious breakdowns. However, there can be no assurance that the implemented safeguard measures will be sufficient and/or be able to prevent any IT system failures which may, in turn, have an adverse effect on the Group's business and results of operations, including increased expenses and decreased revenues. Specifically in order to continue minimising this risk in any case, to ensure service continuity or recovery in the shortest amount of time possible following potential IT infrastructure disaster, FS Italiane Group is implementing business continuity solutions for business critical systems only. The maximum tolerance range for these systems to restore services and update the data is not more than 30 minutes, which is higher than the current limits of the disaster recovery plan.

In addition, we are subject to the regulations governing the protection, collection and processing of personal data in the jurisdictions in which we operate. We are exposed to the risk that the data could be damaged or lost, or removed, disclosed or processed (data breach) for purposes other than those authorized by the customer, including by unauthorized parties (such as third parties or Group employees).

The possible destruction, damage or loss of customer, employee or third party data, as well as its removal, unauthorized processing or disclosure, would have a negative impact on our business and reputation, and could subject us to fines, with consequent negative effects on our business, results of operations or financial condition.

In addition, changes to such regulation could impose more stringent sanctions for violations, could have a negative impact on our business insofar as they lead us to incur additional compliance costs.

There are possible risks with regard to the reliability of the system (disaster recovery), the quality and integrity of the data managed and the threats to which IT systems are subject, as well as physiological risks related to the management of software changes (change management), which could have negative effects on our operations, as well as on our capital and financial situation.

Among the risks we face relating to the management of IT systems are the possible violations of our systems due to unauthorized access to our corporate network, or IT resources, the introduction of viruses into computers or any other form of abuse committed via the Internet. Like attempted hacking, such violations have become more frequent over the years throughout the world and therefore can threaten the protection of information relating to us and our customers and can have negative effects on the integrity

of our IT systems, as well as on the confidence of our customers and on our reputation, with possible negative effects on our capital and financial condition.

## Property Tax risks

In light of the property taxation legislation in force in Italy and given the interpretative uncertainties of the subject, the Group constantly monitors the situation to identify the possible impact, also with regard to the enhancement and the overall cost of assets affected by the process of asset allocation. In particular, reference is made to the *Imposta Municipale Unica*, Local Single Tax ("**IMU**") which affects areas that can potentially be developed or those for which a building permit has already been obtained. This new property taxation legislation may create financial obligations for the Group, particularly in the infrastructure and commercial real estate business segments and this could have an adverse effect on the Group's results of operations.

#### Workforce risks

The recent changes in legislation with regard to social security and pensions reform in Italy (which are still in the preliminary phases of implementation) represent an element of high risk due to the repercussions they could cause in terms of their impact on the policies planned for the reorganisation and the restructuring of the Group. Such repercussions may, in the future, have a negative financial impact on the Group's results of operations.

#### Risks relating to the use of estimates

The determination of provisions and strategies to monitor and mitigate the different risks to which the Issuer's business is exposed involves the use of estimates which reflect the Issuer's knowledge of events and factors which may possibly change in time, thus potentially resulting in significantly different outcomes. Consequently, the financial condition and results of operations of the Issuer may be adversely affected if, due to the occurrence of unexpected events and factors, such provisions, techniques and strategies prove not to be fully effective in mitigating or monitoring the Issuer's risk exposure.

#### Environmental risks

The Group's operations are subject to extensive environmental laws and regulations as it operates as a contracting entity for infrastructure construction works and offers transportation service for products that are hazardous to the environment. Compliance with environmental regulations is an on-going process and, as such, new laws and regulations, the imposition of more stringent requirements, increasingly strict enforcement or new interpretations of existing environmental laws may require the Group to modify its operations, incur substantial unbudgeted costs to comply with current or future regulations or incur fines or penalties for environmental violations that could have a material adverse effect on the Group's business, profitability and operating results.

#### Risks relating to Change of Control

A Change of Control (as such term is defined in Condition 9(f) (Redemption at the option of Noteholders upon a Change of Control Put Event) of the Issuer may activate the right of Noteholders to require the Issuer to redeem the Notes (the "Change of Control Put Option") if, at the time such Change of Control occurs, there is also a downgrade in the credit rating assigned to the Notes, all as described in more detail in Condition 9(f) (Redemption at the option of Noteholders upon a Change of Control Put Event). If the Notes are unrated at the time of the Change of Control, the Noteholders' Change of Control Put Option is exercisable immediately upon the Change of Control occurring, in accordance with the procedures set out in Condition 9(f) (Redemption at the option of Noteholders upon a Change of Control Put Event). The Issuer has certain other financing arrangements in place that were executed before any credit ratings were assigned to the Issuer and which permit the relevant creditors, including certain of the Dealers (the "Other Financing Creditors"), to activate a Change of Control put option regardless of the fulfilment of any additional condition (including any subsequent downgrade in the Issuer's or its securities' credit ratings). Therefore, should a Change of Control in respect of the Issuer occur, holders of Notes that are rated should be aware that they may be able to exercise their Change of Control Put Option only at a later stage, as compared to both (i) holders of Notes that are unrated and (ii) the Other Financing Creditors, who may exercise their put option immediately upon the Change of Control occurring.

# Factors which are material for the purpose of assessing the market risks associated with Notes issued under the Programme

### The Notes may not be a suitable investment for all investors

Each potential investor in the Notes must determine the suitability of that investment in the light of its own circumstances. In particular, each potential investor should:

- (a) have sufficient knowledge and experience to make a meaningful evaluation of the Notes, the merits and risks of investing in the Notes and the information contained or incorporated by reference in this Base Prospectus or any applicable supplement;
- (b) have access to, and knowledge of, appropriate analytical tools to evaluate, in the context of its particular financial situation, an investment in the Notes and the impact the Notes will have on its overall investment portfolio;
- (c) have sufficient financial resources and liquidity to bear all of the risks of an investment in the Notes, including where the currency for principal or interest payments is different from the potential investor's currency;
- (d) understand thoroughly the terms of the Notes and be familiar with the behaviour of any relevant indices and financial markets; and
- (e) be able to evaluate (either alone or with the help of a financial adviser) possible scenarios for economic, interest rate and other factors that may affect its investment and its ability to bear the applicable risks.

#### Risks related to the structure of a particular issue of Notes

A wide range of Notes may be issued under the Programme. A number of these Notes may have features which contain particular risks for potential investors. Set out below is a description of the most common of such features, distinguishing between factors which may occur in relation to any Notes:

#### Notes subject to optional redemption by the Issuer

An optional redemption feature of Notes is likely to limit their market value. During any period when the Issuer may elect to redeem Notes, the market value of those Notes generally will not rise substantially above the price at which they can be redeemed. This also may be true prior to any redemption period.

The Issuer may be expected to redeem Notes when its cost of borrowing is lower than the interest rate on the Notes. At those times, an investor generally would not be able to reinvest the redemption proceeds at an effective interest rate as high as the interest rate on the Notes being redeemed and may only be able to do so at a significantly lower rate. Potential investors should consider reinvestment risk in light of other investments available at that time.

#### Redemption for tax reasons

In the event that the Issuer would be obliged to increase the amounts payable in respect of any Notes due to any withholding or deduction for or on account of, any present or future taxes, duties, assessments or governmental charges of whatever nature imposed, levied, collected, withheld or assessed by or on behalf of the Republic of Italy or any political subdivision thereof or any authority therein or thereof having power to tax, the Issuer may redeem all outstanding Notes in accordance with the Conditions. In such circumstances an investor may not be able to reinvest the redemption proceeds in a comparable security at an effective interest rate as high as that of the relevant Notes.

# If the Issuer has the right to convert the interest rate on any Notes from a fixed rate to a floating rate, or vice versa, this may affect the secondary market and the market value of the Notes concerned

Fixed/Floating Rate Notes are Notes which may bear interest at a rate that converts from a fixed rate to a floating rate, or from a floating rate to a fixed rate. Where the Issuer has the right to effect such a conversion, this will affect the secondary market and the market value of the Notes since the Issuer may

be expected to convert the rate when it is likely to produce a lower overall cost of borrowing. If the Issuer converts from a fixed rate to a floating rate in such circumstances, the spread on the Fixed/Floating Rate Notes may be less favourable than then prevailing spreads on comparable Floating Rate Notes tied to the same reference rate. In addition, the new floating rate at any time may be lower than the rates on other Notes. If the Issuer converts from a floating rate to a fixed rate in such circumstances, the fixed rate may be lower than then prevailing market rates.

### Notes issued at a substantial discount or premium

The market values of securities issued at a substantial discount (such as Zero Coupon Notes) or premium to their principal amount tend to fluctuate more in relation to general changes in interest rates than do prices for more conventional interest bearing securities. Generally, the longer the remaining term of such securities, the greater the price volatility as compared to more conventional interest bearing securities with comparable maturities.

#### CMS Linked Interest Notes

The Issuer may issue Notes with interest determined by reference to the CMS Rate which determine the amount of interest (a "**relevant factor**"). Potential investors should be aware that:

- (a) the market price of such Notes may be volatile;
- (b) they may receive no interest;
- (c) the relevant factor may be subject to significant fluctuations that may not correlate with changes in interest rates, currencies or other indices;
- (d) if the relevant factor is applied to the Notes in conjunction with a multiplier greater than one or contains any other leverage factor, the effect of changes in the relevant factor on interest payable is likely to be magnified; and

the timing of changes in the relevant factor may affect the actual yield to investors, even if the average level is consistent with their expectations.

## In respect of any Notes issued with a specific use of proceeds such as a Green Bond there can be no assurance that such use of proceeds will be suitable for the investment criteria of an investor.

If in respect of any particular issue of Notes there is a particular identified use of proceeds including Eligible Green Projects (as defined under "*Use of Proceeds*" below), this will be specified in the applicable Final Terms. Prospective investors should have regard to the information set out in such Final Terms regarding use of proceeds and must determine for themselves the relevance of such information for the purpose of any investment in such Notes together with any other investigation such investor deems necessary.

In particular, the Issuer may choose to apply the proceeds from the issue of any Notes for Eligible Green Projects which have been defined in accordance with the broad categorisation of eligibility for green projects set out by the International Capital Market Association ("ICMA") Green Bond Principles. No assurance is given by the Issuer or the Dealers that the use of such proceeds for any Eligible Green Projects will satisfy, whether in whole or in part, any present or future investor expectations or requirements as regards any investment criteria or guidelines with which such investor or its investments are required to comply whether by any present or future applicable law or regulations or by its own by-laws or other governing rules or investment portfolio mandates, in particular with regard to any direct or indirect environmental sustainability or social impact of any projects or uses the subject of or related to, any Eligible Green Projects.

There can be no assurance that the relevant project(s) or use(s) (including those the subject of, or related to, any Eligible Green Projects) will be capable of being implemented in or substantially in the manner described in the Final Terms and/or accordance with any timing schedule and that accordingly such proceeds will be totally or partially disbursed for such project(s) or use(s). Nor can there be any assurance that any such projects will be completed within any specified period or at all or with the results or

outcome (whether or not related to the environment) as originally expected or anticipated by the Issuer. Any such event or failure by the Issuer will not constitute an Event of Default under the Notes.

Furthermore, it should be noted that there is currently no clearly defined definition (legal, regulatory or otherwise) of, nor market consensus as to what constitutes, a green or sustainable or an equivalently labelled project or as to what precise attributes are required for a particular project to be defined as green or sustainable or such other equivalent label, nor can any assurance be given that such a clear definition or consensus will develop over time. Accordingly, no assurance is or can be given to investors that any project(s) or use(s) the subject of or related to any Eligible Green Projects will meet any or all investor expectations regarding such green, sustainable or other equivalently-labelled performance objectives or that any adverse environmental, social and/or other impacts will not occur during the implementation of any project(s) or use(s) the subject of, or related to, any Eligible Green Projects.

No assurance or representation is given as to the suitability or reliability for any purpose whatsoever of any opinion or certification of any third party (whether or not solicited by the Issuer) which may be made available in connection with the issue of any Notes and in particular with any Eligible Green Projects to fulfil any environmental, sustainability, social and/or other criteria. For the avoidance of doubt, any such opinion or certification (i) is not, nor shall be deemed to be, incorporated in and/or form part of this Base Prospectus, (ii) is not, nor should be deemed to be, a recommendation by the Issuer, the Dealers or any other person to buy, sell or hold any such Notes and (iii) would only be current as of the date that it was initially issued. Prospective investors must determine for themselves the relevance of any such opinion or certification and/or the information contained therein and/or the provider of such opinion or certification for the purpose of any investment in such Notes. Currently, the providers of such opinions and certifications are not subject to any specific regulatory or other regime or oversight.

In the event that any Notes are listed or admitted to trading on any dedicated green, environmental, sustainable or other equivalently-labelled segment of any stock exchange or securities market (whether or not regulated), no representation or assurance is given by the Issuer, the Dealers or any other person that such listing or admission satisfies, whether in whole or in part, any present or future investor expectations or requirements as regards any investment criteria or guidelines with which such investor or its investments are required to comply, for example with regard to any direct or indirect environmental, sustainability or social impact of any projects or uses, the subject of or related to, any Eligible Green Projects. Additionally, it should be noted that the criteria for any such listings or admission to trading may vary from one stock exchange or securities market to another. Nor is any representation or assurance given or made by the Issuer, the Dealers or any other person that any such listing or admission to trading will be obtained in respect of any such Notes or, if obtained, that any such listing or admission to trading will be maintained during the life of the Notes.

Any such event or failure to apply the proceeds of any issue of Notes for any project(s) or use(s), including any Eligible Green Projects, and/or the withdrawal of any opinion or certification as described above or any such opinion or certification attesting that the Issuer is not complying in whole or in part with any matters for which such opinion or certification is opining or certifying on, and/or any such Notes no longer being listed or admitted to trading on any stock exchange or securities market as aforesaid may have a material adverse effect on the value of such Notes and also potentially the value of any other Notes which are intended by the Issuer to finance Eligible Green Projects and/or result in adverse consequences for certain investors with portfolio mandates to invest in securities to be used for a particular purpose.

As at the date of this Base Prospectus, the Issuer has not published a framework relating to an investment in Eligible Green Projects although the Issuer intends to publish such framework prior to the issuance of any Notes which specify that the relevant proceeds will be used for Eligible Green Projects.

#### Risks related to Notes generally

Set out below is a brief description of certain risks relating to the Notes generally:

#### Modification and waiver

The conditions of the Notes contain provisions for calling meetings of Noteholders to consider matters affecting their interests generally. These provisions permit defined majorities to bind all Noteholders including Noteholders who did not attend and vote at the relevant meeting and Noteholders who voted in a manner contrary to the majority.

## Change of law

The conditions of the Notes are governed by English law in effect as at the date of this Base Prospectus. No assurance can be given as to the impact of any possible judicial decision or change to applicable English law or administrative practice after the date of this Base Prospectus and any such change could materially adversely impact the value of any Notes affected by it.

## Investors who purchase Notes in denominations that are not an integral multiple of the Specified Denomination may be adversely affected if definitive Notes are subsequently required to be issued

In relation to any issue of Notes which have denominations consisting of a minimum Specified Denomination plus one or more higher integral multiples of another smaller amount, it is possible that such Notes may be traded in amounts that are not integral multiples of such minimum Specified Denomination. In such a case a holder who, as a result of trading such amounts, holds an amount which is less than the minimum Specified Denomination in his account with the relevant clearing system at the relevant time may not receive a definitive Note in respect of such holding (should definitive Notes be printed) and would need to purchase a principal amount of Notes such that its holding amounts to a Specified Denomination.

If such Notes in definitive form are issued, holders should be aware that definitive Notes which have a denomination that is not an integral multiple of the minimum Specified Denomination may be illiquid and difficult to trade.

## Potential conflicts of interest

Any Calculation Agent appointed under the Programme (whether the Fiscal Agent, any Paying Agent or otherwise) is the agent of the Issuer and not the agent of the Noteholders. Potential conflicts of interest may exist between the Calculation Agent (if any) and Noteholders (including where a Dealer acts as a Calculation Agent), including with respect to certain determinations and judgments that such Calculation Agent may make pursuant to the Conditions that may influence amounts receivable by the Noteholders during the term of the Notes and upon their redemption.

## Risks related to the market generally

Set out below is a brief description of the principal market risks, including liquidity risk, exchange rate risk, interest rate risk and credit risk:

## The secondary market generally

Notes may have no established trading market when issued, and one may never develop. If a market does develop, it may not be very liquid. Therefore, investors may not be able to sell their Notes easily or at prices that will provide them with a yield comparable to similar investments that have a developed secondary market. This is particularly the case for Notes that are especially sensitive to interest rate, currency or market risks, are designed for specific investment objectives or strategies or have been structured to meet the investment requirements of limited categories of investors. These types of Notes generally would have a more limited secondary market and more price volatility than conventional debt securities. Illiquidity may have a severely adverse effect on the market value of Notes. In addition, Notes issued under the Programme might not be listed on a stock exchange or regulated market and, in these circumstances, pricing information may be more difficult to obtain and the liquidity and market prices of such Notes may be adversely affected.

## Exchange rate risks and exchange controls

The Issuer will pay principal and interest on the Notes in the Specified Currency. This presents certain risks relating to currency conversions if an investor's financial activities are denominated principally in a currency or currency unit (the "**Investor's Currency**") other than the Specified Currency. These include the risk that exchange rates may significantly change (including changes due to devaluation of the Specified Currency or revaluation of the Investor's Currency) and the risk that authorities with jurisdiction over the Investor's Currency may impose or modify exchange controls. An appreciation in the value of the Investor's Currency relative to the Specified Currency would decrease (1) the Investor's Currency equivalent yield on the Notes, (2) the Investor's Currency equivalent value of the principal payable on the Notes and (3) the Investor's Currency equivalent market value of the Notes.

Government and monetary authorities may impose (as some have done in the past) exchange controls that could adversely affect an applicable exchange rate or the ability of the Issuer to make payments in respect of the Notes. As a result, investors may receive less interest or principal than expected, or no interest or principal.

#### Interest rate risks

Investment in Fixed Rate Notes involves the risk that if market interest rates subsequently increase above the rate paid on the Fixed Rate Notes, this will adversely affect the value of the Fixed Rate Notes.

#### Credit ratings

One or more independent credit rating agencies may assign credit ratings to the Notes. The ratings may not reflect the potential impact of all risks related to structure, market, additional factors discussed above, and other factors that may affect the value of the Notes. A credit rating is not a recommendation to buy, sell or hold securities and may be revised, suspended or withdrawn by the rating agency at any time.

In general, European regulated investors are restricted from using a rating for regulatory purposes if such rating is not issued by a credit rating agency established in the European Union and registered under the CRA Regulation unless (1) the rating is provided by a credit rating agency not established in the European Union but is endorsed by a credit rating agency established in the European Union and registered under the CRA Regulation or (2) the rating is provided by a credit rating agency not established in the European Union which is certified under the CRA Regulation. The list of registered and certified rating agencies published by the ESMA on its website in accordance with the CRA Regulation is not conclusive evidence of the status of the relevant rating agency included in such list, as there may be delays between certain supervisory measures being taken against a relevant rating agency and the publication of the updated ESMA list. Certain information with respect to the credit rating agencies and ratings will be disclosed in the Final Terms

#### Legal investment considerations may restrict certain investments

The investment activities of certain investors are subject to investment laws and regulations, or review or regulation by certain authorities. Each potential investor should consult its legal advisers to determine whether and to what extent (1) the Notes are legal investments for it, (2) the Notes can be used as collateral for various types of borrowing and (3) other restrictions apply to its purchase or pledge of the Notes. Financial institutions should consult their legal advisors or the appropriate regulators to determine the appropriate treatment of the Notes under any applicable risk based capital or similar rules.

## FINAL TERMS AND DRAWDOWN PROSPECTUSES

In this section, the expression "necessary information" means, in relation to any Tranche of Notes, the information necessary to enable investors to make an informed assessment of the assets and liabilities, financial position, profits and losses and prospects of the Issuer and of the rights attaching to the Notes. In relation to the different types of Notes which may be issued under the Programme, the Issuer has included in this Base Prospectus all of the necessary information except for information relating to the Notes which is not known at the date of this Base Prospectus and which can only be determined at the time of an individual issue of a Tranche of Notes.

Any information relating to the Notes which is not included in this Base Prospectus and which is required in order to complete the necessary information in relation to a Tranche of Notes will be contained either in the relevant Final Terms or in a Drawdown Prospectus.

For a Tranche of Notes which is the subject of Final Terms, those Final Terms will, for the purposes of that Tranche only, complete this Base Prospectus and must be read in conjunction with this Base Prospectus. The terms and conditions applicable to any particular Tranche of Notes which is the subject of Final Terms are the Conditions as completed by the relevant Final Terms.

The terms and conditions applicable to any particular Tranche of Notes which is the subject of a Drawdown Prospectus will be the Conditions as supplemented, amended and/or replaced to the extent described in the relevant Drawdown Prospectus. In the case of a Tranche of Notes which is the subject of a Drawdown Prospectus, each reference in this Base Prospectus to information being specified or identified in the relevant Final Terms shall be read and construed as a reference to such information being specified or identified in the relevant Drawdown Prospectus unless the context requires otherwise.

Each Drawdown Prospectus will be constituted by a single document containing the necessary information relating to the Issuer and the relevant Notes.

#### FORM OF THE NOTES

Each Tranche of Notes will initially be in the form of either a temporary global note (the "**Temporary Global Note**"), without interest coupons, or a permanent global note (the "**Permanent Global Note**"), without interest coupons, in each case as specified in the relevant Final Terms. Each Temporary Global Note or, as the case may be, Permanent Global Note (each a "**Global Note**") which is not intended to be issued in new global note ("**NGN**") form, as specified in the relevant Final Terms, will be deposited on or around the issue date of the relevant Tranche of the Notes with a depositary or a common depositary for Euroclear Bank SA/NV as operator of the Euroclear System ("**Euroclear**") and/or Clearstream Banking, *société anonyme* ("**Clearstream, Luxembourg**") and/or any other relevant Final Terms, will be deposited on or around the issue date of the relevant Tranche of the Notes with a common safekeeper for Euroclear and/or Clearstream, Luxembourg.

On 13 June 2006, the European Central Bank (the "**ECB**") announced that global bearer notes in NGN form are in compliance with the "Standards for the use of EU securities settlement systems in ESCB credit operations" of the central banking system for the euro (the "**Eurosystem**"), **provided that** certain other criteria are fulfilled. At the same time the ECB also announced that arrangements for Notes in NGN form will be offered by Euroclear and Clearstream, Luxembourg as of 30 June 2006 and that debt securities in global bearer form issued through Euroclear and Clearstream, Luxembourg after 31 December 2006 will only be eligible as collateral for Eurosystem operations if the NGN form is used.

The relevant Final Terms will also specify whether United States Treasury Regulation 1.163-5(c)(2)(i)(C) (the "**TEFRA C Rules**") or United States Treasury Regulation 1.163-5(c)(2)(i)(D) (the "**TEFRA D Rules**") are applicable in relation to the Notes or, if the Notes do not have a maturity of more than 365 days, that neither the TEFRA C Rules nor the TEFRA D Rules are applicable.

## Temporary Global Note exchangeable for Permanent Global Notes

If the relevant Final Terms specifies the form of Notes as being "Temporary Global Note exchangeable for a Permanent Global Note", then the Notes will initially be in the form of a Temporary Global Note which will be exchangeable, in whole or in part, for interests in a Permanent Global Note, without interest coupons, not earlier than 40 days after the issue date of the relevant Tranche of the Notes upon certification as to non-U.S. beneficial ownership. No payments will be made under the Temporary Global Note unless exchange for interests in the Permanent Global Note is improperly withheld or refused. In addition, interest payments in respect of the Notes cannot be collected without such certification of non-U.S. beneficial ownership.

Whenever any interest in the Temporary Global Note is to be exchanged for an interest in a Permanent Global Note, the Issuer shall procure (in the case of first exchange) the delivery of a Permanent Global Note to the bearer of the Temporary Global Note or (in the case of any subsequent exchange) an increase in the principal amount of the Permanent Global Note in accordance with its terms against:

- (i) presentation and (in the case of final exchange) presentation and surrender of the Temporary Global Note to or to the order of the Fiscal Agent; and
- (ii) receipt by the Fiscal Agent of a certificate or certificates of non-U.S. beneficial ownership.

The principal amount of Notes represented by the Permanent Global Note shall be equal to the aggregate of the principal amounts specified in the certificates of non-U.S. beneficial ownership **provided**, **however**, **that** in no circumstances shall the principal amount of Notes represented by the Permanent Global Note exceed the initial principal amount of Notes represented by the Temporary Global Note.

If:

- (a) the Permanent Global Note has not been delivered or the principal amount thereof increased by 5.00 p.m. (London time) on the seventh day after the bearer of the Temporary Global Note has requested exchange of an interest in the Temporary Global Note for an interest in a Permanent Global Note; or
- (b) the Temporary Global Note (or any part thereof) has become due and payable in accordance with the Terms and Conditions of the Notes or the date for final redemption of the Temporary Global

Note has occurred and, in either case, payment in full of the amount of principal falling due with all accrued interest thereon has not been made to the bearer of the Temporary Global Note in accordance with the terms of the Temporary Global Note on the due date for payment,

then the Temporary Global Note (including the obligation to deliver a Permanent Global Note) will become void at 5.00 p.m. (London time) on such seventh day (in the case of (a) above) or at 5.00 p.m. (London time) on such due date (in the case of (b) above) and the bearer of the Temporary Global Note will have no further rights thereunder (but without prejudice to the rights which the bearer of the Temporary Global Note or others may have under a deed of covenant dated 13 June 2017 (the "**Deed of Covenant**") executed by the Issuer.

The Permanent Global Note will become exchangeable, in whole but not in part only and at the request of the bearer of the Permanent Global Note, for Bearer Notes in definitive form ("**Definitive Notes**"):

- (a) on the expiry of such period of notice as may be specified in the Final Terms; or
- (b) at any time, if so specified in the Final Terms; or
- (c) if the Final Terms specifies "in the limited circumstances described in the Permanent Global Note", then if either of the following events occurs:
  - (i) Euroclear or Clearstream, Luxembourg or any other relevant clearing system is closed for business for a continuous period of 14 days (other than by reason of legal holidays) or announces an intention permanently to cease business; or
  - (ii) any of the circumstances described in Condition 12 (*Events of Default*) occurs and is continuing.

Whenever the Permanent Global Note is to be exchanged for Definitive Notes, the Issuer shall procure the prompt delivery (free of charge to the bearer) of such Definitive Notes, duly authenticated and with Coupons and Talons attached (if so specified in the Final Terms), in an aggregate principal amount equal to the principal amount of Notes represented by the Permanent Global Note to the bearer of the Permanent Global Note against the surrender of the Permanent Global Note to or to the order of the Fiscal Agent within 60 days of the bearer requesting such exchange.

Where interests in the Permanent Global Note are to be exchanged for Definitive Notes in the circumstances described in (a) and (b) above, Notes may only be issued in denominations which are integral multiples of the minimum denomination and may only be traded in such amounts, whether in global or definitive form. As an exception to the above rule, where the Permanent Global Note may only be exchanged in the limited circumstances described in (c) above, Notes may be issued in denominations which represent the aggregate of (i) a minimum denomination of €100,000, plus (ii) integral multiples of €1,000, provided that such denominations are not less than €100,000 nor more than €199,000. For the avoidance of doubt, each holder of Notes of such denominations will, upon exchange for Definitive Notes, receive Definitive Notes in an amount equal to its entitlement to the principal amount represented by the Permanent Global Note. However, a Noteholder who holds a principal amount of less than the minimum denomination may not receive a Definitive Note and would need to purchase a principal amount of Notes such that its holding is an integral multiple of the minimum denomination.

If:

- (a) Definitive Notes have not been duly delivered by 5.00 p.m. (London time) on the thirtieth day after the bearer has requested exchange of the Permanent Global Note for Definitive Notes; or
- (b) the Permanent Global Note was originally issued in exchange for part only of a Temporary Global Note representing the Notes and such Temporary Global Note becomes void in accordance with its terms; or
- (c) the Permanent Global Note (or any part thereof) has become due and payable in accordance with the Terms and Conditions of the Notes or the date for final redemption of the Permanent Global Note has occurred and, in either case, payment in full of the amount of principal falling due with all accrued interest thereon has not been made to the bearer in accordance with the terms of the Permanent Global Note on the due date for payment,

then the Permanent Global Note (including the obligation to deliver Definitive Notes) will become void at 5.00 p.m. (London time) on such thirtieth day (in the case of (a) above) or at 5.00 p.m. (London time) on the date on which such Temporary Global Note becomes void (in the case of (b) above) or at 5.00 p.m. (London time) on such due date ((c) above) and the bearer of the Permanent Global Note will have no further rights thereunder (but without prejudice to the rights which the bearer of the Permanent Global Note or others may have under the Deed of Covenant).

## Temporary Global Note exchangeable for Definitive Notes

If the relevant Final Terms specifies the form of Notes as being "Temporary Global Note exchangeable for Definitive Notes" and also specifies that the TEFRA C Rules are applicable or that neither the TEFRA C Rules or the TEFRA D Rules are applicable, then the Notes will initially be in the form of a Temporary Global Note which will be exchangeable, in whole but not in part, for Definitive Notes not earlier than 40 days after the issue date of the relevant Tranche of the Notes.

If the relevant Final Terms specifies the form of Notes as being "Temporary Global Note exchangeable for Definitive Notes" and also specifies that the TEFRA D Rules are applicable, then the Notes will initially be in the form of a Temporary Global Note which will be exchangeable, in whole or in part, for Definitive Notes not earlier than 40 days after the issue date of the relevant Tranche of the Notes upon certification as to non-U.S. beneficial ownership. Interest payments in respect of the Notes cannot be collected without such certification of non-U.S. beneficial ownership.

Whenever the Temporary Global Note is to be exchanged for Definitive Notes, the Issuer shall procure the prompt delivery (free of charge to the bearer) of such Definitive Notes, duly authenticated and with Coupons and Talons attached (if so specified in the relevant Final Terms), in an aggregate principal amount equal to the principal amount of the Temporary Global Note to the bearer of the Temporary Global Note against the surrender of the Temporary Global Note to or to the order of the Fiscal Agent within 60 days of the bearer requesting such exchange.

If:

- (a) Definitive Notes have not been duly delivered by 5.00 p.m. (London time) on the thirtieth day after the bearer has requested exchange of the Temporary Global Note for Definitive Notes; or
- (b) the Temporary Global Note (or any part thereof) has become due and payable in accordance with the Terms and Conditions of the Notes or the date for final redemption of the Temporary Global Note has occurred and, in either case, payment in full of the amount of principal falling due with all accrued interest thereon has not been made to the bearer in accordance with the terms of the Temporary Global Note on the due date for payment,

then the Temporary Global Note (including the obligation to deliver Definitive Notes) will become void at 5.00 p.m. (London time) on such thirtieth day (in the case of (a) above) or at 5.00 p.m. (London time) on such due date (in the case of (b) above) and the bearer of the Temporary Global Note will have no further rights thereunder (but without prejudice to the rights which the bearer of the Temporary Global Note or others may have under the Deed of Covenant).

## Permanent Global Note exchangeable for Definitive Notes

If the relevant Final Terms specifies the form of Notes as being "Permanent Global Note exchangeable for Definitive Notes", then the Notes will initially be in the form of a Permanent Global Note which will be exchangeable in whole, but not in part, for Definitive Notes:

- (a) on the expiry of such period of notice as may be specified in the relevant Final Terms; or
- (b) at any time, if so specified in the relevant Final Terms; or
- (c) if the relevant Final Terms specifies "in the limited circumstances described in the Permanent Global Note", then if either of the following events occurs:
  - (i) Euroclear or Clearstream, Luxembourg or any other relevant clearing system is closed for business for a continuous period of 14 days (other than by reason of legal holidays) or announces an intention permanently to cease business; or

## (ii) any of the circumstances described in Condition 12 (*Events of Default*) occurs and is continuing.

Where interests in the Permanent Global Note are to be exchanged for Definitive Notes in the circumstances described in (i) and (ii) above, Notes may only be issued in denominations which are integral multiples of the minimum denomination and may only be traded in such amounts, whether in global or definitive form. As an exception to the above rule, where the Permanent Global Note may only be exchanged in the limited circumstances described in (iii) above, Notes may be issued in denominations which represent the aggregate of (i) a minimum denomination of  $\leq 100,000$ , plus (ii) integral multiples of  $\leq 1,000$ , provided that such denominations are not less than  $\leq 100,000$  nor more than  $\leq 199,000$ . For the avoidance of doubt, each holder of Notes of such denominations will, upon exchange for Definitive Notes, receive Definitive Notes in an amount equal to its entitlement to the principal amount represented by the Permanent Global Note. However, a Noteholder who holds a principal amount of less than the minimum denomination may not receive a Definitive Note and would need to purchase a principal amount of Notes such that its holding is an integral multiple of the minimum denomination.

Whenever the Permanent Global Note is to be exchanged for Definitive Notes, the Issuer shall procure the prompt delivery (free of charge to the bearer) of such Definitive Notes, duly authenticated and with Coupons and Talons attached (if so specified in the Final Terms), in an aggregate principal amount equal to the principal amount of Notes represented by the Permanent Global Note to the bearer of the Permanent Global Note against the surrender of the Permanent Global Note to or to the order of the Fiscal Agent within 60 days of the bearer requesting such exchange.

If:

- (a) Definitive Notes have not been duly delivered by 5.00 p.m. (London time) on the thirtieth day after the bearer has requested exchange of the Permanent Global Note for Definitive Notes; or
- (b) the Permanent Global Note (or any part thereof) has become due and payable in accordance with the Terms and Conditions of the Notes or the date for final redemption of the Permanent Global Note has occurred and, in either case, payment in full of the amount of principal falling due with all accrued interest thereon has not been made to the bearer in accordance with the terms of the Permanent Global Note on the due date for payment,

then the Permanent Global Note (including the obligation to deliver Definitive Notes) will become void at 5.00 p.m. (London time) on such thirtieth day (in the case of (a) above) or at 5.00 p.m. (London time) on such due date ((b) above) and the bearer of the Permanent Global Note will have no further rights thereunder (but without prejudice to the rights which the bearer of the Permanent Global Note or others may have under the Deed of Covenant).

## **Rights under Deed of Covenant**

Under the Deed of Covenant, persons shown in the records of Euroclear and/or Clearstream, Luxembourg and/or any other relevant clearing system as being entitled to an interest in a Temporary Global Note or a Permanent Global Note which becomes void will acquire directly against the Issuer all those rights to which they would have been entitled if, immediately before the Temporary Global Note or Permanent Global Note became void, they had been the holders of Definitive Notes in an aggregate principal amount equal to the principal amount of Notes they were shown as holding in the records of Euroclear and/or Clearstream, Luxembourg and/or any other relevant clearing system.

## Terms and Conditions applicable to the Notes

The terms and conditions applicable to any Definitive Note will be endorsed on that Note and will consist of the terms and conditions set out under "*Terms and Conditions of the Notes*" below and the provisions of the relevant Final Terms which complete those terms and conditions.

The terms and conditions applicable to any Note in global form will differ from those terms and conditions which would apply to the Note were it in definitive form to the extent described under "Summary of Provisions Relating to the Notes while in Global Form" below.

- (a) **Programme**: Ferrovie dello Stato Italiane S.p.A. (the "**Issuer**") has established a Euro Medium Term Note Programme (the "**Programme**") for the issuance of up to €4,500,000,000 in aggregate principal amount of notes (the "**Notes**").
- (b) Final Terms: Notes issued under the Programme are issued in series (each a "Series") and each Series may comprise one or more tranches (each a "Tranche") of Notes. - (c) Agency Agreement: The Notes are the subject of an issue and paying agency agreement dated 13 June 2017 (the "Agency Agreement") between the Issuer, Deutsche Bank AG, London Branch as fiscal agent (the "Fiscal Agent", which expression includes any successor fiscal agent appointed from time to time in connection with the Notes) and the paying agents named therein (together with the Fiscal Agent, the "Paying Agents", which expression includes any successor or additional paying agents appointed from time to time in connection with the Notes).
- (d) **The Notes:** All subsequent references in these Conditions to "Notes" are to the Notes which are the subject of the relevant Final Terms. Copies of the Agency Agreement are available for inspection by Noteholders during normal business hours at the Specified Offices of each of the Paying Agents, the initial Specified Offices of which are set out below. In case of Notes which, when issued in definitive form, have more than 27 interest payments remaining, talons for further Coupons will be attached on issue ("Talons").

"**Consolidated Assets**" means, with respect to any date, the consolidated total assets of the Group as reported in the most recently published audited annual consolidated financial statements of the Issuer;

"**Consolidated Revenues**" means, with respect to any date, the consolidated total revenues of the Group as reported in the most recently published audited annual consolidated financial statements of the Issuer;

- (a) on terms approved by an Extraordinary Resolution of the Noteholders; or
- (b) occurring by operation of law; or
- (c) in the case of a Material Subsidiary, whilst solvent whereby all or a substantial part of the assets and undertaking of such Material Subsidiary are transferred to or otherwise vested in the Issuer or another Material Subsidiary (or a Subsidiary which, as a result of such transfer or vesting, becomes a Material Subsidiary); or
- (d) in the case of the Issuer, whilst solvent whereby all or a substantial part of the assets and undertaking of the Issuer are transferred to an entity (such entity being, for the avoidance of doubt, prior to or immediately upon such transfer, a Subsidiary of the Issuer) and such entity (1) assumes or maintains (as the case may be) liability as principal debtor in respect of the Notes; and (2) continues substantially to carry on the business of the Issuer;

#### "Permitted Security Interest" means:

- (a) any Security Interest arising by operation of law (or agreement evidencing the same) in the ordinary course of business of the Issuer or any of its Subsidiaries which does not (either alone or together with any one or more other such Security Interests) materially impair the operation of such business prior to any enforcement of any such Security Interest or, as appropriate, Security Interests against the assets to which it or, as appropriate, they attach(es);
- (b) in the case of any entity which becomes a Subsidiary of any member of the Group after the Issue Date of the Notes, any Security Interest securing Relevant Indebtedness existing over its assets at the time it becomes such a Subsidiary **provided that** the Security Interest was not created in contemplation of or in connection with it becoming a Subsidiary and the amounts secured have not been increased in contemplation of or in connection with such acquisitions;
- (c) any Security Interest securing any Project Finance Indebtedness in the form of Relevant Indebtedness;
- (d) any Security Interest created to secure loans or notes provided, supported or subsidised by a governmental agency, export credit agency or a lending organisation established by the United Nations, the European Union or other international treaty organisation (such as the European Investment Bank and Eurofima – European Company for the Financing of Railroad Rolling Stock);
- (e) any Security Interest created over (1) the receivables of a Securitisation Entity (and any bank account to which such proceeds are deposited) which are subject to a Non-recourse Securitisation as security for Non-recourse Securitisation Debt raised by such Securitisation Entity in respect of such receivables; and/or (2) the shares or other interests owned by any member of the Group in any Securitisation Entity as security for Non-recourse Securitisation Entity as security for Non-recourse Securitisation Debt raised by such Securitisation Entity, provided, in each case, that the receivables or revenues which are the subject of the relevant Non-recourse Securitisation comprise all or substantially all of the business of such Securitisation Entity, or any Security Interest referred to in this paragraph (or any successive extensions, renewals or replacements thereof) or extend, renew or refinance any Relevant Indebtedness secured by any Security Interest permitted by this paragraph;
- (f) any Security Interest created in connection with convertible bonds or notes where the Security Interest is created over the assets into which the convertible bonds or notes may be converted and secures only the obligation of the Issuer to effect the conversion of the bonds or notes into such assets;

- (g) to the extent that it does not fall within paragraphs (a) to (f) above, any Security Interest in existence on the date of this Base Prospectus which secures Indebtedness outstanding on such date; and
- (h) any Security Interest created in substitution of any Security Interest permitted under paragraphs (a) to (g) above over the same or substituted assets **provided that** (1) the principal amount secured by the substitute Security Interest does not exceed the principal amount outstanding and secured by the initial Security Interest and (2) in the case of substituted assets, the market value of the substituted assets as at the time of substitution does not exceed the market value of the assets replaced,

provided that the aggregate amount of any Indebtedness secured by any Security Interest pursuant to paragraphs (b) to (h) above shall not, at any time, exceed 20 per cent. of the Group's Consolidated Assets;

"**Person**" means any individual, company, corporation, firm, partnership, joint venture, association, organisation, state or agency of a state or other entity, whether or not having separate legal personality;

"**Principal Financial Centre**" means, in relation to any currency, the principal financial centre for that currency **provided**, **however**, **that**:

- (a) in relation to euro, it means the principal financial centre of such Member State of the European Union as is selected (in the case of a payment) by the payee or (in the case of a calculation) by the Calculation Agent; and
- (b) in relation to New Zealand dollars, it means either Wellington or Auckland as is selected (in the case of a payment) by the payee or (in the case of a calculation) by the Calculation Agent;

"**Project**" means the ownership, development, design, construction, operation and maintenance of the High Speed Project;

"**Project Finance Indebtedness**" means any present or future, secured or unsecured, Indebtedness of any member of the Group incurred to finance or refinance the Project, whereby (A) the claims of the relevant creditor(s) against the borrower are limited to (i) the amount of cash flow or net cash flow generated by and through the Project during the tenor of such Project Finance Indebtedness and/or (ii) the amount of proceeds deriving from the enforcement of any Security Interest taken over the Project to secure the Project Finance Indebtedness and (B) the relevant creditor has no recourse whatsoever against any assets of any member of the Group other than the Project and the Security Interest taken over the Project to secure the Project Finance Indebtedness;

"**Put Option Notice**" means a notice which must be delivered to a Paying Agent by any Noteholder wanting to exercise a right to redeem a Note at the option of the Noteholder;

"**Put Option Receipt**" means a receipt issued by a Paying Agent to a depositing Noteholder upon deposit of a Note with such Paying Agent by any Noteholder wanting to exercise a right to redeem a Note at the option of the Noteholder;

"**Rate of Interest**" means the rate or rates (expressed as a percentage per annum) of interest payable in respect of the Notes specified in the relevant Final Terms or calculated or determined in accordance with the provisions of these Conditions and/or the relevant Final Terms;

"**Rating Agency**" means any of Fitch Italia S.p.A. or Standard & Poor's Credit Market Services Europe Limited, and any other rating agency substituted for either of them by the Issuer and, in each case, any of their respective successors to the rating business thereof;

"**Redemption Amount**" means, as appropriate, the Final Redemption Amount, the Early Redemption Amount (Tax), the Optional Redemption Amount (Call), the Optional Redemption Amount (Put), the Change of Control Redemption Amount, the Early Termination Amount or

such other amount in the nature of a redemption amount as may be specified in the relevant Final Terms;

"**Reference Banks**" has the meaning given in the relevant Final Terms or, if none, four major banks selected by the Calculation Agent in the market that is most closely connected with the Reference Rate;

"**Reference Currency**" has the meaning given in the relevant Final Terms;

"Reference Price" has the meaning given in the relevant Final Terms;

"**Reference Rate**" means EURIBOR, LIBOR or the CMS Rate as specified in the relevant Final Terms in respect of the currency and period specified in the relevant Final Terms;

"Regular Period" means:

- (a) in the case of Notes where interest is scheduled to be paid only by means of regular payments, each period from and including the Interest Commencement Date to but excluding the first Interest Payment Date and each successive period from and including one Interest Payment Date to but excluding the next Interest Payment Date;
- (b) in the case of Notes where, apart from the first Interest Period, interest is scheduled to be paid only by means of regular payments, each period from and including a Regular Date falling in any year to but excluding the next Regular Date, where "Regular Date" means the day and month (but not the year) on which any Interest Payment Date falls; and
- (c) in the case of Notes where, apart from one Interest Period other than the first Interest Period, interest is scheduled to be paid only by means of regular payments, each period from and including a Regular Date falling in any year to but excluding the next Regular Date, where "**Regular Date**" means the day and month (but not the year) on which any Interest Payment Date falls other than the Interest Payment Date falling at the end of the irregular Interest Period;

"**Relevant Date**" means, in relation to any payment, whichever is the later of (a) the date on which the payment in question first becomes due and (b) if the full amount payable has not been received in the Principal Financial Centre of the currency of payment by the Fiscal Agent on or prior to such due date, the date on which (the full amount having been so received) notice to that effect has been given to the Noteholders;

"Relevant Financial Centre" has the meaning given in the relevant Final Terms;

"**Relevant Indebtedness**" means (i) any Indebtedness, whether present or future, which is in the form of or represented by any bond, note (including, for the avoidance of doubt, any note issued on a private placement basis to investors located in the United States or elsewhere), debenture, debenture stock, loan stock, certificate, commercial paper or other instrument which is, or is capable of being, listed, quoted or traded on any stock exchange, over-the-counter or other organised market for securities or (ii) any guarantee and/or indemnity in relation to any such Indebtedness;

"**Relevant Screen Page**" means the page, section or other part of a particular information service (including, without limitation, Reuters) specified as the Relevant Screen Page in the relevant Final Terms, or such other page, section or other part as may replace it on that information service or such other information service, in each case, as may be nominated by the Person providing or sponsoring the information appearing there for the purpose of displaying rates or prices comparable to the Reference Rate;

#### "Relevant Swap Rate" means:

(a) where the Reference Currency is Euro, the mid-market annual swap rate determined on the basis of the arithmetic mean of the bid and offered rates for the annual fixed leg, calculated on a 30/360 day count basis, of a fixed-for-floating euro interest rate swap transaction with a term equal to the Designated Maturity commencing on the first day of the relevant Interest Period and in a Representative Amount with an acknowledged dealer of good credit in the swap market, where the floating leg, in each case calculated on an Actual/360 day count basis, is equivalent to EUR-EURIBOR-Reuters (as defined in the ISDA Definitions) with a designated maturity determined by the Calculation Agent by reference to standard market practice and/or the ISDA Definitions;

- (b) where the Reference Currency is sterling, the mid-market semi-annual swap rate determined on the basis of the arithmetic mean of the bid and offered rates for the semi-annual fixed leg, calculated on an Actual/365 (Fixed) day count basis, of a fixed-for-floating Sterling interest rate swap transaction with a term equal to the Designated Maturity commencing on the first day of the relevant Interest Period and in a Representative Amount with an acknowledged dealer of good credit in the swap market, where the floating leg, in each case calculated on an Actual/365 (Fixed) day count basis, is equivalent (A) if the Designated Maturity is greater than one year, to GBP-LIBOR-BBA (as defined in the ISDA Definitions) with a designated maturity of six months or (B) if the Designated Maturity is one year or less, to GBP-LIBOR-BBA with a designated maturity of three months;
- (c) where the Reference Currency is United States dollars, the mid-market semi-annual swap rate determined on the basis of the mean of the bid and offered rates for the semi-annual fixed leg, calculated on a 30/360 day count basis, of a fixed-for-floating United States dollar interest rate swap transaction with a term equal to the Designated Maturity commencing on the first day of the relevant Interest Period and in a Representative Amount with an acknowledged dealer of good credit in the swap market, where the floating leg, calculated on an Actual/360 day count basis, is equivalent to USD-LIBOR-BBA (as defined in the ISDA Definitions) with a designated maturity of three months; and
- (d) where the Reference Currency is any other currency or if the Final Terms specify otherwise, the mid-market swap rate as determined in accordance with the applicable Final Terms;

"**Relevant Time**" has the meaning given in the relevant Final Terms;

"**Representative Amount**" means an amount that is representative for a single transaction in the relevant market at the relevant time;

"**Reserved Matter**" has the meaning given to such term in Condition 16(a) (*Meetings of Noteholders*);

"**Securitisation Entity**" means any special purpose vehicle created for the sole purpose of carrying out, or otherwise used solely for the purpose of carrying out a Non-recourse Securitisation or any other Subsidiary which is effecting Non-recourse Securitisations;

"**Security Interest**" means any mortgage, charge, pledge, lien or other security interest including, without limitation, anything analogous to any of the foregoing under the laws of any jurisdiction;

"Specified Currency" has the meaning given in the relevant Final Terms;

"**Specified Denomination**(s)" has the meaning given in the relevant Final Terms;

"Specified Office" has the meaning given in the Agency Agreement;

"Specified Period" has the meaning given in the relevant Final Terms;

"Standard Securitisation Undertakings" means representations, warranties, covenants and indemnities entered into by any member of the Group from time to time which are customary in relation to Non-recourse Securitisations, including any performance undertakings with respect to servicing obligations or undertakings with respect to breaches of representations or warranties;

"**Subsidiary**" means, a company which is a *società controllata* as provided by Article 2359, paragraph 1 of the Italian Civil Code;

"**TARGET2**" means the Trans-European Automated Real-Time Gross Settlement Express Transfer payment system which utilises a single shared platform and which was launched on 19 November 2007;

"**TARGET Settlement Day**" means any day on which TARGET2 is open for the settlement of payments in euro;

"Treaty" means the Treaty on the Functioning of the European Union, as amended; and

"Zero Coupon Note" means a Note specified as such in the relevant Final Terms.

(b) *Interpretation* 

In these Conditions:

- (i) if the Notes are Zero Coupon Notes, references to Coupons and Couponholders are not applicable;
- (ii) if Talons are specified in the relevant Final Terms as being attached to the Notes at the time of issue, references to Coupons shall be deemed to include references to Talons;
- (iii) if Talons are not specified in the relevant Final Terms as being attached to the Notes at the time of issue, references to Talons are not applicable;
- (iv) any reference to principal shall be deemed to include the Redemption Amount, any additional amounts in respect of principal which may be payable under Condition 11 (*Taxation*), any premium payable in respect of a Note and any other amount in the nature of principal payable pursuant to these Conditions;
- (v) any reference to interest shall be deemed to include any additional amounts in respect of interest which may be payable under Condition 11 (*Taxation*) and any other amount in the nature of interest payable pursuant to these Conditions;
- (vi) references to Notes being "outstanding" shall be construed in accordance with the Agency Agreement;
- (vii) if an expression is stated in Condition 2(a) (*Definitions*) to have the meaning given in the relevant Final Terms, but the relevant Final Terms gives no such meaning or specifies that such expression is "not applicable", then such expression is not applicable to the Notes; and
- (viii) any reference to the Agency Agreement shall be construed as a reference to the Agency Agreement, as amended and/or supplemented up to and including the Issue Date of the Notes.

#### 3. **Form, Denomination and Title**

The Notes are in bearer form in the Specified Denomination(s) with Coupons and, if specified in the relevant Final Terms, Talons attached at the time of issue. In the case of a Series of Notes with more than one Specified Denomination, Notes of one Specified Denomination will not be exchangeable for Notes of another Specified Denomination. Title to the Notes and the Coupons will pass by delivery. The holder of any Note or Coupon shall (except as otherwise required by law) be treated as its absolute owner for all purposes (whether or not it is overdue and regardless of any notice of ownership, trust or any other interest therein, any writing thereon or any notice of any previous loss or theft thereof) and no Person shall be liable for so treating such holder. No person shall have any right to enforce any term or condition of any Note under the Contracts (Rights of Third Parties) Act 1999.

#### 4. Status

The Notes constitute direct, general and unconditional obligations of the Issuer which will at all times rank *pari passu* among themselves and at least *pari passu* with all other present and future unsecured

obligations of the Issuer, save for such obligations as may be preferred by provisions of law that are both mandatory and of general application.

## 5. Negative Pledge

So long as any Note remains outstanding, the Issuer shall not, and the Issuer shall ensure that none of its Material Subsidiaries will, create or permit to subsist any Security Interest (other than a Permitted Security Interest) upon the whole or any part of its present or future assets to secure any Relevant Indebtedness or Guarantee of Relevant Indebtedness without (a) at the same time or prior thereto securing the Notes equally and rateably therewith or (b) providing such other Security Interest for the Notes as may be approved by an Extraordinary Resolution of Noteholders or (c) the prior written approval by an Extraordinary Resolution of Noteholders.

## 6. **Fixed Rate Note Provisions**

- (a) *Application*: This Condition 6 (*Fixed Rate Note Provisions*) is applicable to the Notes only if the Fixed Rate Note Provisions are specified in the relevant Final Terms as being applicable.
- (b) *Accrual of interest*: The Notes bear interest from the Interest Commencement Date at the Rate of Interest payable in arrear on each Interest Payment Date, subject as provided in Condition 10 (*Payments*). Each Note will cease to bear interest from the due date for final redemption unless, upon due presentation, payment of the Redemption Amount is improperly withheld or refused, in which case it will continue to bear interest in accordance with this Condition 6 (as well after as before judgment) until whichever is the earlier of (i) the day on which all sums due in respect of such Note up to that day are received by or on behalf of the relevant Noteholder and (ii) the day which is seven days after the Fiscal Agent has notified the Noteholders that it has received all sums due in respect of the Notes up to such seventh day (except to the extent that there is any subsequent default in payment).
- (c) *Fixed Coupon Amount*: The amount of interest payable in respect of each Note for any Interest Period shall be the relevant Fixed Coupon Amount and, if the Notes are in more than one Specified Denomination, shall be the relevant Fixed Coupon Amount in respect of the relevant Specified Denomination.
- (d) Calculation of interest amount: The amount of interest payable in respect of each Note for any period for which a Fixed Coupon Amount is not specified shall be calculated by applying the Rate of Interest to the Calculation Amount, multiplying the product by the relevant Day Count Fraction, rounding the resulting figure to the nearest sub-unit of the Specified Currency (half a sub-unit being rounded upwards) and multiplying such rounded figure by a fraction equal to the Specified Denomination of such Note divided by the Calculation Amount. For this purpose a "sub-unit" means, in the case of any currency other than euro, the lowest amount of such currency that is available as legal tender in the country of such currency and, in the case of euro, means one cent.

#### 7. Floating Rate Note Provisions

- (a) *Application*: This Condition 7 (*Floating Rate Note Provisions*) is applicable to the Notes only if the Floating Rate Note Provisions are specified in the relevant Final Terms as being applicable.
- (b) *Accrual of interest*: The Notes bear interest from, and including, the Interest Commencement Date at the Rate of Interest payable in arrear on each Interest Payment Date, subject as provided in Condition 10 (*Payments*). Each Note will cease to bear interest from the due date for final redemption unless, upon due presentation, payment of the Redemption Amount is improperly withheld or refused, in which case it will continue to bear interest in accordance with this Condition (as well after as before judgment) until whichever is the earlier of (i) the day on which all sums due in respect of such Note up to that day are received by or on behalf of the relevant Noteholder and (ii) the day which is seven days after the Fiscal Agent has notified the Noteholders that

it has received all sums due in respect of the Notes up to such seventh day (except to the extent that there is any subsequent default in payment).

- (c) Screen Rate Determination for Floating Rate Notes other than Floating Rate Notes linked to the CMS Rate: If Screen Rate Determination is specified in the relevant Final Terms as the manner in which the Rate(s) of Interest is/are to be determined and "CMS Rate" is not specified as the Reference Rate, the Rate of Interest applicable to the Notes for each Interest Period will be determined by the Calculation Agent on the following basis:
- (i) if the Reference Rate is a composite quotation or customarily supplied by one entity, the Calculation Agent will determine the Reference Rate which appears on the Relevant Screen Page as of the Relevant Time on the relevant Interest Determination Date;
- (ii) if Linear Interpolation is specified as applicable in respect of an Interest Period in the applicable Final Terms, the Rate of Interest for such Interest Period shall be calculated by the Calculation Agent by straight-line linear interpolation by reference to two rates which appear on the Relevant Screen Page as of the Relevant Time on the relevant Interest Determination Date, where:
  - (A) one rate shall be determined as if the relevant Interest Period were the period of time for which rates are available next shorter than the length of the relevant Interest Period; and
  - (B) the other rate shall be determined as if the relevant Interest Period were the period of time for which rates are available next longer than the length of the relevant Interest Period;

*provided, however, that* if no rate is available for a period of time next shorter or, as the case may be, next longer than the length of the relevant Interest Period, then the Calculation Agent shall determine such rate at such time and by reference to such sources as it determines appropriate;

- (iii) in any other case, the Calculation Agent will determine the arithmetic mean of the Reference Rates which appear on the Relevant Screen Page as of the Relevant Time on the relevant Interest Determination Date;
- (iv) if, in the case of (i) above, such rate does not appear on that page or, in the case of (iii) above, fewer than two such rates appear on that page or if, in either case, the Relevant Screen Page is unavailable, the Calculation Agent will:
  - (A) request the principal Relevant Financial Centre office of each of the Reference Banks to provide a quotation of the Reference Rate at approximately the Relevant Time on the Interest Determination Date to prime banks in the Relevant Financial Centre interbank market in an amount that is representative for a single transaction in that market at that time; and
  - (B) determine the arithmetic mean of such quotations; and
- (v) if fewer than two such quotations are provided as requested, the Calculation Agent will determine the arithmetic mean of the rates (being the nearest to the Reference Rate, as determined by the Calculation Agent) quoted by major banks in the Principal Financial Centre of the Specified Currency, selected by the Calculation Agent, at approximately 11.00 a.m. (local time in the Principal Financial Centre of the Specified Currency) on the first day of the relevant Interest Period for loans in the Specified Currency to leading European banks for a period equal to the relevant Interest Period and in an amount that is representative for a single transaction in that market at that time,

and the Rate of Interest for such Interest Period shall be the sum of the Margin and the rate or (as the case may be) the arithmetic mean so determined; **provided**, **however**, **that** if the Calculation Agent is unable to determine a rate or (as the case may be) an arithmetic mean in accordance with the above provisions in relation to any Interest Period, the Rate of Interest applicable to the

Notes during such Interest Period will be the sum of the Margin and the rate or (as the case may be) the arithmetic mean last determined in relation to the Notes in respect of the immediately preceding Interest Period for which such rate or arithmetic mean was determined.

(d) Screen Rate Determination for Floating Rate Notes which are linked to the CMS Rate: If Screen Rate Determination is specified in the relevant Final Terms as the manner in which the Rate(s) of Interest is/are to be determined and "CMS Rate" is specified as the Reference Rate, the Rate of Interest applicable to the Notes for each Interest Period will be determined by the Calculation Agent by reference to the following formula:

#### CMS Rate plus Margin

If the Relevant Screen Page is not available, the Calculation Agent shall request each of the CMS Reference Banks to provide the Calculation Agent with its quotation for the Relevant Swap Rate at approximately 11.00 a.m. (local time in the Principal Financial Centre of the Specified Currency) on the Interest Determination Date in question. If at least three of the CMS Reference Banks provide the Calculation Agent with such quotation, the CMS Rate for such Interest Period shall be the arithmetic mean of such quotations, eliminating the highest quotation (or, in the event of equality, one of the highest) and the lowest quotation (or, in the event of equality, one of the lowest).

If, on any Interest Determination Date, less than three or none of the CMS Reference Banks provides the Calculation Agent with such quotations as provided in the preceding paragraph, the CMS Rate shall be determined by the Calculation Agent in good faith on such commercial basis as considered appropriate by the Calculation Agent in its absolute discretion, in accordance with standard market practice.

- (e) **ISDA Determination**: If ISDA Determination is specified in the relevant Final Terms as the manner in which the Rate(s) of Interest is/are to be determined, the Rate of Interest applicable to the Notes for each Interest Period will be the sum of the Margin and the relevant ISDA Rate where "**ISDA Rate**" in relation to any Interest Period means a rate equal to the Floating Rate (as defined in the ISDA Definitions) that would be determined by the Calculation Agent under an interest rate swap transaction if the Calculation Agent were acting as Calculation Agent for that interest rate swap transaction under the terms of an agreement incorporating the ISDA Definitions and under which:
- (i) the Floating Rate Option (as defined in the ISDA Definitions) is as specified in the relevant Final Terms;
- (ii) the Designated Maturity (as defined in the ISDA Definitions) is a period specified in the relevant Final Terms;
- (iii) the relevant Reset Date (as defined in the ISDA Definitions) is either (A) if the relevant Floating Rate Option is based on the London inter-bank offered rate (LIBOR) or on the Euro-zone inter-bank offered rate (EURIBOR) for a currency, the first day of that Interest Period or (B) in any other case, as specified in the relevant Final Terms; and
- (iv) if Linear Interpolation is specified as applicable in respect of an Interest Period in the applicable Final Terms, the Rate of Interest for such Interest Period shall be calculated by the Calculation Agent by straight-line linear interpolation by reference to two rates based on the relevant Floating Rate Option, where:

(A) one rate shall be determined as if the Designated Maturity were the period of time for which rates are available next shorter than the length of the relevant Interest Period; and

(B) the other rate shall be determined as if the Designated Maturity were the period of time for which rates are available next longer than the length of the relevant Interest Period

*provided, however, that* if there is no rate available for a period of time next shorter than the length of the relevant Interest Period or, as the case may be, next longer than the length of the relevant Interest Period, then the Calculation Agent shall determine such rate at such time and by reference to such sources as it determines appropriate.

- (f) *Maximum or Minimum Rate of Interest*: If any Maximum Rate of Interest or Minimum Rate of Interest is specified in the relevant Final Terms, then the Rate of Interest shall in no event be greater than the maximum or be less than the minimum so specified.
- (g) Calculation of Interest Amount: The Calculation Agent will, as soon as practicable after the time at which the Rate of Interest is to be determined in relation to each Interest Period, calculate the Interest Amount payable in respect of each Note for such Interest Period. The Interest Amount will be calculated by applying the Rate of Interest for such Interest Period to the Calculation Amount and multiplying the product by the relevant Day Count Fraction, rounding the resulting figure to the nearest sub-unit of the Specified Currency (half a sub-unit being rounded upwards) and multiplying such rounded figure by a fraction equal to the Specified Denomination of the relevant Note divided by the Calculation Amount. For this purpose, a "sub-unit" means, in the case of any currency other than euro, the lowest amount of such currency that is available as legal tender in the country of such currency and, in the case of euro, means one cent.
- (h) Publication: The Calculation Agent will cause each Rate of Interest and Interest Amount determined by it, together with the relevant Interest Payment Date, and any other amount(s) required to be determined by it together with any relevant payment date(s) to be notified to the Issuer and the Paying Agents and each competent authority, stock exchange and/or quotation system (if any) by which the Notes have then been admitted to listing, trading and/or quotation as soon as practicable after such determination but (in the case of each Rate of Interest, Interest Amount and Interest Payment Date) in any event not later than the first day of the relevant Interest Period. Notice thereof shall also promptly be given to the Noteholders. The Calculation Agent will be entitled to recalculate any Interest Amount (on the basis of the foregoing provisions) without notice in the event of an extension or shortening of the relevant Interest Period. If the Calculation Amount is less than the minimum Specified Denomination, the Calculation Agent shall not be obliged to publish each Interest Amount but instead may publish only the Calculation Amount and the Interest Amount in respect of a Note having the minimum Specified Denomination.
- (i) Notifications etc: All notifications, opinions, determinations, certificates, calculations, quotations and decisions given, expressed, made or obtained for the purposes of this Condition by the Calculation Agent will (in the absence of manifest error) be binding on the Issuer, the Paying Agents, the Noteholders and the Couponholders and (subject as aforesaid) no liability to any such Person will attach to the Calculation Agent in connection with the exercise or non-exercise by it of its powers, duties and discretions for such purposes.

#### 8. Zero Coupon Note Provisions

- (a) *Application*: This Condition 8 (*Zero Coupon Note Provisions*) is applicable to the Notes only if the Zero Coupon Note Provisions are specified in the relevant Final Terms as being applicable.
- (b) *Late payment on Zero Coupon Notes*: If the Redemption Amount payable in respect of any Zero Coupon Note is improperly withheld or refused, the Redemption Amount shall thereafter be an amount equal to the sum of:
- (i) the Reference Price; and
- (ii) the product of the Accrual Yield (compounded annually) being applied to the Reference
   Price on the basis of the relevant Day Count Fraction from (and including) the Issue
   Date to (but excluding) whichever is the earlier of (i) the day on which all sums due in

respect of such Note up to that day are received by or on behalf of the relevant Noteholder and (ii) the day which is seven days after the Fiscal Agent has notified the Noteholders that it has received all sums due in respect of the Notes up to such seventh day (except to the extent that there is any subsequent default in payment).

#### 9. **Redemption and Purchase**

- (a) **Scheduled redemption**: Unless previously redeemed, or purchased and cancelled, the Notes will be redeemed at their Final Redemption Amount on the Maturity Date, subject as provided in Condition 10 (*Payments*).
- (b) *Redemption for tax reasons*: The Notes may be redeemed at the option of the Issuer in whole, but not in part:
- (i) at any time (if the Floating Rate Note Provisions are not specified in the relevant Final Terms as being applicable); or
- (ii) on any Interest Payment Date (if the Floating Rate Note Provisions are specified in the relevant Final Terms as being applicable),

on giving not less than 30 nor more than 60 days' notice to the Noteholders, or such other period(s) as may be specified in the relevant final terms, (which notice shall be irrevocable), at their Early Redemption Amount (Tax), together with interest accrued (if any) to the date fixed for redemption, if:

- (A) the Issuer has or will become obliged to pay additional amounts as provided or referred to in Condition 11 (*Taxation*) as a result of any change in, or amendment to, the laws or regulations of the Republic of Italy or any political subdivision or any authority or agency thereof or therein having power to tax, or any change in the application or official interpretation or administration of such laws or regulations (including a holding by a court of competent jurisdiction), which change or amendment becomes effective on or after the date of issue of the first Tranche of the Notes; and
- (B) such obligation cannot be avoided by the Issuer taking reasonable measures available to it,

provided, however, that no such notice of redemption shall be given earlier than:

- (1) where the Notes may be redeemed at any time, 90 days (or such other period as may be specified in the relevant final terms) prior to the earliest date on which the Issuer would be obliged to pay such additional amounts if a payment in respect of the Notes were then due; or
- (2) where the Notes may be redeemed only on an Interest Payment Date, 60 days (or such other period as may be specified in the relevant final terms) prior to the Interest Payment Date occurring immediately before the earliest date on which the Issuer would be obliged to pay such additional amounts if a payment in respect of the Notes were then due.

Prior to the publication of any notice of redemption pursuant to this paragraph, the Issuer shall deliver to the Fiscal Agent (A) a certificate signed by two directors of the Issuer stating that the Issuer is entitled to effect such redemption and setting forth a statement of facts showing that the conditions precedent to the right of the Issuer so to redeem have occurred and (B) an opinion of independent legal advisers of recognised standing to the effect that the Issuer has or will become obliged to pay such additional amounts as a result of such change or amendment. Upon the expiry of any such notice as is referred to in this Condition 9(b), the Issuer shall be bound to redeem the Notes in accordance with this Condition 9(b).

(c) **Redemption at the option of the Issuer**: If the Call Option is specified in the relevant Final Terms as being applicable, the Notes may be redeemed at the option of the Issuer

in whole or, if so specified in the relevant Final Terms, in part on any Optional Redemption Date (Call) at the relevant Optional Redemption Amount (Call) on the Issuer's giving not less than 30 nor more than 60 days' notice to the Noteholders, or such other period(s) as may be specified in the relevant final terms, (which notice shall be irrevocable and shall oblige the Issuer to redeem the Notes or, as the case may be, the Notes specified in such notice on the relevant Optional Redemption Date (Call) at the Optional Redemption Amount (Call) plus accrued interest (if any) to such date).

- (d) Partial redemption: If the Notes are to be redeemed in part only on any date in accordance with Condition 9(c) (Redemption at the option of the Issuer), the Notes to be redeemed shall be selected by the drawing of lots in such place as the Fiscal Agent approves and in such manner as the Fiscal Agent considers appropriate, subject to compliance with applicable law, the rules of each competent authority, stock exchange and/or quotation system (if any) by which the Notes have then been admitted to listing, trading and/or quotation and the notice to Noteholders referred to in Condition 9(c) (Redemption at the option of the Issuer) shall specify the serial numbers of the Notes so to be redeemed. If any Maximum Redemption Amount or Minimum Redemption Amount is specified in the relevant Final Terms, then the Optional Redemption Amount (Call) shall in no event be greater than the maximum or be less than the minimum so specified.
- Redemption at the option of Noteholders: If the Put Option is specified in the relevant (e) Final Terms as being applicable, the Issuer shall, at the option of the holder of any Note redeem such Note on the Optional Redemption Date (Put) specified in the relevant Put Option Notice at the relevant Optional Redemption Amount (Put) together with interest (if any) accrued to such date. In order to exercise the option contained in this Condition 9(e), the holder of a Note must, not less than 30 nor more than 60 days before the relevant Optional Redemption Date (Put) (or such other period(s) as may be specified in the relevant final terms), deposit with any Paying Agent such Note together with all unmatured Coupons relating thereto and a duly completed Put Option Notice in the form obtainable from any Paying Agent. The Paying Agent with which a Note is so deposited shall immediately notify the Issuer and shall deliver a duly completed Put Option Receipt to the depositing Noteholder. No Note, once deposited with a duly completed Put Option Notice in accordance with this Condition 9(e), may be withdrawn; provided, however, that if, prior to the relevant Optional Redemption Date (Put), any such Note becomes immediately due and payable or, upon due presentation of any such Note on the relevant Optional Redemption Date (Put), payment of the redemption moneys is improperly withheld or refused, the relevant Paying Agent shall mail notification thereof to the depositing Noteholder at such address as may have been given by such Noteholder in the relevant Put Option Notice and shall hold such Note at its Specified Office for collection by the depositing Noteholder against surrender of the relevant Put Option Receipt. For so long as any outstanding Note is held by a Paying Agent in accordance with this Condition 9(e), the depositor of such Note and not such Paying Agent shall be deemed to be the holder of such Note for all purposes.
- (f) Redemption at the option of Noteholders upon a Change of Control Put Event: If at any time while the Notes remain outstanding a Change of Control Put Event occurs, the holder of any Note will have the option (unless, prior to the giving of the Change of Control Put Notice referred to below, the Issuer gives notice to redeem the Notes in accordance with Condition 9(b) (Redemption for tax reasons)) to require the Issuer to redeem such Note on the Change of Control Put Date at its Change of Control Redemption Amount together with interest accrued to, but excluding, the Change of Control Put Date.

If a Change of Control Put Event occurs, the Issuer shall, within 14 days of the occurrence of such Change of Control Put Event, give notice (a "**Change of Control Notice**") to the Noteholders in accordance with Condition 18 (*Notices*) specifying the nature of the Change of Control and the procedure for exercising the option contained in this Condition 9(f).

To exercise the right to require redemption of this Note, the holder of this Note must deliver this Note at the specified office of any Paying Agent at any time during the normal business hours of

such Paying Agent falling within the period (the "Change of Control Put Period") of 45 days after that on which a Change of Control Notice is given, accompanied by a duly completed and signed notice of exercise in the form (for the time being current) obtainable from any specified office of any Paying Agent (a "Change of Control Put Notice") and in which the holder must specify a bank account (or, if payment is required to be made by cheque, an address) to which payment is to be made under this Condition. All unmatured coupons shall be dealt with in accordance with the provisions of Condition 10 (Payments). The Paying Agent to which such Note and Change of Control Put Notice are delivered will issue to the holder concerned a non transferable receipt (a "Change of Control Put Receipt") in respect of the Note so delivered. The Issuer shall redeem the Notes in respect of which Change of Control Put Receipt have been issued on the date (the "Change of Control Put Date") being the fifteenth day after the date of expiry of the Change of Control Put Period, unless previously redeemed and purchased. Payment in respect of any Note will be made on the Change of Control Put Date by transfer to the bank account (if any) specified in the Change of Control Put Notice (or, if an address is specified for payment by cheque, by cheque sent by first class post to such address) and, in every other case on or after the Change of Control Put Date, in each case against presentation and surrender or (as the case may be) endorsement of such Change of Control Put Receipt at the specified office of any Paying Agent in accordance with the provisions of this Condition 9(f).

For the purposes of these Conditions:

A "**Change of Control**" will be deemed to occur if the Italian Ministry of Economy and Finance (*Ministero dell'economia e delle finanze*) ("**MEF**") ceases to own either directly and/or indirectly (through any arm or body of the Italian State or any company directly or indirectly controlled by MEF) a shareholding which entitles MEF to have the majority of the voting rights in the ordinary and extraordinary shareholders' meetings of the Issuer, both at the first and second summoning (*convocazione*).

A "Change of Control Put Event" shall be deemed to occur if:

- (a) Change of Control occurs; and
- (b) if at the time of the Change of Control, the Notes carry a credit rating which is either:
  - (i) an investment grade credit rating (BBB-/Baa3/BBB-, or equivalent, or better), and such credit rating is, within 90 days of the occurrence of the Change of Control, either downgraded to a non-investment grade credit rating (BB+/Ba1/BB+, or equivalent, or worse) or withdrawn and is not, within such 90-day period, subsequently (in the case of a downgrade) upgraded to an investment grade credit rating by such Rating Agency or (in the case of a withdrawal) replaced by an investment grade credit rating from any other Rating Agency; or
  - (ii) a non-investment grade credit rating (BB+/Ba1/BB+, or equivalent, or worse), and such credit rating is, within 90 days of the occurrence of the Change of Control, either downgraded by one or more notches (for illustration, Ba1 to Ba2 being one notch) or withdrawn and is not, within such 90-day period, subsequently (in the case of a downgrade) upgraded to its earlier credit rating or better by such Rating Agency or (in the case of a withdrawal) replaced by an equivalent credit rating or better from any other Rating Agency.

For the avoidance of doubt, paragraph (b) above shall only apply in the event the Notes carry a credit rating from any Rating Agency at the time of the Change of Control.

- (g) *No other redemption*: The Issuer shall not be entitled to redeem the Notes otherwise than as provided in paragraphs (a) to (f) above.
- (h) *Early redemption of Zero Coupon Notes*: Unless otherwise specified in the relevant Final Terms, the Redemption Amount payable on redemption of a Zero Coupon Note at any time before the Maturity Date shall be an amount equal to the sum of:
- (i) the Reference Price; and

(ii) the product of the Accrual Yield (compounded annually) being applied to the Reference Price from (and including) the Issue Date to (but excluding) the date fixed for redemption or (as the case may be) the date upon which the Note becomes due and payable.

Where such calculation is to be made for a period which is not a whole number of years, the calculation in respect of the period of less than a full year shall be made on the basis of such Day Count Fraction as may be specified in the Final Terms for the purposes of this Condition 9(h) or, if none is so specified, a Day Count Fraction of 30E/360.

- (i) **Purchase:** The Issuer or any of its Subsidiaries may at any time purchase Notes in the open market or otherwise and at any price, **provided that** all unmatured Coupons are purchased therewith.
- (j) *Cancellation*: All Notes so redeemed or purchased by the Issuer or any of its Subsidiaries and any unmatured Coupons attached to or surrendered with them may be cancelled and may not be reissued or resold.

#### 10. **Payments**

- (a) **Principal:** Payments of principal shall be made only against presentation and (**provided that** payment is made in full) surrender of Notes at the Specified Office of any Paying Agent outside the United States by cheque drawn in the currency in which the payment is due on, or by transfer to an account denominated in that currency (or, if that currency is euro, any other account to which euro may be credited or transferred) and maintained by the payee with, a bank in the Principal Financial Centre of that currency.
- (b) *Interest*: Payments of interest shall, subject to paragraph (h) below, be made only against presentation and (**provided that** payment is made in full) surrender of the appropriate Coupons at the Specified Office of any Paying Agent outside the United States in the manner described in paragraph (a) above.
- (c) **Payments in New York City**: Payments of principal or interest may be made at the Specified Office of a Paying Agent in New York City if (i) the Issuer has appointed Paying Agents outside the United States with the reasonable expectation that such Paying Agents will be able to make payment of the full amount of the interest on the Notes in the currency in which the payment is due when due, (ii) payment of the full amount of such interest at the offices of all such Paying Agents is illegal or effectively precluded by exchange controls or other similar restrictions and (iii) payment is permitted by applicable United States law.
- (d) Payments subject to fiscal laws: All payments in respect of the Notes are subject in all cases to (i) any applicable fiscal or other laws and regulations in the place of payment, but without prejudice to the provisions of Condition 11 (*Taxation*); and (ii) any withholding or deduction required pursuant to an agreement described in Section 1471(b) of the U.S. Internal Revenue Code of 1986 or otherwise imposed pursuant to Sections 1471 through 1474 of that Code, any regulations or agreements thereunder, official interpretations thereof, or any law implementing an intergovernmental approach thereto. No commissions or expenses shall be charged to the Noteholders or Couponholders in respect of such payments.
- (e) **Deductions for unmatured Coupons:** If the relevant Final Terms specifies that the Fixed Rate Note Provisions are applicable and a Note is presented for payment on redemption without all unmatured Coupons relating thereto:
- (i) if the aggregate amount of the missing Coupons is less than or equal to the amount of principal due for payment, a sum equal to the aggregate amount of the missing Coupons will be deducted from the amount of principal due for payment; provided, however, that if the gross amount available for payment is less than the amount of principal due for payment, the sum deducted will be that proportion of the aggregate amount of such

missing Coupons which the gross amount actually available for payment bears to the amount of principal due for payment;

- (ii) if the aggregate amount of the missing Coupons is greater than the amount of principal due for payment:
  - (A) so many of such missing Coupons shall become void (in inverse order of maturity) as will result in the aggregate amount of the remainder of such missing Coupons (the "Relevant Coupons") being equal to the amount of principal due for payment; provided, however, that where this sub-paragraph would otherwise require a fraction of a missing Coupon to become void, such missing Coupon shall become void in its entirety; and
  - (B) a sum equal to the aggregate amount of the Relevant Coupons (or, if less, the amount of principal due for payment) will be deducted from the amount of principal due for payment; provided, however, that, if the gross amount available for payment is less than the amount of principal due for payment, the sum deducted will be that proportion of the aggregate amount of the Relevant Coupons (or, as the case may be, the amount of principal due for payment) which the gross amount actually available for payment bears to the amount of principal due for payment.

Each sum of principal so deducted shall be paid in the manner provided in paragraph (a) above against presentation and (**provided that** payment is made in full) surrender of the relevant missing Coupons.

- (f) Unmatured Coupons void: If the relevant Final Terms specifies that this Condition 10(f) is applicable or that the Floating Rate Note Provisions are applicable, on the due date for final redemption of any Note or early redemption in whole of such Note pursuant to Condition 9(b) (Redemption for tax reasons), Condition 9(e) (Redemption at the option of Noteholders), Condition 9(c) (Redemption at the option of the Issuer), Condition 9(f) (Redemption at the option of Noteholders upon a Change of Control Put Event) or Condition 12 (Events of Default), all unmatured Coupons relating thereto (whether or not still attached) shall become void and no payment will be made in respect thereof.
- (g) **Payments on business days:** If the due date for payment of any amount in respect of any Note or Coupon is not a Payment Business Day in the place of presentation, the holder shall not be entitled to payment in such place of the amount due until the next succeeding Payment Business Day in such place and shall not be entitled to any further interest or other payment in respect of any such delay.
- (h) Payments other than in respect of matured Coupons: Payments of interest other than in respect of matured Coupons shall be made only against presentation of the relevant Notes at the Specified Office of any Paying Agent outside the United States (or in New York City if permitted by paragraph (c) above).
- (i) **Partial payments:** If a Paying Agent makes a partial payment in respect of any Note or Coupon presented to it for payment, such Paying Agent will endorse thereon a statement indicating the amount and date of such payment.
- (j) Exchange of Talons: On or after the maturity date of the final Coupon which is (or was at the time of issue) part of a Coupon Sheet relating to the Notes, the Talon forming part of such Coupon Sheet may be exchanged at the Specified Office of the Fiscal Agent for a further Coupon Sheet (including, if appropriate, a further Talon but excluding any Coupons in respect of which claims have already become void pursuant to Condition 13 (*Prescription*). Upon the due date for redemption of any Note, any unexchanged Talon relating to such Note shall become void and no Coupon will be delivered in respect of such Talon.

#### 11. Taxation

- (a) *Gross up*: All payments of principal and interest in respect of the Notes and the Coupons by or on behalf of the Issuer shall be made free and clear of, and without withholding or deduction for or on account of, any present or future taxes, duties, assessments or governmental charges of whatever nature imposed, levied, collected, withheld or assessed by or on behalf of the Republic of Italy or any political subdivision therein or any authority therein or thereof having power to tax, unless the withholding or deduction of such taxes, duties, assessments, or governmental charges is required by law. In that event, the Issuer shall pay such additional amounts as will result in receipt by the Noteholders and the Couponholders after such withholding or deduction of such amounts as would have been received by them had no such withholding or deduction been required, except that no such additional amounts shall be payable in respect of any Note or Coupon presented for payment:
- (i) in the Republic of Italy;
- (ii) by or on behalf of a holder which is liable to such taxes, duties, assessments or governmental charges in respect of such Note or Coupon by reason of its having some connection with the jurisdiction by which such taxes, duties, assessments or charges have been imposed, levied, collected, withheld or assessed other than the mere holding of the Note or Coupon; or
- (iii) in the event of payment to a non Italian resident legal entity or a non Italian resident individual, to the extent that interest or other amounts are paid to a non Italian resident legal entity or a non Italian resident individual which is not resident in a country which allow for a satisfactory exchange of information with the Italian authorities (the "White List States") as listed in the Italian Ministerial Decree dated 4 September 1996, as amended from time to time; or
- (iv) by, or on behalf of, a holder who is entitled to avoid such withholding or deduction in respect of such Note or Coupon, by making a declaration or any other statement to the relevant tax authority, including but not limited to, a declaration of residence or non-residence or other similar claim for exemption; or
- (v) more than 30 days after the Relevant Date except to the extent that the holder of such Note or Coupon would have been entitled to such additional amounts on presenting such Note or Coupon for payment on the last day of such period of 30 days; or
- (vi) in relation to any payment or deduction of any interest, premium or other proceeds of any Note, or Coupon on account of *imposta sostitutiva* pursuant to Italian Legislative Decree No. 239 of 1 April 1996, as amended from time to time, except where the requirements and procedures set forth in Legislative Decree No. 239 of 1 April 1996, as amended, have not been met or complied with due to the actions or omissions of the Issuer; or
- (vii) in respect of any Note where such withholding or deduction is required pursuant to Italian Law Decree No. 512 of 30th September 1983, converted into Law No. 649 of 25th November 1983 as amended from time to time.
- (b) Taxing jurisdiction: If the Issuer becomes subject at any time to any taxing jurisdiction other than the Republic of Italy, references in these Conditions to the Republic of Italy shall be construed as references to the Republic of Italy and/or such other jurisdiction. Notwithstanding any other provision in these Conditions, the Issuer shall be entitled to withhold and deduct any amounts required to be deducted or withheld pursuant to Sections 1471 through 1474 of the U.S. Internal Revenue Code of 1986, as amended (the "Code"), or otherwise imposed pursuant to (i) any regulations thereunder or official interpretations thereof, or (ii) an intergovernmental agreement between the United States and another jurisdiction facilitating the implementation thereof, or (iii) any law implementing such an intergovernmental agreement (any such withholding or deduction,

a "**FATCA Withholding**"), and no person shall be required to pay any additional amounts in respect of FATCA Withholding.

#### 12. Events of Default

If any of the following events occurs and is continuing:

- (a) *Non-payment*: if default is made by the Issuer in the payment of any principal or interest due in respect of the Notes or any of them and the default continues for a period of 7 days in the case of principal and 14 days in the case of interest; or
- (b) **Breach of other obligations**: the Issuer defaults in the performance or observance of any of its other obligations under or in respect of the Notes and such default remains unremedied for 30 days after written notice thereof, addressed to the Issuer by any Noteholder, has been delivered to the Issuer or to the Specified Office of the Fiscal Agent; or

#### (c) Cross-default of Issuer or Material Subsidiary

- (i) any Indebtedness of the Issuer or any of its Material Subsidiaries is not paid when due or (as the case may be) within any originally applicable grace period; or
- (ii) any Indebtedness of the Issuer or any of its Material Subsidiaries becomes due and payable prior to its stated maturity otherwise than at the option of the Issuer or (as the case may be) the relevant Material Subsidiary or (**provided that** no event of default, howsoever described, has occurred) any Person entitled to such Indebtedness; or
- (iii) the Issuer or any of its Material Subsidiaries fails to pay when due any amount payable by it under any Guarantee of any Indebtedness,

**provided that** no such event shall constitute an event of default so long as and to the extent that the Issuer or the relevant Material Subsidiary is contesting in a recognised court and/or jurisdiction, in good faith, that the relevant Indebtedness or Guarantee of any Indebtedness shall be due or enforceable, as appropriate, and **provided further that** the amount of Indebtedness referred to in sub-paragraph (i) and/or sub-paragraph (ii) above and/or the amount payable under any Guarantee referred to in sub-paragraph (iii) above individually or in the aggregate exceeds €100,000,000 (or its equivalent in any other currency or currencies); or

- (d) Contratti di Programma: any of the Contratti di Programma expires and is not renewed (on substantially the same terms) within 12 months of its expiry (or is otherwise terminated), unless the parties thereto continue to perform the relevant obligations therein on materially the same terms, and unless it is replaced by any other instrument, contract, memorandum of understanding, document or agreement of any nature, law or regulation having the same effects thereto on the Group; or
- (e) Unsatisfied judgment: the Issuer fails to pay, for a period of 60 days after the date(s) of receipt of notice or, if later, the date therein specified for payment, one or more final judgment(s) or order(s) of a court of competent jurisdiction rendered against the Issuer for the payment in excess of €500,000,000 (or its equivalent in any other currency or currencies), provided that no such event shall constitute an event of default so long as and to the extent that the Issuer is contesting in a recognised court or jurisdiction, in good faith, that the relevant amount shall not be due or enforceable, as appropriate, within 60 days of receiving notice of the final judgement or order and such final judgement or order is subsequently discharged within 180 days, commencing on the date on which the Issuer commences the proceedings in the recognised court or jurisdiction; or
- (f) Insolvency etc: (i) the Issuer or any of its Material Subsidiaries is adjudicated or becomes insolvent or is unable to pay its debts as they fall due, or (ii) an administrator or liquidator of the Issuer or any of its Material Subsidiaries or the whole or a substantial part of the undertaking, assets and revenues of the Issuer or any of its Material Subsidiaries is appointed (or application for any such appointment is made)

where a "**substantial part**" of the Issuer's or any of its Material Subsidiaries' business means a part of the Issuer's or any of its Material Subsidiaries' business which accounts for 25 per cent. or more of, alternatively, the Group's Consolidated Assets or Consolidated Revenues, or (iii) the Issuer or any of its Material Subsidiaries takes any action for judicial composition proceedings with its creditors or the appointment of an administrator, liquidator, receiver, administrative receiver or other similar official in insolvency proceedings or makes a general assignment or an arrangement or composition with or for the benefit of its creditors or declares a moratorium in respect of any of its Indebtedness or any Guarantee of any Indebtedness given by it, **provided that**, in respect of (i) and (ii) above only, no such event shall constitute an event of default so long as and to the extent that the Issuer is contesting such adjudication or appointment in a recognised court or jurisdiction, in good faith within 60 days of such adjudication or appointment and such adjudication or appointment is subsequently discharged within 180 days, commencing on the date on which the Issuer commences the proceedings in the recognised court or jurisdiction; or

- (g) *Cessation of business*: the Issuer or any of its Material Subsidiaries ceases or threatens to cease to carry on all or any substantial part of its business, save for the purposes of or pursuant to, a Permitted Reorganisation, where a "substantial part" of the Issuer's or any of its Material Subsidiaries' business means a part of the relevant entity's business which accounts for 25 per cent. or more of, alternatively, the Group's Consolidated Assets or Consolidated Revenues; or

The quorum required at any such meeting will be (subject to compliance with mandatory laws, legislation, rules and regulations of Italy in force from time to time) (a) in the case of a first meeting, one or more persons present being or representing Noteholders and holding more than one half of the aggregate principal amount of the outstanding Notes; (b) in the case of an adjourned meeting, one or more persons present being or representing Noteholders and holding more than one third of the aggregate principal amount of the outstanding Notes or for voting on any of the proposal referred to a Reserved Matter (as defined below), one half of the aggregate principal amount of the outstanding Notes. The majority required to pass a resolution will be (subject to compliance with mandatory laws, legislation, rules and regulations of Italy in force from time to time): in the case of a first meeting, a vote in favour by one or more persons holding or representing more than one half of the aggregate principal amount of the Notes for the time being outstanding, and (b) in the case of an adjourned meeting, a vote in favour by one or more persons holding or representing at least two thirds of the aggregate principal amount of the Notes for the time being outstanding represented at the meeting provided, however, that (A) certain proposals, as set out in Article 2415 of the Italian Civil Code (including any proposal to modify the maturity of the Notes or the dates on which interest is payable on them; to reduce or cancel the principal amount of, or interest on, the Notes; or to change the currency of payment of the Notes) (each a "Reserved Matter"), may only be sanctioned by a resolution passed at meeting (including any adjourned meeting) of Noteholders by one or more persons holding or representing not less than one half of the principal amount of the Notes for the time being outstanding, provided that the Issuer's by-laws may in each case (to the extent permitted under applicable Italian law) provide for higher majorities. Any resolution duly passed at any such meeting by the Noteholders will be binding on all Noteholders, whether or not they are present at any meeting, and on all Couponholders.
- (b) Noteholders' Representative: a representative of the Noteholders (rappresentante comune) (the "Noteholders' Representative"), subject to applicable provisions of Italian law, may be appointed pursuant to Article 2417 of the Italian Civil Code in order to represent the Noteholders' interests under these Conditions and to give effect to resolutions passed at a meeting of the Noteholders. # **DESCRIPTION OF THE ISSUER**

# Introduction

### History and Development

Ferrovie dello Stato Italiane S.p.A. ("**FS**", "**FS Italiane**", or the "**Issuer**" and together with its subsidiaries, the "**Group**") is the holding company of the Italian railway group, which is active in the field of passenger and freight transport (mainly by rail) and related services. Among other things, FS controls the infrastructure manager Rete Ferroviaria Italiana S.p.A. ("**RFI**") as well as the railway undertaking Trenitalia S.p.A. ("**Trenitalia**"), which are subsidiaries of FS.

Pursuant to Law n. 137 of 22 April 1905 which entrusted the management and ownership of most railway services, once privatised, to the Italian State (the "**State**"), FS was established on 21 April 1905 through the nationalization of three private companies in operation in Italy since 1839. On 12 August 1992, FS became a joint-stock company which was wholly owned by the State via the Ministry of the Economy and Finance ("**MEF**"). In accordance with Article 4 of the Articles of Association currently in force (the "**Articles of Association**"), FS is incorporated, domiciled and operating under the laws of Italy (the Italian civil code and specific legislation in addition to the Articles of Association) for a period up to 31 December 2100 (which may be extended or decreased by a resolution passed at an extraordinary shareholders' meeting).

### Purpose of the Issuer

According to Article 3 of the Articles of Association, the objectives of FS include the:

- (a) construction and management of the infrastructure network for rail transportation;
- (b) operation of transport services, mainly by rail, of freight and passengers, including the promotion, implementation, and management of initiatives and services in the transportation field; and
- (c) performance of any other connected and instrumental activities related directly or indirectly to those mentioned above, including activities related to customer services and those aimed at the enhancement of assets for the operation of (a) and (b) above.

# Organisational Structure


EC Directive 91/440/EEC on the development of railways (subsequently amended by EC Directive 2001/12/EC of 26 February 2001) as implemented by law D.P.R. 8 July 1998 n. 277 and Legislative Decree 8 July 2003 n. 188 ("**Decree 188/2003**"), established the guidelines for the restructuring of the Italian national rail system. These EC Directives emphasised the need to separate rail infrastructure management from the provision of transport services. Following these legislative developments, the Group initiated a reorganisation program in 1998 by creating the infrastructure division. In May 1999, the Group set up three additional divisions to manage the medium and long-distance passenger transport, freight transport and local transport. The reorganization continued with the establishment in June 2000 of Trenitalia, a passenger and freight transport company, which was completed on 1 July 2001.

Since 2001, infrastructure maintenance (through RFI) and railway undertakings (through Trenitalia) have operated as separate companies within the Group.


- The transport services segment, which accounted for 68 per cent. of the Group's revenues for the year ended 31 December 2015 and for 66 per cent. of the Group's revenues for the year ended 31 December 2016, is divided into medium/long term distance passengers, regional passengers, and freight and is largely represented by the 100 per cent. owned subsidiary, Trenitalia.
- The infrastructure services segment, which accounted for 25 per cent. of the Group's revenues for the year ended 31 December 2015 and for 25 per cent. of the Group's revenues for the year ended 31 December 2016, manages the national rail network, both high speed and conventional lines, through the 100 per cent. owned subsidiary, RFI.
- The commercial activities relating to the real estate segment, which accounted for 4 per cent. of the Group's revenues for the year ended 31 December 2015 and for 7 per cent. of the Group's revenues for the year ended 31 December 2016, includes the companies (primarily, Grandi Stazioni Rail and Centostazioni) that deal with management and enhancement of the property assets of the Group.
- The other services segment, which accounted for 3 per cent. of the Group's revenues for the year ended 31 December 2015 and for 2 per cent. of the Group's revenues for the year ended 31 December 2016, manages other Group services including financial and administrative services.

### **Transport Services**

Within the macro-sector of transport services, the Group operates primarily through Trenitalia, one of its main subsidiaries.

Other Group subsidiaries active in the transport services sector are Netinera Deutschland, Busitalia-Sita Nord, TX Logistik, Mercitalia hub and FSE S.r.l..

**Trenitalia** (100 per cent. owned by FS) is the passenger transport company of the Group and consists of two business areas: passengers/medium and long distance routes (domestic and international) and passengers/local transport (commuter, regional and inter-regional).

Trenitalia signed a partial demerger deed on 21 December which provided for the allocation of a portion of its assets to Mercitalia Rail S.r.l. with effect as of 1 January 2017 via the demerger of its Cargo Division. This transaction is part of FS group's 2017-2026 business plan to relaunch the Cargo business

via a specific dedicated company structure. The shareholders had approved the demerger deed and they were informed of the transaction at their meeting held on 26 October.

In accordance with IFRS 5 "Non-current assets held for sale and discontinued operations", the revenue and costs of such division are recognised in the separate item "Loss from discontinued operations" in the income statement.

Figures as at 31 December 2016 reflect the application of IFRS 5. For the purposes of a better comparison, figures as at 31 December 2015 were restated accordingly.

In 2016, Trenitalia recorded positive results, reporting a net profit of Euro 116.82 million. Also for the previous year ended 31 December 2015, Trenitalia recorded a positive results, with a net profit of Euro 230.04 million.

Through the Long-Haul Passenger Division, Trenitalia provides mobility services for passengers at a national and international level. The services are divided into "market services", for which there is no contribution from public funds, and "universal services", which are only provided on the basis of a specific services contract with the State. In 2016 revenues from market services recorded a decrease of about Euro 62.7 million, due to the fall in revenue (Euro -58.1 million) from the Freccia trains (of which over Euro 30 million related to the lack of traffic generated by EXPO 2015 in 2015), in addition to the decrease in revenue (Euro -4.6 million) generated by the International and Charter trains. Revenues arising from universal services recorded a decrease of about Euro 23.9 million (-8.%) compared to the same period in the previous year.

**Netinera Deutschland GmbH** (in which FS has a 51 per cent. shareholding and Cube Infrastructure SCA Investment Fund has the remaining 49 per cent. shareholding) and its subsidiaries (the "**Netinera Group**") also operates in the Regional Passenger and Freight Transport segment of the Group, through a group of about 40 companies active in Germany. The Netinera Group is primarily involved in rail and road transport activities in the German local and metro transport markets, but it also carries out activities on international routes to the Czech Republic, Poland and the Netherlands. In addition to passenger and cargo transport service, the group performs services for the maintenance and renovation of vehicles.

During the course of 2016, the Netinera Group recorded revenues of Euro 603 million and expenses of Euro 525 million with Euro 78 million EBITDA and Euro 26 million EBIT. Taking into account amortization and depreciation of Euro 52 million and financial expenses of Euro 18 million to its partners, the Netinera group recorded profits of Euro 5.5 million.

**Mercitalia Logistics S.p.A.** (100 per cent. owned by FS), formerly named FS Logistica S.p.A., provides logistic services to several industries and clients both in Italy and abroad. It operates through a number of business units and owns logistic infrastructure in Italy. In 2016, Mercitalia Logistics recorded operating revenues of Euro 59 million, and for 2015, Mercitalia Logistics recorded operating revenues of Euro 54 million. Since 1 January 2017 it owns also Mercitalia Rail S.r.l., the company born from the demerger of Trenitalia's Cargo business unit as mentioned above.


Another important corporate entity which operates within the Regional Passenger Transport Operating Segment is Busitalia-Sita Nord S.r.l. ("**Busitalia**"), which operates in the sector of public road transport. The company carries out its business in various sectors, such as local public transport (both urban and suburban), long-distance bus service (both national and international), tourism and hires.

In 2016, Busitalia Group recorded operating revenues of Euro 354.4 million with Euro 36 million EBITDA and 13.1 million EBIT, principally derived from service contracts with Regions, Provinces and Cities as well as those from the additional service contracts with the region Tuscany.



The following graph shows the increase in Busitalia Group revenues in the last years (€million):




Fs Group key operating data in the transport segment:

#### Infrastructure Services

Within the macro-sector of Infrastructure Services, the Group operates through RFI, one of its main subsidiaries with the public role of Infrastructure Manager. It is responsible for the entire Italian national rail infrastructure including tracks that are 16,788 km long.

**RFI** – **Rete Ferroviaria Italiana S.p.A.** (100 per cent. owned by FS) is a joint stock company which performs the role of Infrastructure Manager in Italy, as assigned by a deed of concession (Concessione) granted by the Ministry of Infrastructure and Transport ("**MIT**") in October 2000 with a duration of 60 years (the "**Deed of Concession**") and on the basis of the *Contratto di Programma*, a program contract governing relations with the State. RFI is responsible for the design, construction, commissioning, management and maintenance of the railway infrastructure in Italy. It manages the control and safety systems connected with train operations, contracts with railway companies, and draws up the timetables for the rail network and promotes the integration of the Italian infrastructure within the European railway network. RFI is also operating in the ferry service between Sicily and Sardinia directly and through its subsidiaries. RFI is also in charge of the development of high-speed projects and is also active in investing in technology innovation and implementing new technology through internal programmes dealing with technology in safety, traffic management and efficiency and development; moreover RFI is also planning on expanding links between Northern Italy and other EU countries as well as adding more connections in Southern Italy, including Naples–Bari, Salerno–Reggio Calabria, and Palermo–Catania-Messina, these projects are under designing/construction.

In 2016, RFI had net profit equal to Euro 181 million (with an increase of 40 per cent. compared to 2015) and EBITDA of Euro 357 million (an increase of 28 per cent.). In 2016, the revenues from sales increased by Euro 96 million (an increase of 4 per cent), mainly due to the toll revenue (an increase of Euro 52 million) and the sale of electrical traction in accordance with Law no. 116/2014, which provided for the reformulation of the electrical toll system of Ferrovie dello Stato Italiane (Euro 41 million). Other income decreased by Euro 7 million (-2 per cent).

The revenues performance achieved was negatively affected by increasing of costs, mainly as a result of the increase in costs for services (+ Euro 12 million). Moreover, 2016 was affected by net reversal of the impairment losses (increased by Euro 12 million) mainly due to greater accruals to the allowance for impairment (Euro 5 million) and greater impairment losses on intangible assets and property, plant and equipment (Euro 7 million). Finally an increase to the fund for the pursuit of pro-active policies to support income and employment (+ Euro 11 million) was occurred.

**Italferr S.p.A.** (100 per cent. owned by FS) is the FS engineering firm and offers its services on the Italian and foreign markets in the field of transport engineering. It initiates and completes infrastructural and technological projects included in investment and upgrades plants for the railways.

In 2016, the company had a positive net result of Euro 8.1 million, with an increase in revenues from engineering services.

# Commercial Real Estate Activities

Within the macro-sector of Commercial Real Estate Activities, the Group operates mainly through Grandi Stazioni Rail formerly Grandi Stazioni S.p.A., after the demerger of latter's retail and real estate business unit, Centostazioni, and FS Sistemi Urbani; furthermore, the parent's real estate activities also contribute to the results of this segment.

The segment's performance and results for 2016 are clearly and absolutely affected by the impacts of FS' sale of 55% of GS Retail S.p.A. to third parties on 20 July 2016 (which generated a net gain of Euro 365 million included under other income), as part of the company restructuring plan that led to the demerger of Grandi Stazioni S.p.A..

On 28 June 2016 it was signed a partial, non-proportionate and asymmetrical demerger deed for Grandi Stazioni S.p.A., providing for the contribution of part of its assets to two newcos limited by shares, Grandi Stazioni Retail S.p.A. and Grandi Stazioni Immobiliare S.p.A.. The demerged company changed its name to Grandi Stazioni Rail S.p.A. and the demerger became effective on 1 July 2016. The demerged company Grandi Stazioni S.p.A., now Grandi Stazioni Rail S.p.A., wholly-owned by Ferrovie dello Stato Italiane S.p.A., kept assets and liabilities equal to equity of Euro 34 million. On 20 July 2016, Ferrovie dello Stato Italiane S.p.A. and Eurostazioni S.p.A. sold and transferred their entire investments in GS Retail S.p.A. and its subsidiary Grandi Stazioni Česká Republika Sro (61% held by GS Retail S.p.A.) to Alba Bidco S.p.A. for Euro 762 million.

**Centostazioni S.p.A.** (59.99% owned by FS and 40.01 per cent. by Archimede 1 S.p.A., since 30 January 2017 FS owns 100%) was incorporated to implement the programme for the upgrading, management and commercial enhancement of the 103 medium-sized stations (through a 40-year management contract with RFI) along similar lines to the model adopted by Grandi Stazioni. On 30 January 2017, FS Italiane S.p.A. regained full control of Centostazioni. The procedure to repurchase 40% of the shares held by Archimede 1 (Save Group) was with the transfer of the shares to FS Italiane S.p.A.. Its objective in regaining 100% of Centostazioni S.p.A. was to achieve unified management of the stations which, under the full control of FS Italiane group, will become intermodal hubs, providing useful related and new services as well as temporary offices for start-up incubators.

It is responsible for the management of the assets comprised in the real estate complexes of the network of 103 medium-sized railway stations owned by RFI spread across 20 Italian regions. Centostazioni is also committed to the upgrading and enhancement of the real estate assets it manages through the implementation of an investment plan agreed with RFI.

**FS Sistemi Urbani S.r.l.** (100 per cent. owned by FS Italiane) carries out activities relating to integrated urban services and the enhancement of assets which are not linked to the conduct of the railway business through the integrated management and the development of real estate services. The net results in 2016 for the company were positive, with a decrease of Euro 3 million. In 2016 FS Sistemi Urbani recorded operating revenues of Euro 14.5 million compared to Euro 52.1 million in 2015.

# Other Services

Other companies which make up the non-core services of the Group are Fercredit S.p.A. and Ferservizi S.p.A.

**Fercredit S.p.A.** (100 per cent. owned by FS) is responsible for the financial services of the Group. Its activities are essentially focused on the development of the credit factoring and leasing on the captive market and on the expansion of the consumer credit transactions for the employees of the Group itself. In 2016, the company recorded a net profit of Euro 10.4 million compared to Euro 11.9 million in 2015.

**Ferservizi S.p.A.** (100 per cent. owned by FS) is the Group's non-core services company, which constitutes the "Integrated Services Centre" of the FS Italiane Group, as it manages activities aimed at the following processes: Real Estate, Administration, Facility Management, Group Procurement. The

company recorded a net profit of Euro 19.4 million compared to Euro 24 million in 2015, with EBITDA - 15.7 million, to Euro 32.3 million and EBIT of Euro 31.6 million equal to -20per cent.

# **Corporate Bodies and Management**

The following table sets out the composition of the Board of Directors of the Issuer as of the date of this Base Prospectus. The shareholders' meeting on 27 November 2015, following the previous amendment of clause 10.1 of the Articles of Association which regulate the numbers of the members of the Board of Directors, appointed a Board of Directors comprising seven members for a period of three terms, which terminate on the date in which the financial statements for the last year of the director's third term is approved. According to clause 10.3 of the Articles of Association, the members of the Board of Directors may be re-elected.

#### **Conflict of Interest**

To the Issuer's knowledge, including on the basis of the FS' procedure concerning the "Related Party Transactions" (Administrative And Accounting Procedure - PAC/FS/11, 3<sup>rd</sup> December 2010), there are no existing potential conflicts of interest between the Board of Directors' or Board of Statutory Auditors' duties with respect to the Issuer and their private interests and/or duties.

### **Third Party Information**

The Issuer confirms that third party information contained in the Base Prospectus has been accurately reproduced. As far as the Issuer is aware and is able to ascertain from information published by a third party, no facts have been omitted that would render the reproduced information inaccurate or misleading.

### Capital

According to Article 5 of the Articles of Association, the share capital of FS as at the date of this Base Prospectus is Euro 36,340,432,802.00 consisting entirely of ordinary shares with a par value of Euro 1 each. All the shares in issue are fully subscribed and paid up. No preference shares have been issued and the Issuer does not hold treasury shares.

The share capital of FS can be increased by means of the contribution of cash or assets. Further to any increase in share capital, the new shares would need to be offered as options to the shareholders in proportion to the shares actually owned; those who exercise the option will have the right to purchase the shares.

#### **Corporate Governance**

The Issuer complies in all material respects with the Italian corporate governance regime applicable to it pursuant to its Articles of Association and Italian legislation. The corporate governance process is based on the provisions and communications issued by FS' Board of Directors. FS is administered by a Board of Directors consisting of seven members (the Chairman, five non-executive directors and a Managing Director) appointed by the Shareholders' Meeting.

### **Relevant Committees**

FS established two committees comprised of members of the Board of Directors of FS: the *Comitato Audit, Controllo rischi e Governance* and the *Comitato per la Remunerazione e le Nomine*.

The main task of the *Comitato Audit, Controllo Rischi e Governance* is to support, through preparatory work, proposals and opinions:

- the evaluations of the Board of Directors concerning the internal control system and risk management, as well as the requirements for the approval of periodic financial reports;
- the evaluations concerning the size/composition of the Board of Directors and the corporate governance of the FS Group, as well as the corporate social responsibility.

The main task of the *Comitato per la Remunerazione e le Nomine*, is to advise and make proposals to the Board of Directors regarding, among other things, the remuneration of the CEO and the Chairman (if the latter has operating powers), the definition of criteria for the designation of FS' key management personnel and members of Group's corporate bodies, the eventual co-option of FS' Directors as well as the

periodic review of the requirements of independence and integrity and the absence of any reasons for incompatibility or ineligibility of the Directors of FS.

Furthermore, FS has established 9 corporate committees, the main tasks of which are described as follows:

- The main task of the **Ethical Committee** is to promote the integration of ethical principles within corporate processes, to verify the compliance of the behaviour of the Board of Directors and employees to the standards of conduct and to revise business procedures in light of the Code of Ethics adopted by FS. Meetings of the Committee take place quarterly and its members are appointed by the Board of Directors.
- The main task of the **Committee for Equal Opportunities** is to promote initiatives and actions to offer female workers more favourable working conditions and greater development opportunities. Meetings of the Committee take place every two months and consist of one female representative from each trade union organization which signs the *CCNL Mobilità/AreaAF* and a corresponding number of female members designated by the Group.
- The main task of the **Antitrust Committee** is to promote, through the development of guidelines, the dissemination of knowledge regarding antitrust regulations and monitor their correct application. Meetings of the Committee take place quarterly and its members are appointed by the CEO. The CEO, with broad executive powers, is appointed by the Board of Directors.
- The main task of the **Investment Committee** is to provide guidelines on investment and disinvestment plans, assess the soundness (strategic, economic and financial) of strategic initiatives, monitor business plan execution and propose corrective actions. Meetings of the Committee take place upon the initiative of the Strategies and Planning Department. The Investment Committee members are appointed by the CEO.
- The group's **Information and IT System Security Committee**, established with group measure no. 168/AD of 25 November 2013, is an intragroup advisory body that monitors information and IT system initiatives, in accordance with group measure no. 167/AD of 25 November 2013. In particular, the committee steers FS Italiane group's information security strategies, formulates proposals to group companies for the mapping of critical business processes in terms of emerging risks inherent to the use and management of information resources, monitors IT projects and assesses and approves proposals concerning the regulation of information and IT system security evaluations and certification.
- The **SoD** (Segregation of Duties) Committee, which was established with group measure no. 184/AD of 22 December 2014 and was updated with group measure no. 188/AD of 23 January 2015, carries out advisory activities and provides guidance on the segregation of duties. FS' SoD Committee is responsible for defining, validating and overseeing the group's SoD risk matrix. In addition, this committee is responsible for analysing and monitoring the implementation of the appropriate remediation actions to take in the management/resolution of SoD risks that are detected throughout many group companies' staff processes.
- The **Foreign Development Committee** was set up with group measure no. 206/AD of 5 May 2016 for the strategic oversight of development initiatives in the group's interests abroad.
- The **Credit Committee**, set up with group measure no. 210/AD of 23 June 2016, is responsible for monitoring the performance of group receivables, highlighting any critical areas and promoting the necessary corrective action, while also assessing consolidated exposure to each counterparty and any possibility of offsetting amounts.
- The **Sustainability Committee** was set up with group measure no. 211/AD of 1 July 2016 to ensure the integration of social and environmental aspects in the group's economic/financial strategies and promote the values and principles of sustainable development, in accordance with stakeholders' requirements and expectations.

# Internal Audit Department

FS' management system is divided into twelve departments which report directly to the Chairman or to the CEO. The main group companies have internal audit departments reporting to the Chairman of their BoD. For companies that do not have (or do not yet have) their own internal audit departments, the parent's Central Audit Department provides this service.

If an Audit Committee has been set up, the internal audit department reports to it as well, as defined by the relevant company's internal procedures.

Internal auditing at group level is independent and objective, provides assurance and serves an advisory purpose, to improve the organisation's efficiency and effectiveness. It also helps the organisation to pursue its targets through a professional and systematic audit approach, which generates added value as it is aimed at assessing and improving control, risk management and corporate governance processes.

For the analysed processes, the group's internal audit departments assess the adequacy of the internal control system (ICS), with respect to the following:

- effective, efficient operations;
- protecting company assets;
- compliance with laws, regulations (both inside and outside the company) and contracts.

The Central Internal Audit Department defines the group's audit guidelines and methodologies, which also helps better manage internal audit personnel.

# Law 262/2005

Since 2007, upon the request of the Ministry of the Economy and Finance and in order to adopt corporate governance systems that are increasingly in line with those of listed companies, the parent created the position of manager in charge of financial reporting pursuant to Law no. 262 of 28 December 2005 "*Provisions to protect asset management and regulate financial markets*" for companies listed on financial markets.

Following the issue of the aforementioned bond (July 2013), FS' status became that of a public interest entity pursuant to article 16 of Legislative decree no. 39/2010 because it had issued bonds. Accordingly, the position of manager in charge of financial reporting is now legally required as the company now completely falls within the scope of application of article 154-bis of the Consolidated finance act.

The Regulation of the Manager in charge of financial reporting approved by the board of directors on 28 July 2015 governs the role, functions, powers, means and responsibilities of FS' manager in charge of financial reporting and this manager's relationships with the company officers, the control and supervisory bodies, the various company departments and group companies.

Considering FS Italiane group's organisational and operational complexity, to strengthen and improve efficiency in the application of this legislation, FS' BoD has deemed it appropriate, from the start, to have its main subsidiaries immediately appoint managers in charge of financial reporting as well (RFI S.p.A., Trenitalia S.p.A., Centostazioni S.p.A., FS Logistica S.p.A. (now Mercitalia Logistics S.p.A.), Busitalia-Sita Nord S.r.l. and Ferservizi S.p.A.).

On 4 July 2016, the shareholder resolved to amend article 16 of the by-laws to implement the legislative requirements for managers in charge of financial reporting (article 154-bis of the Consolidated finance act) which – as noted earlier – applies to FS following the issue of listed bonds.

Since the position was created and filled, FS' current manager in charge of financial reporting has been the Director of the parent's Central Administration, Financial Statements and Tax Department, appointed by the BoD on 1 December 2015 upon the CEO's proposal and with the approval of the board of statutory auditors. He will remain in office until the approval of the financial statements as at and for the year ending 31 December 2017.

# Law 231/2001

Legislative Decree n. 231 of 8 June 2001 ("Law 231/2001") "Regulation of the administrative responsibility of the legal persons, companies and associations even without legal personality under Article. 11 of September 29th 2000, no. 300" introduced into Italian law the principle of corporate criminal responsibility, i.e., criminal responsibility imposed on an entity, as well as on a natural person.

The expansion of such responsibility allows both the property of the entities themselves as well as the economic interests of the shareholders to be considered in formulating the penalty of certain criminal offences committed by the company's directors or employees.

Group measure no. 209/P of 9 June 2016, which replaced the previous measures concerning the control model since 2002, requires FS Italiane group companies to adopt an organisational, management and control model to prevent the illegal conduct covered by Legislative decree no. 231/2001 and establish a supervisory body responsible for monitoring that the models are functional and compliant and propose updates to them.

Supervisory bodies are normally set up as boards with a chairman from outside the company with important, specific expertise in this respect, an internal audit manager and a legal expert from outside the group or, alternatively, a member of the board of statutory auditors.

To ensure the bodies' independence, their members may not hold similar positions with subsidiaries or parents nor have interests in or carry out material transactions with the company, subsidiaries or parents.

FS' Supervisory Body consists of two external members, one of whom acts as Chairman, and one internal member, i.e., the Director of FS' Central Internal Audit Department.

# Code of Ethics

The Code of Ethics adopted by FS clearly sets out the responsibilities, ethical and social commitments that FS has with regard to the stakeholders, and outlines the rules underlying any action taken by the Group. It is approved by the Board of Directors and applies to the corporate bodies, management, employees, external consultants, commercial partners, suppliers and other stakeholders of the Group.

# Sustainability and Environment

FS Italiane group has translated its long-term vision into the new 2017-2026 business plan, with which it has renewed and intensified its ambition of creating transport works and services that create long-lasting value for the community by redefining the business through intermodal transport.

It has made three separate, yet interconnected, commitments to achieve this general vision; one commitment for each aspect of sustainability: economic, social and environmental.

This expression of intent constitutes the shared foundation of values and beliefs that transversally guide FS Italiane group's decisions and operations.

FS Italiane group's code of conduct establishes the rights and responsibilities of corporate officers, managers, employees, freelancers, business partners, suppliers and all other parties involved in transactions with FS Italiane group. With the code of conduct, FS Italiane group transparently assumes its responsibilities and commitments to internal and external stakeholders.

FS Italiane group is also a member of the UIC, which promotes the railway sector around the world as a solution to the challenges of mobility and sustainable development. The group signed the "*UIC declaration on Sustainable Mobility and Transport*", formalising its commitment to responsible practices in terms of human rights, labour conditions, the environment and anti-corruption, in line with the ten principles of the UN Global Compact. FS Italiane group also aims to help achieve the 17 sustainable development goals, in the context of the 2030 Agenda, the United Nations' strategic framework for common, solid development, and the following, in particular.

The group's approach to sustainability is reflected in its commitments to all group stakeholders, which are explicitly stated in company policies and the code of conduct.

Since 2010, the parent has formalised its active role in promoting, directing and coordinating consistent management of environmental issues by maintaining a governance model for the group companies' environmental management systems. The level of maturity that this model has reached has led to further progress, and in 2016, a process began that will result in the transformation of the current environmental management system governance model into a business model that balances the economic, social and environmental components of group operations.

In 2016, FS established a Sustainability Committee, an advisory board made up of senior managers from the main group companies, formed to integrate social and environmental aspects in economic-financial strategies, promote the values and principles of sustainable development and meet stakeholders' needs and expectations.

In view of integrating strategies with sustainability aspects, using the corporate shared value approach, the group is kicking off pilot projects to create a methodology that incorporates multi-dimensional assessments of activities.

The Ferrovie dello Stato Italiane group continuously dialogues with its stakeholders, as it firmly believes that understanding their expectations and identifying medium and long-term objectives with them guarantee the effective creation of value.

With this in mind, FS Italiane group has several ways of interacting with its stakeholders. For example, it organises a panel in which stakeholders propose improvements for the company. The group undertakes to respond to all of their requests and, where appropriate, tangibly implement them.

Over 100 stakeholders from the different stakeholder categories participated in the panels held from 2013 to 2015, actively discussing various issues. A total of 65 proposals were gathered and, of these, 42 were implemented, 16 are being implemented and seven are not feasible.

For years, FS Italiane group has been involved in initiatives and projects for land redevelopment, disabilities and social distress in railway areas. In particular, in recent years, the group has intensified its commitment to solidarity, with the consolidation of a network, which now extends to Europe, of relationships with institutions, local bodies and associations.

The Help Centres are the first major solidarity project launched by FS Italiane group, in collaboration with local authorities and NGOs, to combat the social problems encountered in Italian train stations.

Different projects in each country are discussed continuously within the context of the *Gare Européenne et Solidarité*, a European charter for the development of social initiatives in stations signed in Rome in 2008 through the joint efforts of railway companies on the basis of their experience with social distress.

Finally, in June, the European *Train in Station* project was concluded in Paris. It involved the collaboration of Italian, French, Luxembourg and Bulgarian railways on a railway worker training project concerning migration issues and assistance to the homeless, potential help centre beneficiaries.

Through major non-profit associations, many welcome centres have been set up in idle railways spaces.

FS Italiane group is completing a pilot SROI (social return on investment) analysis project to estimate the direct and indirect social and economic impacts of the help centre project and welcome centres in Rome and Milan. The analysis covers the three years from 2014 to 2016 and involves all help centres operating at 31 December 2016 and the welcome centres in Milan (Progetto Arca) ad Rome (Caritas). The objective of the analysis is to measure the welfare value generated for the community through FS Italiane group commitment to improving social conditions.

FS Italiane group continuously monitors its environmental impacts with the aim of minimising and mitigating negative impacts, while taking the necessary steps to develop the environmental advantages of mass transport and making the most of local resources.

The group's activities span a wide range of diversified operating segments that characterise its business and that have been assigned different impact levels with respect to the main environmental aspects. The reporting scope includes the core activities of the most material companies in aggregate environmental terms for the sector. The transport segment's use of primary energy is composed of: 91.2% for railway traction, 4.0% for public road service traction, 2.3% for heating and 2.5% for other purposes.

The transport segment's use of electrical energy is composed of: 97.5% for railway traction and 2.5% for electrical services.

The transport segment's use of diesel is composed of: 68.4% for railway traction, 22.7% for public road service traction and 8.9% for other purposes.

The transport segment's use of natural gas is composed of: 68.7% for heating and 31.3% for public road service traction.

The transport segment's  $CO_2$  emissions are composed of: 90.5% from railway traction, 5.1% from public road service traction, 2.5% from heating and 1.9% from other activities.

The transport segment, which is significantly affected by railway operations, makes up the largest share of the group's energy consumption by far, accounting for 89% of primary energy.

However, an analysis of each source individually shows that transport activities account for approximately 90% of electrical consumption, nearly all of which for railway traction, while the remaining electrical energy was used for the infrastructure (lighting in the stations, railway yards, etc.).

The observations on the use of diesel differ because, while diesel consumption is concentrated on transport services as well, the various activities contribute differently: while railway transport accounts for a significant share of the consumption (nearly two-thirds of the total) road transport (for the passenger service), are a substantial part of the total value.

On the other hand, the segments use natural gas mainly for a different reason: the real estate services, infrastructure and transport segments mainly use natural gas to heat stations, workshops, offices and buildings.

To offset the consumption described above, FS Italiane group monitors and analyses the quantities of greenhouse gases that its operations emit each year. Its direct and indirect emissions make up roughly 0.5% of total emissions in Italy each year. The amount of climate-changing gases emitted by the group in 2016 came to an estimated 2.2 million tonnes, nearly the same as in the previous year. Similarly to its use of primary energy, nearly 90% of emissions were due to the different types of transport operations, with most due to railway transport and a residual amount of emissions due to infrastructure management.

Water use is another critical aspect of environmental performance for FS Italiane group. Most water is used for non-industrial purposes (offices, toilets, showers, drinking water at stations, etc.) and the group companies periodically run awareness campaigns for the responsible use of water. Furthermore, the group has activated various systems to rationalise the use of water for industrial purposes, both for appropriate water collection and effective treatment at the end of its use in the production cycle.

The group's focus on the use of materials also extends to disposal. Within the group, infrastructure and rolling stock maintenance activities are those that generate the most waste, which can be duly sent to treatment centres for recycling (e.g., iron for the infrastructure).

Initiatives are being carried out to increase the sorting of waste produced in the group's public areas, like stations. The percentage of waste that is sorted could be improved through new systems for its collection and more effective awareness campaigns.

FS Italiane group and the main group companies remain committed to implementing and certifying their environmental management systems or integrated management systems, covering all processes and all operating sites, with the goal of continuing to improve the group's environmental services.

In 2016, the group companies launched a transition process to adopt the new UNI EN ISO 14001:2015 standard. Unlike its previous version, the new standard promotes deeply rooting the management system in the business, extending its improvement strategies as part of a broader vision of environmental sustainability. In this context, the parent, which oversees environmental aspects based on the environmental management system governance model in a coordinated, consistent manner, has

undertaken a process to incorporate the main sustainability principles within the business, in order to generate value for both the group and the community.

# Employees

The number of group employees rose from 69,002 at 31 December 2015 to 70,180 at the end of 2016. This increase of 1,178 in the headcount was mainly due to the new employees who arrived as part of the non-recurring transactions of the year which led to the inclusion of new legal entities within the group (such as FSE S.r.l. with 1,179 employees). However, the net change in the average number of employees of the year, resulting from incoming and outgoing employees, was a decrease of 220.

# Personnel management and development policies

In 2016, the group confirmed and consolidated its commitment to manage and develop human resources.

Pending the agreements necessary for the Bilateral fund for income assistance until workers take their pension, targeted turnover was ensured in 2016 by hiring personnel for the railway operation segments, while the market hiring of graduates and highly experienced personnel was limited by in-house job postings.

Furthermore, the group continued to promote personnel recruitment and development policies to make the most of their professional skills, expertise and motivation as fundamental factors as it faces challenges on

an extremely competitive market and laying the basis for the new 2017-2026 business plan. Development initiatives have included training and coaching in house, as well as continuing the "map of competences", with the goal of enabling group resources to gain more personal awareness of the abilities and value that they can share with the group, by analysing personal and professional expertise. Moreover, the group continued pursuing development plans for group resources, to support their careers with development levers such as training, coaching and/or mentoring and participation in ad hoc projects.

The group companies have developed active in-house job posting and intragroup mobility policies, to strengthen and develop the professional skills in FS Italiane group, fostering a greater sense of belonging among resources. In addition, a new integrated information system was launched for each company to use for in-house personnel recruitment, as part of a process to share a new corporate culture to make the most of the group's people. Through in-house intragroup job postings alone, 21 positions have been covered.

Recruitment on the market outside the group, which encompasses international candidates to meet the group's development needs on foreign markets, has focused on top quality graduates, not only in engineering, but also in business and law specialised experts needed for the core business. To face the sharp increase in volumes, new digital tools were introduced for pre-screening and assessments -(cognitive tests, video interviews and online on-baskets) – which have brought excellent candidates to the classroom, considerably increasing the number of candidates in line with their role at the end of the recruitment process. There are over 440,000 curriculum vitae in the database, including more than 48,000 that were received in response to published advertisements, and they led to the identification of 179 recent graduates as attractive candidates. Of these, 105 were found through intense, ongoing collaboration with universities, in which the group came into contact with over 8,000 young potential candidates in the year, and a variety of activities like level 2 master's programmes, business games, orientation seminars, company presentations at major universities, specialised workshops as part of university courses, internships, research grants, university theses and online and social recruitment. In addition, 68 expert positions and 15 managerial positions were covered. Each month, the online "Work with us" function counts an average of 150,000 visitors and sees its number of followers on Linkedin double. These are initiatives that, through continuous, fruitful contact with young people, have boosted FS Italiane group's image significantly in terms of employer branding and making it recent graduates' Best Employer of Choice among the Italian and international companies for the second year in a row (and again for the third consecutive year at the start of 2017). Substantial focus was also devoted to high school students, with orientation, training and school/work projects, further expanding the network with the involvement of more than 4,500 third, fourth and fifth-year students. The aim is to "cultivate" their skills, equip them with competencies and create a field of excellence to meet future operating needs.

# Industrial relations

On 28 July 2016, the fund's founders, FS Italiane group and the trade unions (which negotiate the national labour agreement for the mobility sector/railway sector and FS Italiane group's employment contract), signed an agreement to integrate and amend the agreement establishing the bilateral fund for income assistance benefiting the group companies' employees, implemented as the fund regulation with Interministerial decree no. 86894 of 9 January 2015, amended to reflect the provisions of Legislative decree no. 148/2015 (the "Job Act"). Moreover, this agreement enabled the group to expand the fund benefits to include pension incentives in order to encourage generational change, making it possible to use the financial resources previously accrued to the Fund until their complete depletion (€125 million). This will encourage approximately 1,000 people to leave employment starting from 2017 and be replaced by the same number of new employees in the railway segments requiring employee turnover to bring in professionals capable of working with new technologies and filling specialist positions (i.e., university and high school graduates) to more rapidly advance the group's transformation and development. At the same time, the parties signed a procedural agreement, whereby they agreed the trade union procedures, criteria and methods of access to the extraordinary fund benefits (pension incentives) pursuant to Interministerial decree no. 86894/2015. This agreement completes the necessary process to enable group employees to resume offering pension incentives to employees in operating segments/operations where the updating of processes, reorganisation of the business and technological innovation generate redundancies, using the fund as a welfare benefit for companies that are not eligible for traditional government welfare benefits. In this respect, another agreement was also signed on 28 July 2016, identifying at least 420 potential recipients of the extraordinary fund benefits, including those not qualified for safety operations and staff and support personnel. At company level, the incentives have begun being offered to employees so they may receive the extraordinary fund benefits in the second half of 2017.

Proposed agreements were signed on 16 December 2016 to renew the national labour agreement for the mobility sector/railway sector and FS Italiane group's employment contract, both of which expired on 31 December 2014. The proposed agreements were definitively validated on 17 January 2017 with the workers' referendum sponsored by the signatory trade unions, which passed with over 84% of the votes.

The two new contracts have:

- aligned their expiration (31 December 2017) with that of the bus/rail/train workers contract signed on 28 November 2015, with the commitment of the parties, reported in the introductions of the two national labour agreements (that for the mobility/railway sector and that for the bus/rail/train workers), to begin the process to unify the contracts within the first half of 2017. This is particularly important given the current stage of FS Italiane group development, as it takes its role on the market as an integrated mobility operator;
- updated labour regulations to the new laws introduced in recent years for the protection of labour conditions (voluntary transfer of holiday leave, civil partnership leave, leave for women who are victims of violence, parental leave and leave for employees who assist disabled family members);
- reinforced the group's internal welfare system, which already includes various benefits (supplementary pension plan, integrative healthcare plan, travel vouchers, leisure activities for railway workers, additional maternity and paternity protections, additional guarantees for serious illnesses), introducing benefits for a work/life balance (time to raise and educate one's children and care for elderly or disabled family members), expanding the supplementary pension plan to cover all workers and not only those who volunteer to participate, offering more coverage with integrative healthcare assistance which will also include income protection for any workers who may no longer work in safety operations for organisational reasons or due to serious illnesses;
- integrated the previously-applicable regulations concerning contracting and changes in contracts, introducing new requirements to improve relationships between customers and contractors, ensuring good labour conditions and better service quality. For the same purposes, on 16 December 2016, the parties signed an agreement regarding the hourly cost of employees working in services and operations complementary to the transport services to be considered for subsequent calls for tender. This agreement was forwarded to the Ministry of Labour and Social Policies to meet the requirements of article 23.16 of Legislative decree no. 50/2016 (Contract Code);
- introduced regulatory flexibility on work hours and the use of personnel, especially in the cargo transport segment, necessary to help strengthen and develop the new cargo and logistics hub run by Mercitalia Logistics S.p.A. (formerly FS Logistica S.p.A.). To this end, on 16 December 2016, a specific agreement was signed that, once the transfer of the business unit pursuant to article 2112 of the Italian Civil Code was complete, made the seamless transfer of personnel from Trenitalia S.p.A.'s former Cargo Division to Mercitalia Rail S.p.A. on 1 January 2017 possible; and
- offered personnel a raise above the contractual minimum that, considering the overall positive performance of group companies in the year, was in any case within acceptable limits and equal to a conventional ⊕8 (corresponding with an average of €102), disbursed in three tranches on 1 November 2016, 1 July 2017 and 1 December 2017, and a one-off payment averaging a gross total of €600 to cover contractual holiday time from 1 January 2015 to 31 October 2016.

Furthermore, when the two contracts were signed, another two specific agreements were signed on 16 December 2016:

- the first agreement entails the payment of a one-off benefit to cover performance bonuses for 2013, 2014 and 2015, for a gross average payment of €600 per head; and
- the second agreement defines the 2016 performance bonus indexed to productivity and profitability indicators and to specific improvement targets for such indicators, which will be calculated on the basis of the 2016 financial statements, after which, the benefits, including overperformance, if the established targets are reached and overperformed, are paid in June 2017.

The 2016 performance bonus agreement meets all the requirements of the new legislation in force for its non-taxability and also introduces the legal option of allocating a portion of the bonus (40%) to the


welfare benefits provided for by FS Italiane group's employment contract. It therefore lays the basis for the annual structural definition of measurable productivity/profitability/quality performance targets, motivating workers to strive to achieve them.

# Capital Expenditure

In 2016, the capital expenditure of FS amounted to Euro 5,950 million ( $\textcircled$ ,649 million of which selffinanced and  $\textcircled$ ,301 million through government grants mainly earmarked to infrastructure) compared to Euro 5,497 million in 2015, with a significant growth of 8.2 per cent. The majority of the capital expenditure related to the maintenance and development of rail infrastructure. The breakdown of the 2016 capital expenditures is as follows: 67 per cent. in respect of RFI's investment in the traditional network, which included the implementation of projects aimed at raising safety levels and improving efficiency of railway traffic as well as the construction of large development projects; 3 per cent invested by RFI in the high speed network; 26 per cent. invested by Trenitalia ( $\sim \textcircled{el}$ ,5bn) up by 9% on the previous year and 63% of them to purchase new **rolling stock both** for long haul and regional passenger transport:

- ► €614 million was earmarked to additional "Frecciarossa 1000"
- $\triangleright$  €455 million went to the **new regional fleet**

Approximately 4 per cent. of capex related to other technical investments and other capital expenditures.

2016 ended with a profit of 772 million, showing a significant increase (+66.4%) on the previous year, when the group posted a profit of 464 million.

The increase is mainly due to the asset enhancement activities completed by management in 2016 as part of the group's broader vision as it is poised, as detailed below, to become an integrated mobility operator following the decision in September, when FS' board of directors approved the new 2017-2026 business plan. This includes the above-mentioned sale of the business related to the management of non-core commercial premises through the sale of Grandi Stazioni Retail S.p.A. to third parties, which generated a gain of €365 million in the year. Furthermore, at the end of 2015, a similar transaction was successfully completed, entailing the sale of the electrical energy grid to Terna S.p.A., generating a gain of €18 million.

Consequently, the main top line operating indicators, gross operating profit and operating profit, also grew significantly, up by 318 million (+16.1%) and 2248 million (+38.5%), respectively.

The effects of the changes in legislation in 2016 had a less significant impact on the results for the year than in 2015. In this respect, the legislative measure of 22 January 2016 (the Eco bonus) provided additional support to cargo transport by reducing the toll by 2.5/train-km, thereby re-establishing a more sustainable framework for the sector, compared to the extremely negative impact caused in the past by the earlier reduction in the cargo service contract. Conversely, 2016 was affected by greater charges related to the rise in the costs incurred for electrical energy used for traction (up by 33 million), caused by the simultaneous enactment of a series of legal and regulatory provisions (specifically, Resolutions nos. 654 and 668/2015) issued at the end of 2015 by the Electrical Energy, Gas and Water Regulator ("AEEGSI").

Revenue increased by 343 million as a result of the rise in revenue from sales and services (+27 million) and other income (+316 million).

The increase (+0.3%) in revenue from sales and services is due to the revenue from transport services which grew by  $\notin 2$  million, and the rise in revenue from infrastructure services (+ $\notin 26$  million). Conversely, the other residual items making up revenue from sales and services are slightly down by  $\notin 1$  million.

With respect to the main factors behind the increase in revenue from transport services (+C million), a positive contribution came from the short haul passenger transport service revenue (+C19 million), broken down into domestic rail revenue (+C76 million), international rail revenue (+C24 million, mainly earned by Netinera group operating in Germany) and road transport revenue (+C19 million). Conversely, the long haul rail segment contributed negatively. Indeed, during the year, despite the increase in the volume of the HS (high speed) service generated by the Frecciarossa brand, its revenue in Italy and abroad decreased by O9 million, mainly as a consequence of the lower average market yield, in addition to the absence of the positive effects of Expo 2015 generated in 2015. The cargo service decreased by C18 million.

For additional information on the trend in revenue from transport services, reference should be made to the section on the Transport segment.

The increase in revenue from infrastructure services, up by C6 million on 2015, mainly consists of the C20 million increase in toll revenue due to the rise in production volumes and the greater contributions for service contracts related to the entry of FSE S.r.l. into the consolidation scope (+ $\oiint{C}5$  million). Revenue from the government for grants related to income paid to RFI S.p.A. pursuant to the 2016 Stability Act are unchanged on the previous year ( $\oiint{C}76$  million).

Other revenue, included in revenue from sales and services, dropped slightly by  $\in I$  million (a total of - 0.4%), mainly as a consequence of trends in operations.

Other income rose by €316 million, mainly as a result of the above-mentioned €365 million gain from the sale of Grandi Stazione Retail S.p.A.'s assets to third parties, compared to the €18 million received in

2015 from the sale of the electrical assets to Terna S.p.A.. Furthermore, there was a decrease in revenue from leases, recharges of condominium expenses and the sale of advertising spaces, amounting to  $\pounds 28$  million, following the sale of the retail business unit, in addition to lower sales of land and buildings held for trading during the year (- $\pounds 1$  million).

Operating costs amount to 6,635 million, up by 25 million (+0.4%) on 2015 (6,610 million). They may be analysed as follows:

- the rise in personnel expense (+€17 million) mainly due to the increase in permanent employees provided for by the new national labour agreement for the mobility sector/railway sector which took full effect. However, the increase is almost fully absorbed by the streamlining of work, the reduction in average workforce, the social security contribution tax benefits related to production bonuses and lower costs for leaving incentives. The costs for the Netinera Deutschland group increased due to the personnel hired following the acquisition of new routes (+⊕ million) as well as those related to FSE S.r.l.'s entry into the consolidation scope (+€ million);
- the rise in other costs, net (+ I million), mainly as a consequence of the following changes:
  - i) the increase in raw materials, consumables, supplies and goods (+€71 million). The consumption of materials rose by €86 million following the investments in infrastructure; the cost of electrical energy grew by €33 million due to the above-mentioned new regulatory provisions, offset, in part, by smaller costs for fuel for traction (-€7 million) and other general savings (-€1 million); smaller change in buildings and land held for trading due to the reduction in selling costs (-€5 million) and smaller impairment losses compared to 2015 (-€25 million);
  - ii) services rose by €35 million following the net effect of the increase in transport services (+€42 million), offset by savings totalling €7 million, specifically in relation to maintenance. The above increases in services are essentially attributable to Netinera Deutschland group following the acquisition of new routes during the year;
  - iii) other operating costs rose by €34 million following the increase in membership fees and contributions to sundry bodies, penalties received and compensation, non-deductible VAT and other taxes, and the larger accruals of the years, specifically in respect of sundry taxes on areas zoned for building;
  - iv) greater capitalisations (+€134 million), basically due to the increase in investments in infrastructure, specifically the technological upgrades and the safety renewal, as well as greater value-increasing maintenance of rolling stock.

Gross operating profit increased by 318 million or 16.1% to 2,293 million as a result of the variations in revenue and operating costs described above.

Operating profit amounts to 892 million, up by 248 million or 38.5% on the previous year. The increase is mainly due to that described above in respect of revenue and operating costs, as well as greater amortisation/depreciation and impairment losses (+78 million and +15 million, respectively), offset by smaller provisions (-23 million). Provisions of 25 million (48 million in 2015) include the accruals recognised by the FS Italiane group companies for the extraordinary portion of the Bilateral fund for income assistance.

Net financial expense of ⊕4 million improved on 2015 by €13 million. The improvement is substantially due to significant non-recurring items which affected both income and expense. Specifically:

- the absence of financial income, unlike in 2015, from the derecognition of the financial liability related to the equity investment in Eurofima SA (€75 million);
- greater financial income for the year (+€14 million) generated by the settlement agreement between Mercitalia Logistics S.p.A. and the Campania waste emergency government commissioner as detailed in the notes to the consolidated financial statements to which reference should be made;
- other changes related to the decrease in borrowing costs and exchange rate losses of €49 million.

Income taxes amount to €26 million, down by €47 million (-64.4%).

In addition to the above observations, the following table shows the directly generated economic value and that distributed by FS group, highlighting its redistribution to stakeholders. The group acknowledges the importance of a balanced distribution of the value generated by its operations to its stakeholders, value that they contributed to creating directly or indirectly. The analysis of the economic value distributed shows the flows allocated to employees, providers of goods, services and capital, the public administration and the communities in which the group is present.

# Strategy of the Group

On 13 September 2016, the Board of Directors of FS approved the 2017-2026 business plan of FS Italiane group.

The new business plan covers a ten-year period to adequately follow up large infrastructural projects in progress, make appropriate use of FS Italiane group's long-standing experience in the transport sector and contextualise the industrial developments of the group companies amidst the rapidly evolving market and socio-economic environment.

The 2017-2026 business plan makes FS Italiane group the gate to accessing the mobility ecosystem, with a view to integration and coopetition, bringing together all the collective transport players and modes. Moreover, all this is possible thanks to the centrality of the railway system and the unique know how that FS Italiane group has developed in its 111 years of history.

The 2017-2026 business plan is based on five strategic pillars:

### Modal integration

The group's goal is to expand its collective mobility services, putting Italy at the avant-garde of sustainable transport by offering a range of services tailored to different mobility needs and giving customers an increasingly collective door-to-door travel experience.

# **Integrated logistics**

As in passenger transport, road transport is the prevalent model of transport for integrated logistics as well. The group's objective is to contribute to a modal rebalance through the following main actions:

- 1. a turnaround to be achieved with the group's new logistics hub (Mercitalia) with a specific focus on taking a customer-centric approach, improving service quality and maximising efficiency;
- 2. reinforcement of intermodality;
- 3. expansion in high added value service segments (such as cargo forwarding).

### **Integrated infrastructure**

In this area, the group has budgeted large investments to create increasingly modern infrastructures offering faster, systemic mobility for passengers and cargo: the Giovi third railway crossing, the Brenner base tunnel and the Turin-Lyon line to complete the Italian side of the four TEN-T corridors crossing the country and connecting it to the European regions that are the most densely populated and most important for industry and production; infrastructural and technological improvements in urban hubs in major cities to increase traffic capacity; in the south, the opening of sites for the HS/HC Naples – Bari line and, in Sicily, the Palermo – Catania – Messina line. Speeds were ramped up on the Adriatic coast and Salerno – Reggio Calabria lines following technological upgrades and improvements in the railway route.

Transport optimisation has also been achieved by integrating RFI S.p.A.'s national network with the contribution of former railways to increase efficiency by bringing the national railway network under the same manager and new routes to shorten travel times and improve safety, meeting RFI S.p.A.'s highest technological standards.

The potential transaction with ANAS also falls within the scope of integrated infrastructures. This transaction, if it is confirmed and carried out, will make it possible to implement an integrated policy of

infrastructural investments, to generate major industrial synergies and to manage, as an integrated player, long-term technological development, which will see roadway infrastructures increasingly equipped with technologies that are already used in the railway network (i.e. electrified highways).

Stations complete the framework, as they are the nerve centres between infrastructures and transport services, destined to become genuine mobility hubs with car parks, car rentals, car sharing, bike sharing, electric car recharging stations, etc., as well as spaces offering a wide range of services making the stations places where day-to-day activities may be carried out, like picking up a parcel or paying a utility bill, transforming any waiting times into time well spent. In this respect, the 2017-2026 business plan provides for the creation of a network of smart stations, managed as one network and poised to become the core of a system of infrastructures and integrated mobility services.

# International development

The 2017-2026 business plan places great importance on international growth.

The group will pursue this growth following three main areas:

- 1. general contractor activities, with the capacity to build railway works, especially in countries lagging behind in terms of infrastructure;
- 2. market railway services, considering the fact that Trenitalia S.p.A. can export the extremely high quality of travel that it already offers with the Frecce trains to other countries. This is possible in the wake of the deregulation of the European railway space beginning in 2020 under the Fourth Railway Package;
- 3. LPT services abroad in the regional railway and road transport segments, as the group plans to seek mainly rail/road modal integration opportunities for passenger transport in the larger cities.

# Digital & Customer centricity

One enabler of FS Italiane group's 2017-2026 plan is the strong drive towards digitalisation, which lies at the heart of the extended customer experience that the group aims to make a part of its customers' daily lives (e.g., the travel companion), a solution that provides flexible, customisable door-to-door real-time journey planners that include other local public transport players' offers, as part of the group's coopetition approach.

In conclusion, the 2017-2026 business plan will accompany the FS Italian group in its transformation from a prevalently railway operator to an integrated mobility operator, radically updating logistics activities and taking the necessary leap forward by strengthening and integrating all transport infrastructures. This transformation is based on, inter alia, the strong drive towards digitalisation, which will be a determinant factor in speeding up the pace of our march into the future.

# The Fourth Railway Package

In 2016, the Fourth EU Railway Package was approved.

The package consists of a political pillar and a technical pillar, which are respectively established in directives and regulations, as specified below:

### Political pillar

- EU directive no. 2016/2370 of the European Parliament and Council of 14 December 2016 amending EU directive no. 2012/34/EU as regards to the opening of the market for domestic passenger transport services by rail and and the governance of the railway infrastructure. Directive must be transposed by 25 December 2018;
- EU regulation no. 2016/2337 of the European Parliament and Council of 14 December 2016 repealing the Council's regulation no. 1192/69 on common rules for the normalisation of the accounts of railway undertakings; and
- EU regulation no. 2016/2338 of the European Parliament and Council of 14 December 2016 amending EC regulation no. 1370/2007 concerning the opening of the market for domestic passenger transport services by rail.

# Technical pillar

- EU regulation no. 2016/796 of the European Parliament and Council of 11 May 2016, establishing a European Union Agency for Railways and repealing EC regulation no. 881;
- EU directive no. 2016/797 of the European Parliament and Council of 11 May 2016 on the interoperability within the European Union; and
- EU directive no. 2016/798 of the European Parliament and Council of 11 May 2016 on railway safety.

In short, the political pillar provides for the opening of domestic passenger transport services to competition throughout the EU by December 2020. Right of access can be limited only to protect economic equilibrium of public service contracts.

Furthermore, it contains rules concerning the infrastructure manager's independence within integrated groups, i.e., those in which there is both an infrastructure manager and railway undertakings.

EU regulation no. 2016/2338 provides calls for tenders as a general rule for awarding public service contracts. However, national authorities can continue to directly award service contracts under certain conditions.

Technical pillar strengths the powers of the European Union Agency for Railways (EUAR, formerly ERA)concerning the rolling stock authorisation in EU countries and its certification in accordance with safety standards.

### Regulatory Overview Transportation

- The relationship between Trenitalia and the Italian central / local administrations is regulated by different PSCs in which the required level of services are specified in terms of quantity and quality, tariff obligations, and fees.
- The State and the Regions define the perimeter of the services to be provided on the basis of the mobility and accessibility of user needs. Contracts are subject to specific regulation that defines eligible costs in terms of company operational expenses, depreciations and adequate capital investments returns.
- As the State and the Regions define quantity and quality of rail services included in the contracts, it is their responsibility to decide whether to reduce or increase them according to the terms and conditions defined in the contract.
- PSCs contain appropriate tools and clauses to guarantee payments to railway undertakings by Regions within the stated terms. In case of non-payment or under compensation of the services provided, the railway undertakings have the right to reduce or even to stop the services.
- Rail fares are adjusted annually for (i) inflation; (ii) any variations on contractual quality/performance objectives (e.g. punctuality, cancellations, cleaning); (iii) change in access infrastructure charges; and (iv) changes in regional fare policy.
- According to EC Regulation 1370/2007, competent authorities (the Regions and the State) may decide to directly award PSCs or to launch competitive tenders. Since 1997 only a few Regions have launched tenders for local rail transport. To date, all the PSCs have been awarded to Trenitalia (on its own or as a consortium leader).
- All risks deriving from the performance of the PSCs are borne by Trenitalia; the contracts with the central administration foresee the possibility of revision in case of significant change in the overall scenario, in order to maintain economic equilibrium.

# Infrastructure

- As foreseen by the Deed of Concession and Legislative Decree n. 112/2015 which implemented the Directive 2012/34/EU, the relationship between RFI and the State is regulated on the basis of an Agreement (*Contratto di Programma*).
- The *Contratto di Programma* is the basis for the funding of rail infrastructure development; the funding is primarily based on a medium term investment plan and covers infrastructure development, extraordinary maintenance and ordinary maintenance. Each *Contratto di Programma* lasts for a minimum of five years and may be subject to annual adjustments.
- According to the current regulatory framework, the *Contratto di Programma* is organized in two main parts:

- 1. investments to modernize and further develop rail infrastructure are disciplined by the *Contratto di Programma* Investment Part; and
- 2. ordinary and extraordinary maintenance and other activities (including safety, security and navigation) are disciplined by the *Contratto di Programma* Services Part.
- In 2016, following the ordinary approval procedure, the *Contratto di Programma* Investment Part has been updated with reference to the new investment strategy. Furthermore, the new *Contratto di Programma* Services Part 2016-2021 is in its final stage of approval. It introduces some novelties in line with the evolution of the regulatory framework (Legislative Decree n. 112/2015 and decision n. 96/2015 of the Italian Transport Regulation Authority).

# The Italian Transport Regulation Authority

The new authority became operational in January 2014. Its main objects are to:

- 1. guarantee equitable and non-discriminatory access to rail, port, airport and highway infrastructures;
- 2. define minimum quality levels for national and local transport considered to be a public service;
- 3. regulate access to rail infrastructure;
- 4. define public tender mechanisms to assign transport services; and
- 5. cooperate with the public administration in identifying public service obligation routes and support it in identifying the most effective methods to finance them.

On 5 November 2014, the Italian Transport Regulation Authority released its decision no. 70 of 31 October 2014 on the regulation of railway infrastructure access, where it was resolved on: (a) the adoption of measures for the fair and non-discriminatory access to rail infrastructure, and (b) the start of the process for the establishment of criteria for determining the toll for the use of railway infrastructure.

With respect to adoption of measures for the fair and non-discriminatory access to rail infrastructure for the year 2015, the new authority considers that, in defining the level of toll, the Infrastructure Manager should be oriented to principles of more transparency and economic efficiency, and in particular:

- a) in line with article 15 of Legislative Decree 188/2003 (now replaced by the article 16 of Legislative Decree n. 112/2015), the financial statements of the Infrastructure Manager must have a balance between the total revenues and the costs related to the management of the infrastructure;
- b) the eligible financial costs should be evaluated by the Infrastructure Manager having regard to any possible optimisation of the management of the debt, in line with the best market conditions;
- c) the investments made by the Infrastructure Manager after 31 December 2013 must be adjusted annually, as well as the related credit lines; and
- d) the incidence of the infrastructure management costs must be reformulated time to time, with immediate implementation, in order to burden less in the period in which the competitive scenario has been deploying and consolidating.

With regard to the eligible costs criteria, the authority requests the Infrastructure Manager to consider eligible, for the computation of the toll for the access to the HS\HC network, in addition to the infrastructure management costs (appropriately reformulated), only the following annual financial costs, properly optimized in line with the best market conditions:

- a) the annual financial costs related to the investments already made as of 31 December 2013 incurred by the Infrastructure Manager, as not covered by government grants; and
- b) the annual cumulative financial costs related to the investments in progress after 31 December 2013, calculated as the costs actually incurred by the Infrastructure Manager net of government grants.

On 18th November 2015, the Italian Transport Regulation Authority released its decision N. 96 of 13th November 2015 on the criteria for determining access charges for the use of national rail infrastructure.

The new regulatory framework concerns (i) the minimum access package supplied by the Infrastructure Manager (RFI) to all railway undertakings in a non-discriminatory manner and (ii) other rail services supplied by operators of service facilities. With regard to the charges for the use of rail infrastructure, the decision particularly defines:

- a five year regulatory period;
- perimeter of relevant costs;
- market segmentation based on the main types of service;
- new classification of the network;
- «caps» to the segment average kilometric charge for the purpose of market sustainability and
- requirements for regulatory accounting.

On 1st July 2016, the Italian Transport Regulation Authority released its **decision n. 75/2016** validating the 2016-2021 charging scheme for the Minimum Access Package supplied by the Infrastructure Manager (RFI). The charging scheme complies with the criteria for the determination of charges for access and use of the railway infrastructure, as adopted by Decision n. 96/2015 and later amendments.

The content of the main ART regulations in 2016 and first months of 2017 is summarised below:

## Resolution no. 32 of 23 March 2016

With this resolution, the ART postponed to 22 April 2016 the deadline (pursuant to resolution no. 96/2015, it was initially set for 12 March 2016) by which service plant operators must publish on their websites a report containing the list of prices for the subsequent service schedule and inform the regulatory accounting authority for type-A service plants pursuant to resolution no. 96/2015.

# Resolution no. 54 of 11 May 2016

Following a consultation, with this resolution, the ART approved certain measures relating to the minimum rights that passengers with "passes" may exercise with HS railway service operators. Railway companies are required to implement the ART's new rules by 1 January 2017. Until these measures go into effect, the ART reiterated its recommendation to HS railway service operators that they continue to refrain from charging customers fines or surcharges for failing to make seat reservations.

#### Resolution no. 72 of 27 June 2016

With this resolution, the ART clarified how to apply and interpret the measures established in Attachment 1 to resolution no. 96/2015 and approved postponing the terms of specific measures under the aforesaid resolution no. 96.

# Resolution no. 75 of 1 July 2016

With this resolution, the ART approved the conformity, with a few specific requirements, of the new 2016-2021 rates for the minimum national railway infrastructure access package, presented by the infrastructure operator on 30 June 2016, with the criteria for determining railway infrastructure access and use rates pursuant to resolution no. 96/2015, as amended.

# Resolution no. 77 of 7 July 2016

With this resolution, the ART approved postponing to 14 April 2017 the deadline for the procedure to establish the minimum railway transport service quality conditions for the national and local passenger services, which including public financing, commenced with resolution no. 54/2015.

#### Resolution no. 80 of 15 July 2016

With this resolution, the ART approved the conformity, with a few specific requirements, of the new 2017-2021 rates for services other than the minimum access package, presented by the infrastructure

operator, with the criteria for determining railway infrastructure access and use tolls pursuant to resolution no. 96/2015, as amended.

#### Resolution no. 83 of 27 July 2016

With this resolution, the ART commenced a public consultation on the "regulation scheme containing the definition of the method to identify the public service scopes and most efficient financing methods" and postponed the deadline for the procedure to 30 November 2016.

#### Resolution no. 93 of 4 August 2016

With this resolution, the ART approved the call for input, a document requesting observations and other comments useful in establishing the most appropriate regulations to ensure that railway shunting services are cost-effective and efficient.

#### Resolution no. 130 of 8 November 2016

With this resolution, the ART began a survey to gather information on the analysis of types of regulations for the medium and long haul bus transport service market. In this context, the Authority highlighted the need to also analyse the repercussions that developments in medium and long haul bus transport services have on other modes of transport.

#### Resolution no. 143 of 30 November 2016

With this resolution, the ART extended to 31 March 2017 the deadline for the definition of the method to identify the public service scopes and most efficient financing methods (commenced with resolution no. 49/2015).

#### Resolution no. 18 of 10 February 2017

On 10 February 2017, the ART approved the regulation measure with resolution no. 18 designed to ensure the cost effectiveness and operating efficiency of the railway shunting services. These measures are applicable to the 13 railway districts specified in the resolution.

# Relationship with the Italian State

The Italian State is the 100 per cent. shareholder of FS via the MEF. The State also acts as a client to FS via the MIT and Regions.

As sole shareholder, the Italian State: (i) appoints the Board of Directors; (ii) oversees FS' strategy via its board representation; and (iii) services (mainly to RFI) a large part of FS' debt directly through guaranteed State transfers as detailed in the debt structure section below.

As a client, the State (i) executes PSCs which set out scheduling, quality level and pricing of the services and fees to be paid to Trenitalia, and (ii) executes the *Contratto di Programma* with the infrastructure manager which sets out the funds for infrastructure investment and maintenance.

FS' legal status was formally changed on 12 August 1992 from that of a government body to a public limited joint stock company. However, in accordance with public law obligations and being an entity which, although formally a corporation under private law, is owned by the State and/or is benefiting from public money, the *Corte dei Conti* (Italy's Court of Auditors) controls FS. A *Magistrato Delegato*, appointed by the Court of Auditors, attends the meetings of FS' corporate bodies. FS is also required to abide by public procurement laws; indeed FS and other companies belonging to it are to be considered public undertakings under Article 2(b) of Directive 2014/25/UE (coordinating the procurement procedures of entities operating in the water, energy, transport and postal services sectors). The EU legislative provision applicable to FS was transposed into Legislative Decree n. 50/2016 (*Nuovo codice dei contratti pubblici di lavori, servizi e forniture*).

According to its Articles of Association and pursuant to Article 2364 of the Italian Civil Code, the General Assembly (*Assemblea*) of the FS, composed by the sole shareholder, MEF, resolves, in particular, on: (i) the appointment and revocation of members of the Board of Directors (*Consiglio di Amministrazione*) and the Board of Statutory Auditors (*Collegio Sindacale*) as well as their remuneration;

(ii) the responsibility of the Board of Directors members and the Statutory Auditors; and (iii) the approval of the annual financial statements.

# Debt Structure

FS's gross financial debt ("Total Debt") amounts to Euro 11,862m at YE 2016 vs. Euro 11,143m at YE 2015


The majority of the Group's debt is held by FS, RFI and Trenitalia (91 per cent. of Total Debt at 31<sup>st</sup> December 2016). RFI's borrowings are solely used to fund infrastructure investments and Trenitalia borrowings are entirely linked to the purchase/revamping of rolling stock, as described in further detail in the "*Use of Proceeds*" section.

The Group has a balanced debt maturity profile extending out over the next 15 years, with the majority of maturities falling due over the next 5 years.

A large part of FS' debt is funded directly through guaranteed State transfers (Euro 2.99 billion out of a total debt of Euro 11.86 billion as of 31 December 2016).

Out of the remaining Euro 8.87 billion at 31 December 2016, Euro 2.01 billion is fully underwritten by Eurofima, a European infrastructure supranational rated Aa1 by Moody's and AA+ by Standard & Poor's Rating Services.

With €2.05 billion outstanding, FS has significantly increased the use of senior unsecured bonds for its funding needs since the establishment of this EMTN Programme, which now account for 23% of financial sources. Supranational entities such as EIB, Cdp, Eurofima, still act as important Group's lenders whereas bank lending accounts for 16%. These percentages are calculated on the long term debt held by FS, RFI and Trenitalia which amounts to around Euro 9 billion.




Furthermore FS has a  $\leq 1.5$ bn committed revolving credit facility underwritten by the a pool of 10 banks in May 2015 having a 3-year maturity and additional uncommitted credit lines granted by many primary domestic and international banks.

Given improvement in profitability and conservative debt management, Total Debt / EBITDA has been keeping stable around 5.5x

Historically low borrowing costs and prudent management of finance costs, including interest rate risk management policies, has resulted in EBITDA interest cover remaining above 8x in the last four years reaching 16x in 2016.



FS Italiane maintains a strong equity cushion and capital base which offsets its debt leverage

Historically low borrowing costs and an effective management of finance costs, including interest rate risk management policies, has resulted in a containment of interest expense on debt generating value for the Group. In 2016 interest expense on debt was a record low at 1.7% compared to 2.4% in 2015.

# Deed of Concession

FS' infrastructure and national rail passenger activities are subject to public service obligations and are agreed by contract with the State through the Deed of Concession.

RFI acts as the national railway infrastructure manager, as set forth in the Deed of Concession with the MIT, under which RFI's role consists of developing, strengthening and maintaining the Italian rail network and controlling traffic and handling relations with train operators over safety standards and access to the tracks. The relationship between RFI and the State is governed by the *Contratto di Programma*.

# **Public Service Contracts**

The relationship between Trenitalia and the Italian central/local administrations are regulated by different PSCs in which the required level of services are specified in terms of quantity and quality, tariff

obligations, and fees. The State and the Regions define the perimeter of the services to be provided on the basis of mobility and accessibility needs. Such contracts are subject to specific regulation that defines eligible costs in terms of company operational expenses, depreciations and adequate capital investments returns. As the State and Regions define quantity and quality of rail services included in the contracts, it is left to their discretion to decide to reduce or increase the rail services according to the terms and conditions defined in the contract. PSCs contain appropriate tools and clauses to guarantee payments to railway undertakings by Regions within the stated terms. Rail fares are adjusted annually for (1) inflation; (2) any variations on contractual quality/performance objectives (e.g. punctuality, cancellations, cleaning); (3) change in access infrastructure charges; and (4) changes in regional fare policy.

Trenitalia primarily self-finances its own rolling stock. A put clause in favour of Trenitalia provides that the rolling stock accounted for by Trenitalia during the life of the contract according to the contractual terms have to be purchased by the Region should the services be assigned to another company.

According to EC Regulation n. 2016/2338, competitive tendering is the main rule for awarding public service contracts, but member states' competent authorities (Regions and Central Government) are allowed to opt for direct awarding of PSCs. Since 1997 only a few Regions have launched tenders for local rail transport.

# National Public Service Contracts

The MIT produces an investigation on medium/long distance passenger transport market conditions in order to ensure the equilibrium between costs and revenues of the rail service is maintained. The Interministerial Committee for Economic Planning ("CIPE") identifies the rail passenger services perimeter to be included in the National PSC. The MIT and MEF, within the limits of available financial resources, negotiate with the railway undertaking with respect to the annual services timetable, with the aim of guaranteeing the achievement of an economic equilibrium during the validity period of the contract. This analysis is based on a multi-year business plan ("PEF") that defines a specific regulatory accounting for eligible costs covered by State compensation, which includes the cost of capital

The contract concerns medium/long distance public transport services, and it is regulated by Law 166/2002 in accordance with the EU legal framework. The competent authorities (MIT and MEF) and Trenitalia recently defined the content of the 2017-2026 National PSC for passenger services. Currently the contract is in its final stage of approval. The overall duration of the contract is ten years.

# **Regional Public Service Contracts**

Regions are responsible for Regional PSCs in which scheduling, pricing and planning of the services are set. A Service Catalogue approach has been adopted by Trenitalia containing prices of each offered train category and type of service set on the basis of the costs incurred in providing them including a fair return on capital included. Contract duration is typically six years, with possibility of extension. Reviews of tariffs and fee structure within a PSC normally occur after the contract expires.

# Judicial Investigations and Proceedings (Arbitration, Antitrust Proceedings and Proceedings before the Public Contracts Supervisory Authority; Administrative Litigation)

In relation to the most significant judicial investigations and proceedings initiated by some public prosecutors' offices against former representatives of the Group companies, to date no events have been reported which the Issuer believes could lead to either the companies themselves or the Group being exposed to material liabilities or losses, nor is the Group aware, at present, of events that could considerably affect their economic, financial and equity position, and, therefore, no provisions have been set aside in the accounts. Furthermore, in cases where circumstances existed, the said companies appeared as aggrieved parties to recover damages.

In 2016, following criminal proceedings initiated by the public prosecutors against former or current group company representatives, there were no definitive rulings against senior management (company officers or general managers) for any of the following:

- particularly serious negligent criminal acts entailing significant damage to the concerned group company or that gave rise to the application of restrictive measures;
- negligent criminal acts covered by Legislative decree no. 231/2001; and
- additional negligent criminal acts covered by Law no. 190/2012.

To meet disclosure requirements, the paragraph below includes information on criminal proceedings and contingent assets and liabilities arising from the most significant civil, administrative and arbitration proceedings and proceedings before the Italian and EU authorities.

# Litigation pursuant to Legislative decree no. 231/01

• Criminal proceedings no. 25816/10 with the general register of crimes before the Florence Court relate to alleged crimes in the management of the contract assigned to a general contractor for the

design and construction of the Florence hub HS station and bypass. With respect to this contract, the Florence Public Prosecutors' Office investigated an RFI S.p.A. employee, the pro-tempore Chairman and pro-tempore CEO of Italferr S.p.A. and certain Italferr S.p.A. employees, as well as members of other organisations and companies performing the work. Following the Florence Public Prosecutors' request to prosecute all the people and companies under investigation, including Italferr S.p.A. for violations of Legislative decree no. 231/2001, on 10 March 2016, after the preliminary hearing, the Florence Court's Preliminary Hearing Judge decided the case could not proceed against Italferr S.p.A., its former CEO, former Operating Manager and Project Manager, nor against the RFI S.p.A. manager, while it admitted the proceedings against Italferr S.p.A.'s former Chairman and two officials, although it significantly reduced the scope. The Public Prosecutor appealed before the Court of Cassation against this decision and, in October 2016, the Court of Cassation denied all appeals concerning Italferr S.p.A., its former Operating Manager and Project Manager and ordered the cancellation of the decision to not proceed, admitting certain allegations against Italferr S.p.A.'s Chairman, pro-tempore CEO and officials for proceedings before the Florence Court. These proceedings, which involved Italferr S.p.A. with respect to the alleged violations of

These proceedings, which involved Italferr S.p.A. with respect to the alleged violations of Legislative decree no. 231/2001, were concluded with its acquittal, which became a definitive ruling when issued by the Court of Cassation.

- Criminal proceedings no. 10095/2010 in the general register of crimes pending before the Catania Court for RFI S.p.A.'s alleged administrative liability in relation to the workplace accident that occurred on 1 September 2008 in Motta Sant'Anastasia, in which two RFI S.p.A. employees lost their lives was concluded in the first level proceedings with the 14 April 2016 hearing in which the company was acquitted on the grounds that no crime had been committed. The ruling became irrevocably definitive on 21 May 2016.
- Hearings are underway in criminal proceedings no. 2554/13 in the general register of crimes at the Foggia Court (merged with criminal proceedings no. 3253/2010 in the general register of crimes) against RFI S.p.A. for administrative liability pursuant to Legislative decree no. 231/01 and one of its employees and two employees of Fersalento S.r.l.. The proceedings concern the fatal workplace accident on 5 March 2010 at Agro di Cerignola, in which an employee of Fersalento S.r.l. died.
- With respect to criminal proceedings no. 6305/09 in the general register of crimes pending before the Public Prosecutors' Office at the Lucca Court, following the railway accident in Viareggio on 29 June 2009, at the 31 January 2017 hearing, the judge read the first-level ruling. For FS Italiane group, the Court found that FS and FS Logistica S.p.A. had not committed administrative liability violations pursuant to Legislative decree no. 231/2001 "because there is no crime" and acquitted, "because they did not commit the crime, FS' former pro-tempore CEO for the allegations against him in his position as pro-tempore CEO, FS Logistica S.p.A.'s former CEO and former Chairman, and five RFI S.p.A. officials. However, it found Trenitalia S.p.A. and RFI S.p.A. guilty of administrative violations pursuant to article 25-septies of Legislative decree no. 231/2001, fined them €700 thousand each and prohibited them from advertising their goods and services for three months. The Court also issued guilty rulings for 12 natural persons within FS Italiane group, including two of RFI S.p.A.'s former pro-tempore CEOs who succeeded each other between 2001 and 2009 and Trenitalia S.p.A.'s former pro-tempore CEO, in addition to another 11 natural persons and three companies outside the group for violations of Legislative decree no. 231/2001, while one person was found not guilty. The Court also ordered the guilty parties, jointly and severally and with the related civil liability, to pay damages (in addition to court and defence costs) to the aggrieved parties that had filed the lawsuit, submitting most of the damages to the civil court judge for liquidation, while ordering payment of an advance on the damages at the same time. The Court set a 90-day term, extended by a further 90 day term, at the request of the court and approved by the President of the court, expiring on 31 July 2017, to lodge arguments, with the consequent possibility of filing appeals with the Court of Appeals. None of the orders, except for the advance, are executive pursuant to law until the ruling has been issued.
- Arguments are being heard in criminal proceedings no. 7906/2009 in the general register of crimes with the Public Prosecutors' Office at the Latina Court concerning alleged injuries due to negligence in connection with alleged violations of anti-accident legislation (following an accident that occurred on 10 August 2009). Three of RFI S.p.A.'s officials are being investigated, in addition to the company itself for the alleged violation of Legislative decree no. 231/01. RFI S.p.A. has also been summoned for third party liability upon the petition of the aggrieved parties.

- Criminal proceedings no. 1430/2014 in the general register of crimes with the Public Prosecutors' Office at the Gela Court are pending for the alleged violation of article 589.1/2 and the last paragraph of the same article of the Italian Criminal Code (negligent manslaughter in violation of workplace safety regulations after three RFI S.p.A. maintenance workers were fatally hit). The former pro-tempore CEO and eight officials and former officials of RFI S.p.A. have been charged in these proceedings, and RFI S.p.A. has been charged with administrative liability in connection with violations of article 25-septies of Legislative decree no. 231/01. The preliminary investigations are underway.
- Criminal proceedings no. 3566/2015 in the general register of crimes with the Public Prosecutors' Office at the Rimini Court are pending in relation to the accident that occurred on 5 March 2015 in which an employee of A.T.S. Costruzioni was injured while working at OMC Locomotive in Rimini. Trenitalia S.p.A. has been charged with the administrative crimes covered by article 25-septies of Legislative decree no. 231/01, as the negligence that led to the injuries was allegedly committed in violation of anti-accident and health protection in the workplace legislation.
- Criminal proceedings no. 20765/2014 in the general register of crimes are pending before the Florence Court in reference to the operating accident that occurred on 12 January 2014 during rolling stock shunting operations. One employee working as a signalman at the watchtower at the entrance to where train carriages are kept lost his life in the accident. The preliminary hearing is being held against two managers and two employees of Trenitalia S.p.A. (charged with negligent manslaughter for violations of anti-accident legislation, and Trenitalia S.p.A. is also charged with administrative liability following a crime covered by article 25-septies of Legislative decree no. 231/01.
- Criminal proceedings no. 1525/08 in the general register of crimes (the "Truck Center" case) relate to negligent manslaughter due to violations of anti-accident legislation. The first-level proceedings were concluded with certain FS Logistica S.p.A. officials found guilty, along with the company itself, for both third party liability and violations of Legislative decree no. 231/2001. The court ruling is being appealed.
- Criminal proceedings no. 5643/10 in the general register of crimes pending before the Sassari Court were initiated following a fatal accident involving the driver of train 8921 when it hit an obstacle on the tracks after an exceptional, unexpectedly large mudslide. Arguments are being heard against the three RFI S.p.A. employees and the company itself for third party and administrative liability.
- Criminal proceedings no. 1933/2011 in the general register of crimes with the Public Prosecutors' office pending before the Latina Court were initiated following the fatal accident on 25 February 2011 involving an employee of an outside company on the Campoleone-Cisterna di Latina section of track. Preliminary hearings are being held against one manager and three employees of the company and the company itself, in respect of the charges against it for violation of Legislative decree no. 231/01.
- Criminal proceedings no. 1758/2014 in the general register of crimes before the Milan Court relate to alleged violations of the legislative limits established for the drainage of industrial waste water in public sewers at an industrial plant in Milan. In these proceedings, charges have currently been lodged against one manager of Trenitalia S.p.A. and Trenitalia S.p.A. itself for liability under Legislative decree no. 231/01 in relation to the same alleged environmental violations.

# Other significant criminal court proceedings

• Criminal proceedings no. 3034/2012 in the general register of crimes previously with the Public Prosecutors' Office at the Rossano Court and subsequently transferred to the Castrovillari Public Prosecutors' Office relate to a fatal accident in which a train hit a car with six people inside it at the private railroad crossing on the Rossano C. - Mirto Crosia section. The Public Prosecutor has issued a notice that the preliminary investigations against RFI S.p.A. managers and employees (some of whom are pensioners) and non-FS Italian group parties have been concluded.

- Criminal proceedings no. 6765/2012 in the general register of crimes with the Brindisi Court are pending with the Lecce Court of Appeals in connection with a claim relating to an accident involving the Freccia Argento train no. 9351 and a lorry on 24 September 2012 at the railroad crossing on the Bari Lecce section near the Cisternino (BR) station. In these proceedings, RFI S.p.A. and Trenitalia S.p.A. have joined the criminal proceedings as a civil party claiming damages. The non-group defendant found guilty has appealed against the Brindisi Court ruling of 21 October 2014.
- Criminal proceedings no. 35874/13 in the general register of crimes with the Public Prosecutors' Office at the Rome Court originated from alleged violations of Legislative decree no. 81/2008 in connection with the introduction of the "single driver" module which, according to the accusations, allegedly weakened the measures in place to prevent risks in emergencies and/or first aid situations involving the train driver while the train is operating. The Rome Public Prosecutor directly summoned Trenitalia S.p.A.'s former CEO and Director of Frecciarossa Operations. Arguments are currently being heard.

## Arbitration proceedings with general contractors

- Giovi third railway crossing: RFI/COCIV arbitration. RFI S.p.A. appealed against the award, concerning the development of certain designs previously completed by the COCIV consortium, COCIV lodged a cross appeal. The proceedings are still pending (the hearing of conclusions was postponed to 24 May 2018). Reference should be made to the 2015 annual report for additional details.
- Sub-section AV/AC Novara-Milan: RFI-FCA arbitration. Following the appeal against the award which involves part of the reserves advanced by FCA in the course of work, the proceedings, which were commenced by FCA, are now pending before the Supreme Court following such appeal by RFI. Proceeding for revocation of judgement lodged by FCA before the Rome Court of Appeal is also pending (the hearing for clarification of the conclusions is scheduled for 7 June 2017).

## Civil and administrative proceedings

K2 Discount pursuant to Ministerial decree no. 44T/2000. With respect to that indicated in the previous annual reports, to which reference should be made for additional details, in relation to the two cases currently pending before the Lazio regional administrative court against URSF (the office that regulates railway service) decisions no. 18/2006 and 83/2007, a public hearing was scheduled for 14 June 2017. With respect to the appeal filed by the railway companies petitioning for compliance with the Council of State's decision cancelling DM 92T (reference should also be made to the 2015 annual report for a detailed description of all events in this stage of the proceedings), on 26 September 2016, the ad Acta Commissioner's delegate issued a conclusive report on the outcome of the preliminary investigations, specifying that the K2 discount period began on 1 January 2006 and ended on 30 June 2009, except for the traffic produced using rolling stock that, before 30 June 2009, met the conditions for a single driver (equipped with ground sub-system technologies, installation of the connected on-board signalling system and the issue of rules and procedures governing how single-driver trains are operated). The ad Acta Commissioner's delegate then quantified the individual amounts, including interest accrued at the legal rate up to 30 September 2016 and separated from self-applied discounts, to be paid to the four appellant railway companies affected by the order to comply (namely, Rail Traction Company, NordCargo, SBB Cargo and DB Schenker) totalling approximately €20 million (which, net of the amount already withheld by the appellant companies, will entail covering the balance of roughly €12.6 million). The company recognised a liability of the same amount to the railway companies and an asset of the same amount from the MEF, against an accrual of €30 million in the 2015 update to the GPC-I for "charges arising from the application of Ministerial decree no. 44T/2000" as part of the overall accrual for "train operating and efficiency technologies". Finally, the company has recalculated and increased the provision to cover any interest and related charges to be incurred should it be ordered pending reimbursement of the amounts that, in the first level decision, it might be ordered to pay eligible railway companies. Following the deposit of the conclusive report of the ad Acta Commissioner's delegate, RFI S.p.A. proposed the commencement of talks with the four appellant railway companies, in which the MIT will also participate, to quickly settle the matter, which may include the negotiation of settlement agreements between the parties; such proposal has unfortunately not achieved the expected results. As a result the four appellant railway companies have promoted a new legal proceeding by notifying MIT and RFI of 3 April 2017 a recourse before the Council of State for additional reasons in order to obtain clarification on the compliance with the decision in respect of the K2 discount matter (with particular reference to the way in which the ad Acta Commissioner's delegate conclusive report was adopted) or, subordinately, the compensation for damage for the non-performance of the decision, whose hearing has been scheduled on 19 October 2017.

- Appeal against ART resolution no. 70/2014. Various FS Italiane group companies (RFI S.p.A., Grandi Stazioni S.p.A. and Centostazioni S.p.A.) lodged three extraordinary appeals with the President of Italy against ART resolution no. 70 of 31 October 2014 "*Regulation for fair and equal access to railway infrastructures and commencement of proceedings to define the criteria for the definition of the toll to use railway infrastructures*"). Initially lodged with the Lazio regional administrative court, the appeals were then transferred to the Piedmont regional administrative court where RFI S.p.A.'s and Grandi Stazioni S.p.A.'s cases were summarised. Trenitalia S.p.A. appeared in both proceedings on 5 May 2016. During the 15 March 2017 hearing, the judge decided to hear one case only, that resulting from RFI S.p.A.'s appeal, and to postpone the hearing about Grandi Stazioni S.p.A.'s appeal to 28 June 2017. At the outcome of the aforementioned public hearing on 21 April 2017, with judgment no. 541/17, the TAR Piedmont partially rejected and declared partially inadmissible the extraordinary appeal with the President of Italy (then transposed in front of the TAR) brought by RFI S.p.A. against the ART resolution no. 70/2014.
- Appeal against ART resolution no. 96/2015. With an extraordinary appeal before the President of Italy, RFI S.p.A., Trenitalia S.p.A. and the former Grandi Stazioni S.p.A. appealed against ART resolution no. 96 of 13 November 2015 containing the principles and criteria for determining the fees to access and use the railway infrastructure. Their appeals were transferred to the Piedmont regional administrative court. RFI S.p.A. also appeared in the proceedings pending before the Piedmont regional administrative court for the railway transport operator Nuovo Trasporto Viaggiatori S.p.A.'s appeal against the same ART resolution no. 96/2015. During the hearing of 15 March 2017, the judge postponed discussion of Trenitalia S.p.A.'s appeal to the hearing scheduled for 28 June 2017. Since June 2016, while the FS Italiane group companies' appeals were pending. the ART resumed adjusting the fees to access and use the railway infrastructures by passing resolutions no. 72/2016, no. 75/2016 and no. 80/2016. These resolutions were also appealed by Trenitalia S.p.A. and other railway transport companies. In particular, with a brief presenting additional grounds, in September 2016, Trenitalia S.p.A. appealed against resolutions no. 72 and no. 75/2016. The hearing to discuss the precautionary injunction was held on 11 October 2016 in which the panel suggested, considering the complexity of the matter, discussing the merits of the case and postponing the proceedings to the public hearing of 15 March 2017, when they were postponed again to 28 June 2017. As for resolution no. 80/2016, Trenitalia S.p.A. lodged its appeal individually before the Piedmont regional administrative court. During the first public hearing held on 15 March 2017, the Piedmont regional administrative court postponed the discussion of the appeal and the related documents to the hearing scheduled for 28 June 2017.
- Appeal against ART resolution no. 33/2016. On 31 July 2015, with resolution no. 64, the ART commenced proceedings against RFI S.p.A., taking disciplinary action for any violation of the regulatory measures in resolution no. 70/2014. In the preliminary stage, for some of the ART's claims (namely those regarding measures 1.6.4, 3.6.1, 11.6.1 and 11.6.3), RFI S.p.A. has presented a set of commitments that, with ART resolution no. 91 of 5 November 2015, the Authority found to be admissible and published on its website, thereby beginning the market test stage. On 16 March 2016, the ART published resolution no. 24/2016 on its website, approving these commitments and making them mandatory, without assessing any violations by RFI S.p.A.. With respect to the claims in response to which RFI S.p.A. did not submit any commitments, it has instead lodged defensive briefs and presented its arguments in hearings before the ART's offices and board. With resolution no. 33/2016, the ART concluded the disciplinary proceedings with the assessment of two violations and a total fine of €30,000. With respect to the violation of measure 5.6.1.d) "organisation of the penalty/exemption clause system into tiers", the ART also required RFI S.p.A. to introduce a clause in the 2015 and 2017 Network Prospectuses, within 15 days of notification of the measure, establishing an exemption tier of 3% for the railway companies with network use contracts worth less than €6 million and publish the updated Network Prospectuses on its website with immediate notification to all concerned parties. RFI S.p.A. performed all of the above within the deadlines, publishing the updates to the 2015 and 2017 Network Prospectuses and paying the total fine due.

However, without prejudice to these measures, to protect its interests, RFI S.p.A. lodged an appeal on 23 May 2016 with the Piedmont regional administrative court against resolution no. 33/2016 concerning only the assessment of the aforementioned violations. The date of the hearing has yet to be set.

- Appeal against AEEGSI resolution no. 654/2015. On 26 February 2016, RFI S.p.A. lodged an appeal before the Lombardy regional administrative court against resolution no. 654/2015 whereby the AEEGSI approved the rate regulation for electrical energy transmission, distribution and measurement services for the 2016-2023 regulation period. This measure consists of, inter alia, the "Integrated measures for the provision of electrical energy transmission and distribution services for the 2016-2019 period ("TIT")", including part IV governing "special rate regimes". In accordance with the special rate regime applicable to RFI S.p.A. and the railway system, the new TIT provides that, as from 1 January 2016, the benefit of applying a "single virtual point" is limited to energy used for the universal and cargo services only, and therefore cannot be applied to energy used for services sold on the market (for which monthly energy consumption is considered to "evenly distributed throughout RFI S.p.A.'s withdrawal points" and, accordingly at the maximum applicable rate). The first hearing in the legal proceedings has yet to be set.
- Appeal against ART resolution no. 54/2016. In September 2016, Trenitalia S.p.A. lodged an extraordinary appeal before the President of Italy to cancel ART resolution no. 54/2016 published on 11 May 2016 containing "*Measures concerning the minimum content of specific rights that passengers with long-term passes may demand from HS railway service operators*". The appeal was lodged on 7 September 2016. On 25 October 2016, the ART transposed the appeal to the Piedmont regional administrative court and the hearing has yet to be scheduled.
- Unionlog S.p.A. c/ RFI SpA. On 28 March 2017 Unionlog S.p.A. commenced proceeding against RFI before the Civil Court of Rome in order to: (a) ascertain and seek a declaration in respect of RFI's pre-contractual liability concerning the opening of a rail link at Secugnago Station; (b) seek an order for RFI to pay Unionlog's damages for the conduct of RFI, quantified by the claimant for a total of €5,702,700.88 (€3,105,700.88 €for loss of profit and €2,597,000 for emerging damage). The hearing indicated in the writ of summons is scheduled for 6 July 2017 and RFI is providing for the constitution in court.
- On 27 January 2017, RFI was notified as defendant of proceedings brought before the TAR of Lombardy, Milan, by Serfer Servizi Ferroviari S.r.l. for the annulment, subject to the grant of monocratic precautionary measures and the suspension of the measures previously taken to carry out the competitive procedure that RFI had to establish on the basis of the resolutions adopted by the ART (Resolutions no. 70/2014 and 104/2015), aimed at identifying the sole manager of the Lecco Maggianico and Milano Segrate service facilities. The aforementioned competitive procedure ended on 28 November 2016 with the definitive award made in favour of both TS Traction & Service S.r.l. (the other party in the aforementioned appeal). By a decree published on 1 January 2017 the TAR of Lombardy - Milan has accepted the request submitted by Serfer Servizi Ferroviari S.r.l. to suspend the effects of the award decision in favour of TS Traction & Service Srl, ordering such party not to enter into any contract for rail transport services in the two service facilities of Lecco Maggianico and Milano Segrate until the end of the relevant precautionary hearing, for which the council chamber had been fixed for 23 February 2017. By way of a subsequent decision dated 21 April 2017, the TAR of Lombardy - Milan declared the appeal brought by Serfer Servizi Ferroviari S.r.l. inadmissible for late notification of the same, with a consequent order for costs, totaling Euro 3,000.00 plus legal expenses, in favor of each of the parties constituted, i.e. RFI and TS Traction & Service S.r.l..

# Proceedings before the Italian and EU authorities

• Antitrust Authority proceedings A/495. On 15 June 2016, the Antitrust Authority resolved to begin a preliminary investigation against Busitalia Veneto S.p.A. (Busitalia Veneto) and Busitalia Sita Nord S.r.l. (Busitalia SN), as well as against APS Holding SpA (APS), to ascertain whether there was a violation of article 102 of the Treaty on the Functioning of the European Union and article 3 of Law no. 287/1990 concerning the abuse of a dominant position. At the same time, the Authority authorised surprise inspections at the Busitalia SN's and Busitalia Veneto's Rome, Florence and Padua offices, which took place on 23 June 2016. The Antitrust Authority's initiative is part of the

relevant government body/contracting station's preparation of documentation for the tender to assign urban and suburban car and tram services in the province of Padua. In the measure notifying the commencement of the preliminary investigation, the authority charged Busitalia Veneto, which manages the transport services subject to the future tender procedure, and its shareholders Busitalia SN and APS with using practices meant to delay the preparation of tender documentation, which included the omission of information and the delayed transmission of necessary data/pieces of information. The Authority also charged the companies with exerting allegedly undue pressure on the Padua provincial authorities to obtain authorisation to increase the prices of tickets sold electronically, i.e. SMS tickets. As for the first practice, the Antitrust Authority threatened to take, pursuant to article 14-bis of Law no. 287/1990, provisional precautionary measures against the parties in the proceedings. However, following the information and clarifications received, on 20 July 2016, the Authority resolved not to take precautionary measures against Busitalia SN and Busitalia Veneto (Antitrust Authority measure no. 26129 of 20 July 2016). On 14 December 2016, Busitalia SN and Busitalia Veneto proposed certain remedies in terms of conduct that, upon the outcome of the preliminary assessment of "no clear lack of grounds", were published on the Authority's website to enable the concerned third parties to submit any observations (i.e., market tests). Once the observations submitted in the market tests were considered, Busitalia SN and Busitalia Veneto proposed certain accessory changes to commitments. The proceedings are still underway. The procedure to evaluate the commitments must be completed within three months of when they are published. However, the term may be suspended for the time needed to obtain the European Commission's opinion pursuant to article 11.4 of regulation no. 1/2003.

- Antitrust Authority proceedings PS/10578. On 9 November 2016, the Antitrust Authority resolved to begin preliminary proceedings against Trenitalia S.p.A., alleging that its sales systems violate Consumers' Rights Code regulations protecting against unfair business practices. The notice that preliminary proceedings had commenced was served on 15 November 2016, when an inspection was conducted at the Trenitalia S.p.A. offices in Rome. In short, the Antitrust Authority claimed that the company was allegedly using unfair business practices, implemented through certain, limited sales channels, which impacted the public service obligations imposed on Trenitalia S.p.A. in the regional transport segment and, partly in the medium and long haul transport segment. Specifically, it claimed that the practice was "aggressive" under the Consumers' Rights Code. Within the deadlines established in the proceedings, Trenitalia S.p.A. has: (i) filed petitions to obtain the return and/or confidentiality of the documents that were gathered during the inspection, in order to protect any sensitive information from third parties; (ii) provided a response with respect to the Antitrust Authority's request for information when the preliminary proceedings began; and (iii) submitted briefs and documents to justify that its conduct was appropriate. Furthermore, with two notes dated December 2016 and January 2017, while confirming that its conduct was legitimate, Trenitalia S.p.A. formulated a series of commitments to remedy the practices that the Antitrust Authority deemed were improper in the preliminary evaluations when the proceedings began. With its resolution of 7 February 2017, the Antitrust Authority did not accept the company's proposed commitments, ordering the preliminary proceedings to continue. Originally scheduled for 8 April 2017 and later extended to 7 June 2017, is now set for 22 July 2017.
- EU cases SA 32179 and SA 32953. On 28 March 2014, the European Commission's Directorate-General for Competition notified Italy of a decision to begin a formal investigation in connection with two potential state aid programmes relating to:
  - a) state aid measures under the forms of transfers of infrastructure assets (case SA 32179); and
  - b) compensation for a public service obligation in the rail freight sector (case SA 32953).

The first aid measure being investigated relates to four asset allocation operations within the FS Italiane group, in which assets were allocated to Trenitalia S.p.A. and FS Logistica S.p.A., respectively. In particular, these transfers include assets that do not constitute railway infrastructure (they are mainly workshops) and are, in any case, no longer functional for the infrastructure operator. The second measure being investigated relates to the compensation by the Italian station to Trenitalia S.p.A. for the discharge of public service obligations in rail freight transport from 2000 to 2014 under three consecutive public service contracts. In 2015 and 2016, there were no other formal communications. The risk analysis for the EU cases detailed above shows that, to date, the European Community has not taken any other direct action against FS Italiane group for potential state aid and, accordingly, there are no actual disputes directly affecting the group at this time. Considering that this situation is still in a preliminary stage and is complex, it is in any case impossible to objectively identify a contingent liability or reliably estimate any amount that might be paid. Following our

reading of the above analyses and based on the opinions of independent legal experts, we do not believe that the conditions established by IAS 37 have been met for the recognition of provisions. See "*Risk Factors - Risk related to the European Commission procedures SA 32953 and SA 32179 relating to the implementation of the competition policy*".

- EU SA 44627. On 24 November 2016, the Directorate-General for Competition of the European Commission authorised the "Ferrobonus" scheme (SA 44627) as compatible state aid pursuant to article 93 of the Treaty on the Functioning of the European Union ("TFEU") and the guidelines for state aid to railway companies, following the Italian authorities' official notification to the European Commission on 22 June 2016. This authorisation makes it possible to disburse aid for three years (starting as from the authorisation date) of up to €30 million per year (accrual of €20 million pursuant to article 1.648 of Law no. 208 of 28 December 2015) to logistics operators that decide to increase the volume of cargo transported by rail to encourage the development of intermodal transport.
- EU SA 40887/SA 45482. On 19 December 2016, the European Commission authorised the 2015-2017 measure to support cargo railway transport (SA 40887/SA 45482) as compatible state aid pursuant to article 93 of the TFEU and the guidelines for state aid to railway companies. This authorisation makes it possible to disburse €255 million (€55 million for 2015, €100 million for 2016 and €100 million for 2017) to railway companies for three years (2015-2017) to offset the costs they incur to access the infrastructures and a portion of saved external costs.

#### **Recent events**

# FS Italiane: Fitch downgrades the rating by one notch to 'BBB' mirroring the downgrade of Italy. Outlook changes from negative to stable

On 5th May 2017 Fitch downgraded Ferrovie dello Stato Italiane's Long-Term Issuer Default Rating to 'BBB' from 'BBB+' while changing the outlook from negative to stable. The rating action mirrors the corresponding downgrade on Italy's national government, made by the Agency on April 21<sup>st</sup>, because of the FITCH criteria applicable to the Ferrovie rating.

# Trenitalia completes the acquisition of c2c

On 13 February 2017 Trenitalia has completed the acquisition of Essex and London train operator c2c from National Express Group via its British subsidiary Trenitalia UK. The deal, formally approved by the Department for Transport, will see c2c's franchise continue to run until November 2029. The total consideration of the deal has been confirmed in the region of £72.6 million. FS Italiane, parent company of the Group, in its function as guarantor with the Department of Transport, has paid to the vendor an extra £35.0 million to settle an existing intercompany loan granted to the franchisee and in which it now acts as a lender. Trenitalia intends to build on c2c's existing strengths as one of the UK's most punctual and popular train operators. The franchise will benefit from Trenitalia's innovative technology, such as advanced ticketing, that will aim to provide to c2c customers with an increase in their overall quality of service. All of Trenitalia's tech is proven in the highly competitive Italian railway market, and has been one of the most important drivers of the continued increase in customer satisfaction recorded in recent years. In December 2015, Trenitalia became the first new entrant to be awarded a "PQO Passport" by the Department for Transport in the United Kingdom: this acquisition marks the first step in Trenitalia's longterm plan to establish a major presence in the UK rail market. On January 24th 2017 Trenitalia announced its participation, in a joint venture with FirstGroup, in bidding for the East Midlands and West Coast Partnership (which will include the HS2 line) rail franchise; due to be awarded in 2018.

# FS Italiane regains 100% ownership of Centostazioni

On 30 January 2017 FS Italiane regained 100% of Centostazioni. The process of buying back the 40% holding owned by Archimede 1 (Save Group) was concluded with the return and transfer of the stock to FS Italiane. The deal was closed in Milan in the presence of Renato Mazzoncini, CEO and General Manager of FS Italiane, and Monica Scarpa, President of Archimede 1 and CEO of Save. The operation, authorised by the Italian Competition Authority (AGCM), was carried out by FS Italiane with a payment of 65.6 million euros. For FS strategies this is a decisive step towards creating a network of Smart Stations, more than 600 stations managed by a single owner, which is destined to become the beating heart of a system of integrated mobility infrastructures and services, as set out in the 2017-2026 business

plan. The stations will thus become intermodal hubs with bus terminals, parking lots, car rental, car/bike sharing and electric car charging points, capable of offering useful accessory services and new functions, from temporary office space to start-up incubators.

# FS Italiane acquires Trainose

On 18th January 2017 it took place the signing for the acquisition by FS Italiane of TRAINOSE, the Greek rail transport company. The agreement has been executed by Renato Mazzoncini, FS' CEO and General Manager, and by Antonis Leousis, CEO of the Hellenic Republic Development Asset Fund (HRADF). In July 2016 FS Italiane has been declared "preferred investor" by HRADF which had accepted the Euro 45million offer. This transaction is perfectly in line with the 2017-2026 Industrial Plan which envisages Europe as the target market for FS. The closing is expected following the green light from European Union. Trainose is the leading Greek railway undertaking, it provides passengers and freight transport services both at national, regional and international level, along with logistic services. The main route on which operates is Athens – Salonica.

# Ferrovie dello Stato Italiane and Astaldi: final closing of stake in M5 S.p.A.

On 9 June 2017, Ferrovie dello Stato Italiane S.p.A. acquired 36.7% stake (equity and shareholder loan) held by Astaldi in M5 SpA, Concessionaire of Line 5 (Lilla Line) of the Milan Metro, valued at EUR 64.5 million. The closing took place at the end of the planned authorisation process, as well as upon the outcome of the assessment by the Italian Competition Authority. Astaldi will continue to hold a 2% stake in M5, as a commitment to support the development of its activities. The shares held by other shareholders remain unchanged: Ansaldo STS 24.6%, ATM 20%, Alstom 9.4% and Hitachi Rail Italy 7.6%. The acquisition of 36.7% stake in M5 marks another step forward in carrying out FS Industrial Plan 2017-2016, with regard to the integrated mobility pillar. The Lilla line (of the Milan Metro links Bignami Parco Nord station to San Siro Stadio station, along a route extending for about 13 kilometres, with 19 stations and a light transport system connected with Milan's other underground lines.

# FS S.p.A. will build two HS lines in Iran

On 12 April 2016, a framework cooperation agreement was signed between the CEO and General Manager of FS S.p.A. and the Chairman of the Iranian Railways, to build two HS lines in Iran, build a test centre and train personnel. This framework cooperation agreement comes in the wake of the Memorandum of Understanding that the parties signed on 9 February 2016. FS S.p.A., as general contractor, will design, build, test and roll out the HS Teheran – Hamedan and Qom – Arak lines. Italcertifer S.p.A., the group's certification company, will instead work on the design, construction and certification of an Iranian railway test centre that will use advanced equipment to test both the infrastructure and the rolling stock.

# TAXATION

The following is a general description of certain Italian, US and EU tax considerations relating to the Notes. It does not purport to be a complete analysis of all tax considerations relating to the Notes, whether in those countries or elsewhere. Prospective purchasers of Notes should consult their own tax advisers as to which countries' tax laws could be relevant to acquiring, holding and disposing of Notes and receiving payments of interest, principal and/or other amounts under the Notes and the consequences of such actions under the tax laws of those countries. This summary is based upon the law as in effect on the date of this Base Prospectus and is subject to any change in law that may take effect after such date.

#### **Taxation in the Republic of Italy**

#### Tax treatment of the Notes

Legislative Decree No. 239 of 1 April 1996, as subsequently amended ("**Decree 239**") provides for the applicable regime with respect to the tax treatment of interest, premium and other income (including the difference between redemption amount and the issue price) (hereinafter collectively referred to as "**Interest**") from notes falling within the category of bonds (*obbligazioni*) or debentures similar to bonds (*titoli similari alle obbligazioni*), issued, *inter alia*, by public entities transformed in limited companies, pursuant to specific law provisions.

For this purpose, bonds and debentures similar to bonds (*titoli similari alle obbligazioni*) pursuant to Article 44 of Presidential Decree No. 917 of 22 December 1986 are securities that incorporate an unconditional obligation to pay, at redemption, an amount not lower than their nominal value, with or without the payment of periodic interest, and which do not grant the holder any direct or indirect right of participation to (or of control of) the management of the Issuer or to the business in connection to which the securities were issued, nor to control the same.

#### Italian resident Noteholders

Pursuant to Decree 239, where the Italian resident Noteholder, who is the beneficial owner of the Notes, is:

- (a) an individual not engaged in an entrepreneurial activity to which the relevant Notes are connected (unless he has opted for the application of the "*risparmio gestito*" regime according to Article 7 of Italian Legislative Decree No. 461 of 21st November, 1997, as amended ("Decree No. 461") see under "*Capital gains tax*", below);
- (b) a non-commercial partnership;
- (c) private or public institutions (other than companies), trusts not carrying out mainly or exclusively commercial activities, the Italian State and public and territorial entities; or
- (d) an investor exempt from Italian corporate income taxation,

Interest payments relating to the Notes, accrued during the relevant holding period, are subject to a tax, referred to as *imposta sostitutiva*, levied at the rate of 26 per cent (either when Interest is paid or when payment thereof is obtained by the holder on a sale of the Notes). All the above categories are qualified as "net recipients".

In the event that Noteholders described under (a) and (c) above are engaged in an entrepreneurial activity to which the Notes are connected, the *imposta sostitutiva* applies as a provisional tax and may be deducted from the taxation on income due.

Subject to certain limitations and requirements (including a minimum holding period), Italian resident individuals not acting in connection with an entrepreneurial activity may be exempt from any income taxation, including the *imposta sostitutiva*, on Interest if the Notes are included in a long-term savings account (*piano di risparmio a lungo termine*) that meets the requirements set forth in Article 1(100-114) of Law No. 232 of 11 December 2016 (the **Finance Act 2017**).

Where an Italian resident Noteholder is a company or similar commercial entity or a permanent establishment in Italy of a foreign company to which the Notes are effectively connected and the Notes

are deposited with an authorised intermediary, Interest will not be subject to *imposta sostitutiva*, but must be included in the relevant Noteholder's income tax return and are therefore subject to general Italian corporate income taxation (and, in certain circumstances, depending on the "*status*" of the Noteholder, also to the regional tax on productive activities ("**IRAP**")).

Where an Italian resident Noteholder is an individual engaged in an entrepreneurial activity to which the Notes are connected, interests, premium and other income relating to the Notes, are subject to *imposta sostitutiva* and will be included its relevant income tax return. As a consequence, interests, premium and other income will be subject to the ordinary income tax and the *imposta sostitutiva* may be recovered as a deduction from the income tax due.

Pursuant to Decree 239, *imposta sostitutiva* is applied by banks, SIMs, fiduciary companies, SGRs, stockbrokers and other entities identified by a decree of the Ministry of Economy and Finance (each an "**Intermediary**"). An Intermediary must (a) be resident in Italy or be a permanent establishment in Italy of a non Italian resident financial intermediary; and (b) intervene, in any way, in the collection of interest or in the transfer of the Notes. For the purpose of the application of the *imposta sostitutiva*, a transfer of Notes includes any assignment or other act, either with or without consideration, which results in a change of the ownership of the relevant Notes or in a change of the Intermediary with which the Notes are deposited.

Where the Notes are not deposited with an Intermediary, the *imposta sostitutiva* is applied and withheld by any Intermediary paying Interest to a Noteholder or, absent that by the Issuer.

Under the current regime provided by Law Decree No. 351 of 25 September 2001 converted into law with amendments by Law No. 410 of 23 November 2001 ("**Decree 351**"), Law Decree No. 78 of 31 May 2010, converted into Law n. 122 of 30 July 2010 and Legislative Decree No. 44 of 4 March 2014, all as amended, Italian real estate investment funds and Italian real estate SICAFs, qualifying as such from a legal and regulatory perspective (the "**Real Estate Funds**") are subject neither to *imposta sostitutiva* nor to any other income tax in the hands of the Real Estate Funds.

If the investor is resident in Italy and is an open ended or closed ended investment fund, a SICAV (an investment company with variable capital) or a SICAF (an investment company with fixed capital) established in Italy (the "**Fund**") and either (i) the Fund or (ii) their manager is subject to the supervision of a regulatory authority, and the relevant Notes are held by an authorised intermediary, as clarified by the Italian tax authorities through Circular No. 11/E of 28 March 2012, Interest accrued during the holding period on the Notes will not be subject to *imposta sostitutiva*, but must be included in the management results of the Fund. The Fund will not be subject to taxation on such results but a withholding tax of 26 per cent. will apply, in certain circumstances, to distributions made in favour of unitholders or shareholders (the "**Collective Investment Fund Tax**").

Where an Italian resident Noteholder is a pension fund (subject to the regime provided for by Article 17 of the Legislative Decree No. 252 of 5 December 2005, the "**Pension Fund**") and the Notes are deposited with an authorised intermediary, Interest relating to the Notes and accrued during the holding period will not be subject to *imposta sostitutiva*, but must be included in the result of the relevant portfolio accrued at the end of the tax period, to be subject to a 20 per cent. substitute tax on the increase in value of the managed assets accrued at the end of each tax year (which increase would include Interest accrued on the Notes).

# Non Italian resident Noteholders

Where the Noteholder is a non Italian resident, without a permanent establishment in Italy to which the Notes are connected, an exemption from the *imposta sostitutiva* applies provided that the non Italian resident beneficial owner is either:

(a) resident for tax purposes in a state or territory which allows an adequate exchange of information with the Italian tax authorities and listed in the Decree of the Minister of Finance dated 4<sup>th</sup> September, 1996, as amended and supplemented from time to time (the "White List"). According to Article 11, par. 4, let. c) of Decree 239, the White List will be updated every six months period. In absence of the issuance of the new White List, reference has to be made to the Italian Ministerial Decree dated 4th September, 1996 as amended from time to time; or

- (b) an international body or entity set up in accordance with international agreements which have entered into force in Italy; or
- (c) a Central Bank or an entity which manages, *inter alia*, the official reserves of a foreign State; or
- (d) an institutional investor which is resident in a country which allows for a satisfactory exchange of information with Italy, even if it does not possess the status of a taxpayer in its own country of residence.

In order to ensure gross payment, non-resident investors must be the beneficial owners of payments of Interest on the Notes and (a) deposit, directly or indirectly, the Notes, the receipts or the coupons with a bank or a SIM or a permanent establishment in Italy of a non-resident bank or SIM or with a non-resident operator of a clearing system having appointed as its agent in Italy for the purposes of Decree 239 a resident bank or SIM or a permanent establishment in Italy or a non-resident bank or SIM which are in contact via computer with the Ministry of Economy and Finance and (b) file with the relevant depositary, prior to or concurrently with the deposit of the Notes, a statement (*autocertificazione*) of the relevant Noteholder, to be provided only once, until revoked or withdrawn, in which the Noteholder declares to be resident, for tax purposes, in one of the above-mentioned White List states. Such statement, which is not requested for international bodies or entities set up in accordance with international agreements which have entered into force in Italy or in the case of foreign Central Banks or entities which manage, *inter alia*, the official reserves of a foreign State, must comply with the requirements set forth by Ministerial Decree of 12 December 2001, as subsequently amended.

The *imposta sostitutiva* will be applicable at the rate of 26 per cent. to Interest paid to Noteholders who do not qualify for the exemption.

Noteholders who are subject to the substitute tax might, nevertheless, be eligible for a total or partial relief under an applicable tax treaty between the Republic of Italy and the country of residence of the relevant Noteholder.

#### Atypical Securities

Interest payments relating to Notes that are not deemed to be bonds (*obbligazioni*) or debentures similar to bonds (*titoli similari alle obbligazioni*) pursuant to Article 44 of Presidential Decree No. 917 of 22 December 1986 may be subject to a withholding tax, levied at the rate of 26 per cent. For this purpose, debentures similar to bonds are securities that incorporate an unconditional obligation to pay, at maturity, an amount not lower than their nominal value.

Subject to certain limitations and requirements (including a minimum holding period), Italian resident individuals not acting in connection with an entrepreneurial activity may be exempt from any income taxation, including the withholding tax, on interest, premium and other income relating to the Notes if such Notes are included in a long term savings account (*piano di risparmio a lungo termine*) that meets the requirements set forth in Article 1(100-114) of the Finance Act 2017.

Where the Noteholder is (a) an Italian individual engaged in an entrepreneurial activity to which the Notes are connected, (b) an Italian company or a similar Italian commercial entity, (c) a permanent establishment in Italy of a foreign entity, (d) an Italian commercial partnership or (e) an Italian commercial private or public institution, such withholding tax is a provisional withholding tax. In all other cases, including when the Noteholder is a non-italian resident, the withholding tax is a final withholding tax. For non Italian resident Noteholders, the withholding tax rate may be reduced by any applicable tax treaty.

#### Capital gains tax

Any gain obtained from the sale or redemption of the Notes would be treated as part of the taxable income (and, in certain circumstances, depending on the "status" of the Noteholder, also as part of the net value of production for IRAP purposes) if realised by an Italian company or a similar commercial entity (including the Italian permanent establishment of foreign entities to which the Notes are connected) or Italian resident individuals engaged in an entrepreneurial activity to which the Notes are connected.

Pursuant to Decree No. 461, where an Italian resident Noteholder is (i) an individual holding the Notes not in connection with an entrepreneurial activity; (ii) a non-commercial partnership; (iii) a non-

commercial private or public institution, any capital gain realised by such Noteholder from the sale or redemption of the Notes would be subject to an *imposta sostitutiva* on capital gains, levied at the current rate of 26 per cent. Noteholders may set off losses with gains.

In respect of the application of the *imposta sostitutiva*, taxpayers may opt for one of the three regimes described below.

Under the tax declaration regime (*regime della dichiarazione*), which is the default regime for Italian resident individuals not engaged in entrepreneurial activity to which the Notes are connected, the *imposta sostitutiva* on capital gains will be chargeable, on a cumulative basis, on all capital gains, net of any incurred capital loss, realised by the Italian resident individual Noteholder holding Notes not in connection with an entrepreneurial activity pursuant to all sales or redemptions of the Notes carried out during any given tax year. Italian resident individuals holding Notes not in connection with an entrepreneurial activity must indicate the overall capital gains realised in any tax year, net of any relevant incurred capital loss, in the annual tax return and pay *imposta sostitutiva* on such gains together with any balance of income tax due for such year. Capital losses in excess of capital gains may be carried forward against capital gains realised in any of the four succeeding tax years. Pursuant to Law Decree No. 66 of 24 April 2014, as converted into law with amendments by Law No. 89 of 23 June 2014 ("**Decree 66**"), capital losses realized from 1st January 2012 to 30th June 2014 may be offset against capital gains of the same nature realized after 30th June 2014 for an overall amount of 76.92 per cent. of the same capital losses.

As an alternative to the tax declaration regime, Italian resident individual Noteholders holding Notes not in connection with an entrepreneurial activity, Italian resident partnerships not carrying out commercial activities and Italian private or public institutions not carrying out mainly or exclusively commercial activities may elect to pay the imposta sostitutiva separately on capital gains realised on each sale or redemption of the relevant Notes (the "risparmio amministrato" regime). Such separate taxation of capital gains is allowed subject to (a) the Notes being deposited with Italian banks, SIMs or certain authorised financial intermediaries (including permanent establishments in Italy of foreign intermediaries); and (b) an express election for the *risparmio amministrato* regime being punctually made in writing by the relevant Noteholder. The depository is responsible for accounting for *imposta sostitutiva* in respect of capital gains realised on each sale or redemption of Notes (as well as in respect of capital gains realised upon the revocation of its mandate), net of any incurred capital loss, and is required to pay the relevant amount to the Italian tax authorities on behalf of the taxpayer, deducting a corresponding amount from the proceeds to be credited to the Noteholder or using funds provided by the Noteholder for this purpose. Under the risparmio amministrato regime, where a sale or redemption of Notes results in a capital loss, such loss may be deducted from capital gains subsequently realised, within the same securities management, in the same tax year or in the following tax years up to the fourth. Under the risparmio amministrato regime, the Noteholder is not required to declare the capital gains in the annual tax return. Pursuant to Decree 66, capital losses realised from 1st January 2012 to 30th June 2014 may be offset against capital gains of the same nature realised after 30th June 2014 for an overall amount of 76.92 per cent. of the same capital losses.

Any capital gains realised by Italian resident individuals holding Notes not in connection with an entrepreneurial activity, Italian resident partnerships not carrying out commercial activities and Italian private or public institutions not carrying out mainly or exclusively commercial activities who have entrusted the management of their financial assets, including Notes, to an authorised intermediary and have opted for the so called "*risparmio gestito*" regime will be included in the computation of the annual increase in value of the managed assets accrued, even if not realised, at year end, subject to a 26 per cent. substitute tax, to be paid by the managing authorised intermediary. Under the *risparmio gestito* regime, any depreciation of the managed assets accrued at year end may be carried forward against increase in value of the managed assets accrued in any of the four succeeding tax years. Under the *risparmio gestito* regime, the Noteholder is not required to declare the capital gains realised in the annual tax return. Pursuant to Decree 66, depreciations of the managed assets registered from 1st January 2012 to 30th June, 2014 may be offset against any subsequent increase in value accrued as of 1st July 2014 for an overall amount of 76.92 per cent. of the same depreciations in value.

Subject to certain limitations and requirements (including a minimum holding period), Italian resident individuals not engaged in an entrepreneurial activity may be exempt from Italian capital gain taxes, including the *imposta sostitutiva*, on capital gains realised upon sale or redemption of the Notes if the

Notes are included in a long-term savings account (*piano di risparmio a lungo termine*) that meets the requirements set forth in Article 1(100-114) of Finance Act 2017.

Any capital gains realised by a Noteholder who is an Italian Real Estate Fund will be subject neither to *imposta sostitutiva* nor to any other income tax at the level of the Real Estate Fund.

Any capital gains realised by a Noteholder which is a Fund will not be subject to *imposta sostitutiva*, but will be included in the result of the relevant portfolio. Such result will not be taxed with the Fund, but subsequent distributions in favour of unitholders or shareholders may be subject to the Collective Investment Fund Tax.

Any capital gains realised by a Noteholder which is an Italian Pension Fund will be included in the result of the relevant portfolio accrued at the end of the tax period, to be subject to the 20 per cent.

Capital gains realised by non-Italian resident Noteholders, not having a permanent establishment in Italy to which the Notes are connected, from the sale or redemption of Notes issued by an Italian resident issuer and traded on regulated markets are neither subject to the *imposta sostitutiva* nor to any other Italian income tax.

Capital gains realised by non Italian resident Noteholders from the sale, early redemption or redemption of Notes not traded on regulated markets are not subject to the *imposta sostitutiva*, provided that the effective beneficiary: (a) is resident, for tax purposes, in a country which allows for a satisfactory exchange of information with Italy and listed in the White List, or (b) is an international entity or body set up in accordance with international agreements which have entered into force in Italy; or (c) is a Central Bank or an entity which manages, *inter alia*, the official reserves of a foreign State; or (d) is an institutional investor which is resident in a country which allows for a satisfactory exchange of information with Italy, even if it does not possess the status of a taxpayer in its own country of residence. If non-Italian resident Noteholder without a permanent establishment in Italy to which the Notes are effectively connected, elect for the *risparmio amministrato* regime or are subject to the *risparmio gestito* regime, exemption from Italian capital gains tax will apply upon condition that they file in time with the authorised financial intermediary an appropriate declaration (*autocertificazione*) stating that they meet the requirement indicated above.

If none of the conditions above is met, capital gains realised by non Italian resident Noteholders from the sale or redemption of Notes issued by an Italian resident issuer not traded on regulated markets are subject to the *imposta sostitutiva* at the current rate of 26 per cent. In any event, non Italian resident individuals or entities without a permanent establishment in Italy to which the Notes are connected, that may benefit from a double taxation treaty with Italy providing that capital gains realised upon the sale, early redemption or redemption of Notes are to be taxed only in the country of tax residence of the recipient, will not be subject to *imposta sostitutiva* in Italy on any capital gains realised upon the sale, early redemption or redemption of Notes.

# Inheritance and gift taxes

Pursuant to Law Decree No. 262 of 3 October 2006, converted into Law No. 286 of 24 November 2006, as subsequently amended, the transfers of any valuable asset (including shares, bonds or other securities) as a result of death or donation are taxed as follows:

- (a) transfers in favour of spouses and direct descendants or direct ancestors are subject to an inheritance and gift tax applied at a rate of 4 per cent. on the value of the inheritance or the gift exceeding, for each beneficiary, €1,000,000;
- (b) transfers in favour of relatives to the fourth degree or relatives in law to the third degree, are subject to an inheritance and gift tax applied at a rate of 6 per cent. on the entire value of the inheritance or the gift. Transfers in favour of brothers/sisters are subject to the 6 per cent. inheritance and gift tax on the value of the inheritance or the gift exceeding, for each beneficiary, €100,000; and
- (c) any other transfer is, in principle, subject to an inheritance and gift tax applied at a rate of 8 per cent. on the entire value of the inheritance or the gift.

If the transfer is made in favour of persons with severe disabilities, the tax is levied at the rate mentioned above in (a), (b) and (c) on the value exceeding, for each beneficiary,  $\leq 1,500,000$ .

# Transfer tax

Following the repeal of the Italian transfer tax, contracts relating to the transfer of securities are subject to the following registration tax: (i) public deeds and notarised deeds are subject to fixed registration tax at a rate of  $\leq 200.00$ ; (ii) private deeds are subject to registration tax only in the case of use or voluntary registration.

#### Stamp duty

Pursuant to Article 13 par. 2/ter of the tariff Part I attached to Presidential Decree No. 642 of 26th October, 1972, a proportional stamp duty applies on an annual basis to the periodic reporting communications sent by financial intermediaries to their clients for the Notes deposited in Italy. The stamp duty applies at a rate of 0.20 per cent. and cannot exceed  $\leq 14,000$  for taxpayers other than individuals; this stamp duty is determined on the basis of the market value or, if no market value figure is available, the nominal value or redemption amount of the Notes held.

Based on the wording of the law and the implementing decree issued by the Italian Ministry of Economy on 24 May 2012, the stamp duty applies to any investor who is a client (as defined in the regulations issued by the Bank of Italy on 20 June 2012) of an entity that exercises in any form a banking, financial or insurance activity within the Italian territory. The communication is deemed to be sent to the customers at least once a year, even for instruments for which it is not mandatory. In case of reporting periods of less than 12 months, the stamp duty is payable based on the period accounted.

# Wealth Tax on securities deposited abroad

Pursuant to Article 19(18) of Decree No. 201 of 6 December 2011, Italian resident individuals holding the Notes outside the Italian territory are required to pay an additional tax at a rate of 0.20 per cent.

This tax is calculated on the market value of the Notes at the end of the relevant year or, if no market value figure is available, the nominal value or the redemption value of such financial assets held outside the Italian territory. Taxpayers are entitled to an Italian tax credit equivalent to the amount of wealth taxes paid in the State where the financial assets are held (up to an amount equal to the Italian wealth tax due).

# Tax monitoring obligations

According to the Law Decree No. 167 of 28 June 1990, converted with amendments into Law No. 227 of 4 August 1990, as amended from time to time, individuals, non-profit entities and certain partnerships (*società semplici* or similar partnerships in accordance with Article 5 of Presidential Decree No. 917 of 22 December 1986) resident in Italy for tax purposes, under certain conditions, are required to report for tax monitoring purposes in their yearly income tax return (or, in case the income tax return) the amount of investments directly or indirectly held abroad. The disclosure requirements are not due if the foreign financial investments (including the Notes) are held through an Italian resident intermediary or are only comprised of deposits and/or bank accounts having an aggregate value not exceeding an  $\{0,000\}$  threshold throughout the year.

# The proposed financial transactions tax ("FTT")

On 14 February 2013, the European Commission published a proposal (the "**Commission's proposal**") for a Directive for a common FTT in Belgium, Germany, Estonia, Greece, Spain, France, Italy, Austria, Portugal, Slovenia and Slovakia (each other than Estonia, a "**participating Member State**"). However, Estonia has ceased to participate.

The Commission's proposal has very broad scope and could, if introduced, apply to certain dealings in the Notes (including secondary' market transactions) in certain circumstances. The issuance and subscription of Notes should, however, be exempt.

Under the Commission's proposal, FTT could apply in certain circumstances to persons both within and outside of the participating Member States. Generally, it would apply to certain dealings in the Notes

where at least one party is a financial institution, and at least one party is established in a participating Member State. A financial institution may be, or be deemed to be, "established" in a participating Member State in a broad range of circumstances, including (a) by transacting with a person established in a participating Member State or (b) where the financial instrument which is subject to the dealings is issued in a participating Member State.

However, the FTT proposal remains subject to negotiation between participating Member States. It may therefore be altered prior to any implementation, the timing of which, remains unclear. Additional EU Member States may decide to participate.

Prospective holders of the Notes are advised to seek their own professional advice in relation to the FTT.

# FATCA

Pursuant to certain provisions of the U.S. Internal Revenue Code of 1986, commonly known as FATCA, a "foreign financial institution" may be required to withhold on certain payments it makes ("foreign passthru payments") to persons that fail to meet certain certification, reporting, or related requirements. A number of jurisdictions (including the jurisdiction of the Issuer) have entered into, or have agreed in substance to, intergovernmental agreements with the United States to implement FATCA ("IGAs"), which modify the way in which FATCA applies in their jurisdictions. Certain aspects of the application of the FATCA provisions and IGAs to instruments such as the Notes, including whether withholding would ever be required pursuant to FATCA or an IGA with respect to payments on instruments such as the Notes, are uncertain and may be subject to change. Even if withholding would be required pursuant to FATCA or an IGA with respect to payments on instruments such as the Notes, such withholding would not apply prior to 1 January 2019. However, if additional notes (as described under "Terms and Conditions—Further Issues") that are not distinguishable from previously issued Notes are issued after the expiration of the grandfathering period and are subject to withholding under FATCA, then withholding agents may treat all Notes, including the Notes offered prior to the expiration of the grandfathering period, as subject to withholding under FATCA. Holders should consult their own tax advisors regarding how these rules may apply to their investment in the Notes.

TO ENSURE COMPLIANCE WITH IRS CIRCULAR 230, EACH TAXPAYER IS HEREBY NOTIFIED THAT: (A) ANY TAX DISCUSSION HEREIN IS NOT INTENDED OR WRITTEN TO BE USED, AND CANNOT BE USED BY THE TAXPAYER FOR THE PURPOSE OF AVOIDING U.S. FEDERAL INCOME TAX PENALTIES THAT MAY BE IMPOSED ON THE TAXPAYER; (B) ANY SUCH TAX DISCUSSION WAS WRITTEN TO SUPPORT THE PROMOTION OR MARKETING OF THE TRANSACTIONS OR MATTERS ADDRESSED HEREIN; AND (C) THE TAXPAYER SHOULD SEEK ADVICE BASED ON THE TAXPAYER'S PARTICULAR CIRCUMSTANCES FROM AN INDEPENDENT TAX ADVISER.

#### SUBSCRIPTION AND SALE

Notes may be sold from time to time by the Issuer to any one or more of Banca Akros S.p.A. - Gruppo Banco BPM, Banca IMI S.p.A., Banco Bilbao Vizcaya Argentaria, S.A., Banco Santander, S.A., Barclays Bank PLC, Bayerische Landesbank, BNP Paribas, Citigroup Global Markets Limited, Commerzbank Aktiengesellschaft, Crédit Agricole Corporate and Investment Bank, Deutsche Bank AG, London Branch, Goldman Sachs International, HSBC Bank plc, ING Bank N.V., J.P. Morgan Securities plc, Mediobanca, Banca di Credito Finanziario S.p.A., Merrill Lynch International, MUFG Securities EMEA plc, Morgan Stanley & Co. International plc, MPS Capital Services S.p.A., Natixis, Société Générale, SMBC Nikko Capital Markets Limited, The Royal Bank of Scotland plc (trading as NatWest Markets), Unione di Banche Italiane S.p.A. and UniCredit Bank AG (the "Dealers"). The arrangements under which Notes may from time to time be agreed to be sold by the Issuer to, and subscribed by, Dealers are set out in a Dealer Agreement dated 13 June 2017 (the "Dealer Agreement") and made between the Issuer and the Dealers. If in the case of any Tranche of Notes the method of distribution is an agreement between the Issuer and a single Dealer for that Tranche to be issued by the Issuer and subscribed by that Dealer, the method of distribution will be described in the relevant Final Terms as "Non-Syndicated" and the name of that Dealer and any other interest of that Dealer which is material to the issue of that Tranche beyond the fact of the appointment of that Dealer will be set out in the relevant Final Terms. If in the case of any Tranche of Notes the method of distribution is an agreement between the Issuer and more than one Dealer for that Tranche to be issued by the Issuer and subscribed by those Dealers, the method of distribution will be described in the relevant Final Terms as "Syndicated", the obligations of those Dealers to subscribe the relevant Notes will be joint and several and the names and addresses of those Dealers and any other interests of any of those Dealers which is material to the issue of that Tranche beyond the fact of the appointment of those Dealers (including whether any of those Dealers has also been appointed to act as Stabilising Manager in relation to that Tranche) will be set out in the relevant Final Terms.

Any such agreement will, *inter alia*, make provision for the form and terms and conditions of the relevant Notes, the price at which such Notes will be subscribed by the Dealer(s) and the commissions or other agreed deductibles (if any) payable or allowable by the Issuer in respect of such subscription. The Dealer Agreement makes provision for the resignation or termination of appointment of existing Dealers and for the appointment of additional or other Dealers either generally in respect of the Programme or in relation to a particular Tranche of Notes.

# **United States of America**: *Regulation S Category 2; TEFRA D or TEFRA C as specified in the relevant Final Terms or neither if TEFRA is specified as not applicable in the relevant Final Terms.*

The Notes have not been and will not be registered under the Securities Act and may not be offered or sold within the United States or to, or for the account or benefit of, U.S. persons except in certain transactions exempt from the registration requirements of the Securities Act. Terms used in this paragraph have the meanings given to them by Regulation S.

The Notes are subject to U.S. tax law requirements and may not be offered, sold or delivered within the United States or its possessions or to a United States person, except in certain transactions permitted by U.S. tax regulations. Terms used in this paragraph have the meanings given to them by the United States Internal Revenue Code and regulations thereunder.

Each Dealer has agreed and each further Dealer appointed under the Programme will be required to agree that, except as permitted by the Dealer Agreement, it will not offer, sell or deliver Notes, (i) as part of their distribution at any time or (ii) otherwise until 40 days after the completion of the distribution of the Notes comprising the relevant Tranche, as certified to the Fiscal Agent or the Issuer by such Dealer (or, in the case of a sale of a Tranche of Notes to or through more than one Dealer, by each of such Dealers as to the Notes of such Tranche purchased by or through it, in which case the Fiscal Agent or the Issuer shall notify each such Dealer when all such Dealers have so certified) within the United States or to, or for the account or benefit of, U.S. persons, and such Dealer will have sent to each dealer to which it sells Notes during the distribution compliance period relating thereto a confirmation or other notice setting forth the restrictions on offers and sales of the Notes within the United States or to, or for the account or benefit of, U.S. persons.

In addition, until 40 days after the commencement of the offering of Notes comprising any Tranche, any offer or sale of Notes within the United States by any dealer (whether or not participating in the offering) may violate the registration requirements of the Securities Act.

- (b) the expression an "offer" includes the communication in any form and by any means of sufficient information on the terms of the offer and the Notes to be offered so as to enable an investor to decide to purchase or subscribe the Notes.

Prior to 1 January 2018, and from that date if the Final Terms in respect of any Notes specifies "Prohibition of Sales to EEA Retail Investors" as "Not Applicable", in relation to each Member State of the European Economic Area which has implemented the Prospectus Directive (each, a "**Relevant Member State**"), each Dealer has represented, warranted and agreed, and each further Dealer appointed under the Programme will be required to represent, warrant and agree, that with effect from and including the date on which the Prospectus Directive is implemented in that Relevant Member State (the "**Relevant Implementation Date**") it has not made and will not make an offer of Notes which are the subject of the offering contemplated by a Drawdown Prospectus, as the case may be) to the public in that Relevant Member State except that it may, with effect from and including the Relevant Implementation Date, make an offer of such Notes to the public in that Relevant Member State:

- (c) **Qualified investors:** at any time to any legal entity which is a qualified investor as defined in the Prospectus Directive;
- (d) *Fewer than 150 offerees*: at any time to fewer than 150 natural or legal persons (other than qualified investors as defined in the Prospectus Directive), subject to obtaining the prior consent of the relevant Dealer or Dealers nominated by the Issuer for any such offer; or
- (e) *Other exempt offers*: at any time in any other circumstances falling within Article 3(2) of the Prospectus Directive.

**provided that** no such offer of Notes referred to in (a) to (c) above shall require the Issuer or any Dealer to publish a prospectus pursuant to Article 3 of the Prospectus Directive or supplement a prospectus pursuant to Article 16 of the Prospectus Directive.

For the purposes of this provision, the expression an "offer of Notes to the public" in relation to any Notes in any Relevant Member State means the communication in any form and by any means of sufficient information on the terms of the offer and the Notes to be offered so as to enable an investor to decide to purchase or subscribe the Notes, as the same may be varied in that Member State by any measure implementing the Prospectus Directive in that Member State, the expression "**Prospectus Directive**" means Directive 2003/71/EC (as amended by Directive 2010/73/EU), and includes any relevant implementing measure in the Relevant Member State.

## Selling Restrictions Addressing Additional United Kingdom Securities Laws

Each Dealer has represented, warranted and agreed (and each further Dealer appointed under the Programme will be required to represent, warrant and agree) that:

- (a) *No deposit-taking*: in relation to any Notes having a maturity of less than one year:
  - (i) it is a person whose ordinary activities involve it in acquiring, holding, managing or disposing of investments (as principal or agent) for the purposes of its business; and:
  - (ii) it has not offered or sold and will not offer or sell any Notes other than to persons:

#### Selling Restrictions Addressing Additional French Securities Laws

Each of the Dealers and the Issuer has represented, agreed and warranted (and each further Dealer appointed under the Programme will be required to further represent, agree and warrant) that it has not offered or sold and will not offer or sell, directly or indirectly, Notes to the public in France, and it has not distributed or caused to be distributed and will not distribute or cause to be distributed to the public in France, this Base Prospectus, the relevant Final Terms or any other offering material relating to the Notes and such offers, sales and distributions have been and will be made in France only to (a) providers of

Other persons into whose hands this Base Prospectus, any Final Terms or a Drawdown Prospectus comes are required by the Issuer and the Dealers to comply with all applicable laws and regulations in each country or jurisdiction in or from which they purchase, offer, sell or deliver Notes or possess, distribute or publish this Base Prospectus, any Final Terms or a Drawdown Prospectus are required by the Issuer and the Dealers to comply with all applicable laws and regulations in each country or jurisdiction in or from which they purchase, offer, sell or deliver Notes or possess, distribute or publish this Base Prospectus, any Final Terms or a Drawdown Prospectus or any related offering material, in all cases at their own expense.

Other than with respect to the admission to listing, trading and/or quotation by such one or more competent authorities, stock exchanges and/or quotation systems as may be specified in the Final Terms, no action has been or will be taken in any country or jurisdiction by the Issuer or the Dealers that would permit a public offering of Notes, or possession or distribution of any offering material in relation thereto, in any country or jurisdiction for that purpose is required. Persons into whose hands this Base Prospectus or any Final Terms comes are required by the Issuer and the Dealers to comply with all applicable laws and regulations in each country or jurisdiction in or from which they purchase, offer, sell or deliver Notes or have in their possession or distribute such offering material, in all cases at their own expense.

The Dealer Agreement provides that the Dealers shall not be bound by any of the restrictions relating to any specific jurisdiction (set out above) to the extent that such restrictions shall, as a result of change(s) or change(s) in official interpretation, after the date hereof, of applicable laws and regulations, no longer be applicable but without prejudice to the obligations of the Dealers described in the paragraph headed "*General*" above.

None of the Issuer and the Dealers represents that Notes may at any time lawfully be sold in compliance with any applicable registration or other requirements in any jurisdiction, or pursuant to any exemption available thereunder, or assumes any responsibility for facilitating such sale.

Selling restrictions may be supplemented or modified with the agreement of the Issuer. Any such supplement or modification may be set out in a supplement to this Base Prospectus.

## GENERAL INFORMATION

#### Listing and admission to trading

Application has also been made for Notes issued under the Programme to be admitted to trading on the regulated market of the Irish Stock Exchange and to be listed on the official list of the Irish Stock Exchange.

However, Notes may be issued pursuant to the Programme which are admitted to listing, trading and/or quotation by such competent authority, stock exchange and/or quotation system as the Issuer(s) and the relevant Dealer(s) may agree or which are not admitted to listing, trading and/or quotation by any competent authority, stock exchange and/or quotation system.

The Central Bank of Ireland may at the request of the Issuer, send to the competent authority of another European Economic Area Member State (i) a copy of this Base Prospectus; and (ii) an Attestation Certificate.

#### Authorisation

The update of the Programme was authorised by a resolution of the Board of Directors of the Issuer dated 21 April 2017. The Issuer has obtained or will obtain from time to time all necessary consents, approvals and authorisations in connection with the issue and performance of the Notes.

#### Legal and Arbitration Proceedings

There are no governmental, legal or arbitration proceedings, (including any such proceedings which are pending or threatened, of which the Issuer is aware), which may have, or have had during the 12 months prior to the date of this Base Prospectus, a significant effect on the financial position or profitability of the Issuer or the Group.

#### Significant/Material Change

Since 31 December 2016, there has been no significant change in the financial or trading position of the Issuer or the Group and since 31 December 2016 there has been no material adverse change in the prospects of the Issuer or the Issuer and its Subsidiaries.

# Auditors

The consolidated financial statements of the Ferrovie dello Stato Italiane Group as of and for the years ended December 31, 2015 and December 31, 2016, incorporated by reference in this Base Prospectus, have been audited by KPMG S.p.A, independent auditors, as stated in their reports.
