

Fujitsu Production Scanner (fi-6800, fi-5850) End User Trade-in Terms and Conditions

1. The “Fujitsu Production Scanner (fi-6800, fi-5850) End User Trade-in Promotion” (“Promotion”) is provided by PFU (EMEA) Limited (PFUE), ultimately a wholly owned subsidiary of Fujitsu Limited, Japan.
2. The Promotion is available to end user customers located in the United Kingdom; and does not apply if the product will be resold.
3. The Promotion is valid for eligible Fujitsu Scanner purchases and Fujitsu Scanner + Assurance Program Bundle purchases as detailed in Clause 28 (“Qualifying Products”) purchased by an end-user (“Participant”) [organisation] between December 1st 2015 and February 29th 2016 (“Promotion Period”).
4. The Promotion is valid only on new Qualifying Products purchased and invoiced directly from a qualifying Fujitsu Imaging Partner or Retailer. The Promotion is not open to employees of PFUE or any Fujitsu group company or their immediate family members, Fujitsu Partners, their respective agents, distribution partners, participating stockists or anyone professionally connected with the Promotion (or members of their family or household).
5. To qualify for the trade-in allowance as detailed in Clause 28 (“Trade-in Allowance”) the Participant must purchase a Qualifying Product during the Promotion Period and trade in one of the eligible Scanner products (“Trade-in Products”) detailed in Clause 29 in full working condition.
6. The Trade-in Allowance is payable on condition that the Trade-in Product the Participant wants to trade-in is directly and verifiably connected to the purchase of a Qualifying Product.
7. The Promotion cannot be combined with any other PFUE promotional offer or special pricing agreements with PFUE.
8. In order to apply for the Promotion purchasers of Qualifying Products must visit <http://emea.fujitsu.com/fiseriespromo> to download the application form to provide the requested details.
9. The Trade-in Product must be located in the same country as the Participant claiming the Trade-in Allowance in respect of then.
10. The Participant is responsible for the de-installation of the Trade-in Product(s) and must properly prepare it/them for shipment. PFUE will pay for collection and recycling of

eligible Trade-in Product(s). Trade-in Products must be made available for collection from an entrance/exit door on the ground floor at street level.

11. On the agreed date, PFUE will dispatch a carrier to the address stated by the Participant in the application form. If it is not possible for the PFUE carrier to collect the Trade-in Product(s) on the agreed date, the carrier will contact the Participant to agree a new date. If the Trade-in Product(s) are not ready for collection on the agreed date and the PFUE carrier has to return on another day, the Participant will be charged any additional cost charged to PFUE by the carrier.
12. To ensure safe receipt of the Trade-in Product(s) it/they must be packed and secured in a sturdy cardboard box and packaging suitable for shipping.

BY SUBMITTING A CLAIM FOR A TRADE-IN ALLOWANCE UNDER THE PROMOTION YOU WARRANT THAT YOU ARE THE OWNER OF THE TRADE-IN PRODUCT AND ARE LEGALLY ENTITLED TO TRANSFER OWNERSHIP OF IT TO PFUE; OR THAT YOU HAVE OBTAINED EXPRESS PERMISSION FROM THE RIGHTFUL OWNER TO TRADE-IN THE TRADE-IN PRODUCT AND TRANSFER OWNERSHIP OF IT TO PFUE. IF YOU BREACH THIS WARRANTY YOU WILL INDEMNIFY PFUE AND ANY OTHER FUJITSU GROUP COMPANY AGAINST ANY CLAIMS, LIABILITIES, LOSSES, DAMAGES, PENALTIES, FINES COSTS OR EXPENSES SUFFERED OR INCURRED BY THEM RESULTING DIRECTLY OR INDIRECTLY FROM SUCH BREACH OF WARRANTY, INCLUDING WITHOUT LIMITATION ANY LEGAL OR OTHER PROFESSIONAL COSTS, ON A FULL INDEMNITY BASIS AND ANY CONSEQUENTIAL OR INDIRECT LOSSES.**
14. The delivery of the Trade-in Product to PFUE's designated carrier shall be final and effective to transfer ownership of such product to PFUE free and clear of all liens and encumbrances.
15. After collection, no Trade-in Product (including accessories/consumables) can be returned to the Participant.
16. If a Trade-in Product other than that stated in the registration form has been placed ready for collection and / or carried to the collection centre, PFUE is entitled to charge the Participant the costs incurred for its return, unless the error was obvious to PFUE or the carrier on collection.
17. The Trade-in Product(s) must match the details provided during the registration process. If they do not match, PFUE reserves the right not to pay any Trade-in Allowance or to debit the difference in Trade-in Allowance between the stated and actually received Trade-in Product where the Trade-in Allowance of the received product is less.
18. PFUE warrants environmentally friendly disposal of Trade-in Products.

19. Once the Trade-in Product has been collected the Participant must complete the trade-in claim form at <http://emea.fujitsu.com/fiseriespromo> ("Claim Form") and email this to cashback@uk.fujitsu.com. The Claim Form should be accompanied by the proof of collection document provided by PFUE's designated carrier ("Collection Receipt") and a proof of purchase in the form of an invoice for the Qualifying Product(s) from your Reseller. The proof of purchase from your Reseller must be dated within the Promotion Period and must be received by PFUE no later than 31 March 2016 ("Final Claim Date") in order for the claim to be validated and processed.
20. Claims for Trade-in Allowances will be responded to via an e-mail within fourteen (14) days of submission. PFUE is not responsible for invalid, incorrect, or unreachable e-mail addresses that are noted on the Claim Form. If a purchaser does not receive a response from PFUE after 15 days of submission the purchaser should contact cashback@uk.fujitsu.com.
21. All claims for a Trade-in Allowance must be made before the Final Claim Date . Any claims for the Promotion with incomplete, incorrect, or invalid information will be declined and any duplicate claims will be rejected. If incomplete, they must be completed and resubmitted to be processed. A claim is considered incomplete if:
 - Any information requested on the Claim Form, (for example: serial number of the Qualifying Products) is missing or incorrect;
 - A Proof of purchase document with a valid date of purchase of the Qualifying Products is not submitted by the Participant in accordance with these Terms.
 - A valid Collection Receipt is not submitted by the Participant in accordance with these Terms.
22. PFUE is not responsible or liable for any technical, hardware, software, server, website, or other failures or damage of any kind to the extent that this prevents the Participant from or otherwise obstructs him/her in participating in the Promotion.
23. PFUE may declare the Promotion void where it is taxed, regulated, prohibited or restricted by applicable law. The decisions of PFUE in respect of any and all aspects of the promotion will be final and binding.
24. Please allow 28 days from submission of your Claim Form for receipt of your Trade-in Allowance. Payment will be paid in the form of BACS Transfer. Payment will only be made to the original purchaser of the Qualifying Trade-in Product(s) as displayed on the proof of purchase.
25. Any tax liability arising on from or relating to the payment of a Trade-in Allowance is the Participants' responsibility.

27. Return of a Qualifying Trade-in Product(s) to the seller by or on behalf of the Participant following submission of a Claim Form will entitle PFUE to disqualify the Participant from the Promotion and stop payment of any Trade-in Allowance to the Participant. If Payment of the Trade-in Allowance has already been made, the Participant will immediately reimburse the full amount of any such payment to PFUE by BACS payment or such other means as PFUE may agree. PFUE retains the right to void any claim for a Trade-in Allowance if after investigation there is found to be a deviance in the supply chain from distributor to reseller to end user or on any other matter deemed by PFUE in its absolute discretion not to be in spirit of the offer.
