RESOLUTION NO. 2878.23

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING AND APPROVING THE PURCHASE OF COMPUTER EQUIPMENT FOR THE NEW CIVIC CENTER COMPLEX; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach, Florida (the "Town") wishes to provide adequate finishes, furniture and equipment (FF&E) to outfit the new Civic Center Complex; and

WHEREAS, one of the most critical components of the functionality of the staff is to provide the Information Technology (servers, and computing capabilities) for all workstations in the new Civic Center; and

WHEREAS, upon consultation with the Town's IT team, it was determined that the best course of action is to provide all workstations with one (1) laptop computer with docking station, two (2) stationary monitors on mounted arms, one (1) external keyboard and mouse, and a new robust server; and

WHEREAS, all equipment will come with extended warranties and insurance; and

WHEREAS, it is requested that the Town authorize the expenditure of \$150,000.00 as described in the attached Exhibit "A" for the purchase of the equipment; and

WHEREAS, the Town Council finds that it is in the best interest of the Town to proceed as indicated in this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above-stated recitals is hereby adopted and confirmed.

Section 2. Purchase Authorized. The expenditure of funds in an amount not to exceed \$150,000.00 for the purchase of computer equipment for the new Civic Center Complex is hereby authorized and approved.

Section 3. Implementation. That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
