This letter is regarding to your Centers for Disease Control and Prevention and Agency for Toxic Substances and Disease Registry (CDC/ATSDR) Freedom of Information Act (FOIA) request of August 18, 2019, assigned #19-01086-FOIA, for:

"The CDC/ATSDR FOIA Office provides monthly reports to CDC/ATSDR Management on FOIA Administration, FOIA Requests, and FOIA backlogs. I request a copy of the most recent five such monthly reports."

A responsive record in the form of two Excel spreadsheets is being released to you in part. After a careful review of all data, some information was withheld from release pursuant to 5 U.S.C. §552 Exemption (b)(6).

EXEMPTION 6

Exemption 6 protects information in personnel and medical files and similar files when disclosure would constitute a clearly unwarranted invasion of personal privacy. The information that has been withheld under Exemption 6 consists of personal information, such as names of private citizens, laboratory sample numbers, and other private information. We have determined that the individuals to whom this information pertains have a substantial privacy interest in withholding it.

In addition, please be informed that our FOIA office does not furnish a monthly report to management; instead, we post our monthly statistics on our FOIA website found at https://www.cdc.gov/od/foia/resources/references.htm.
