PART KAIMAI MAMAKU CONSERVATION PARK (OTS-113-17)

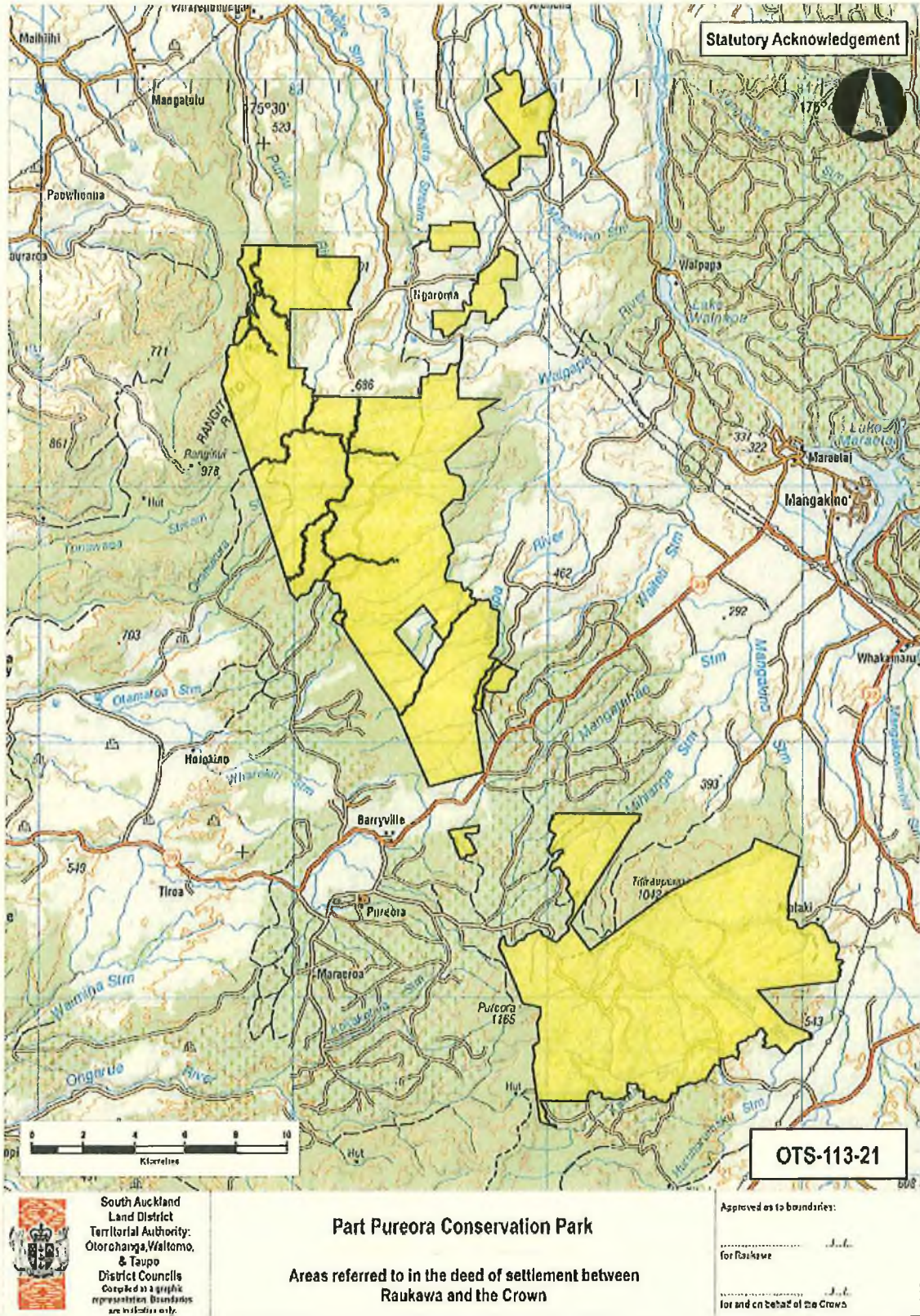

WHAKAMARU (SITE A AND SITE B) (OTS-113-07)

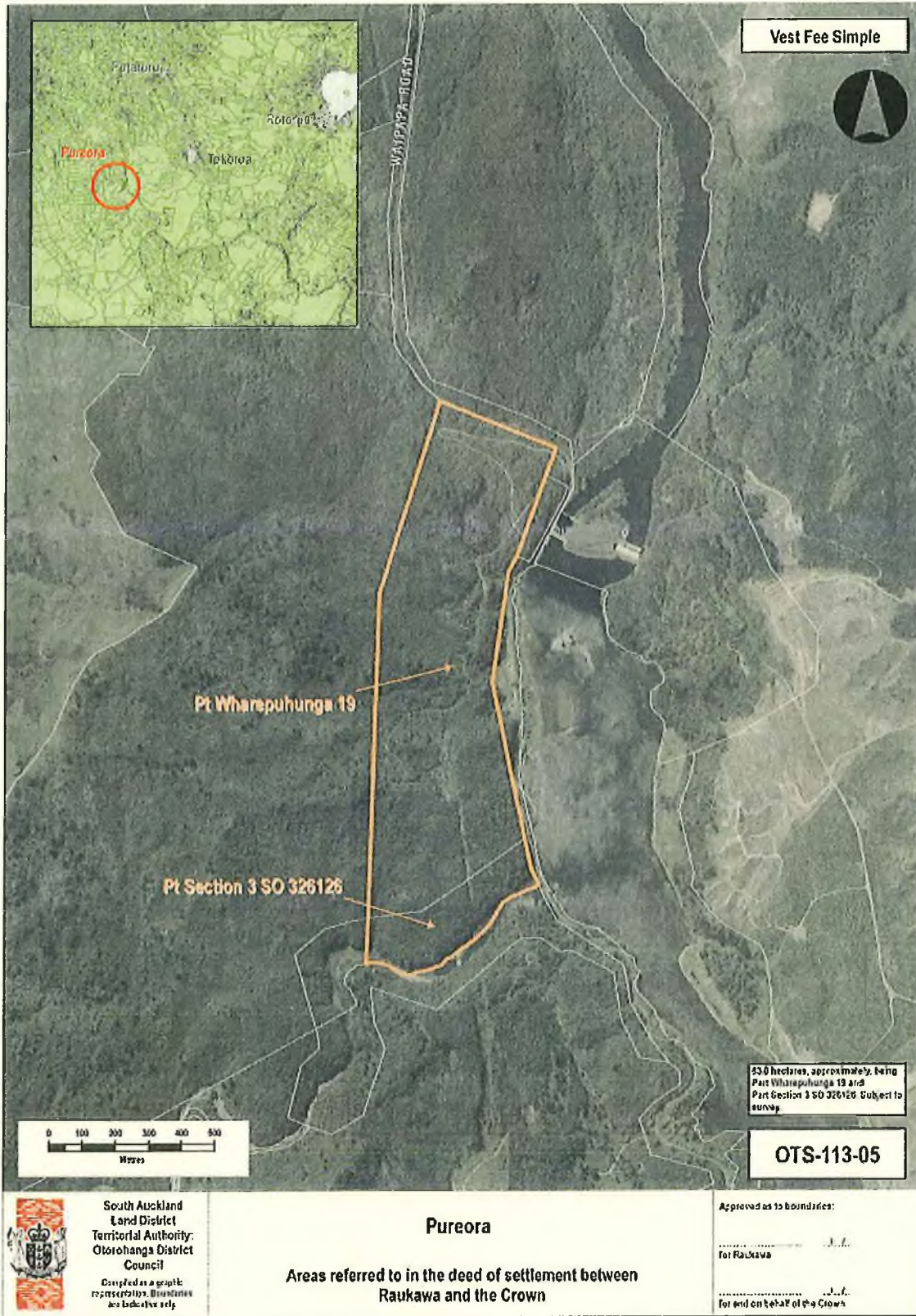

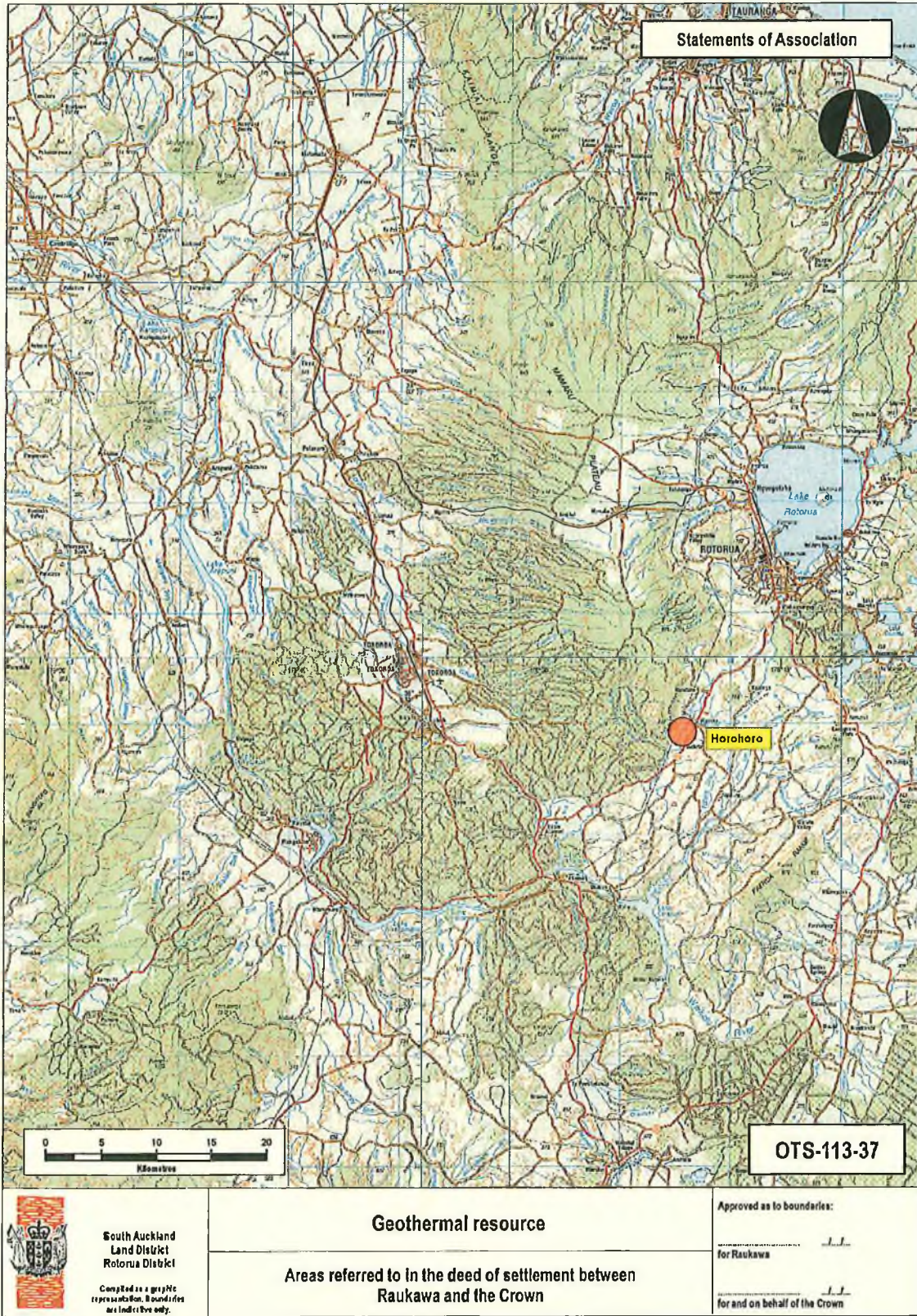

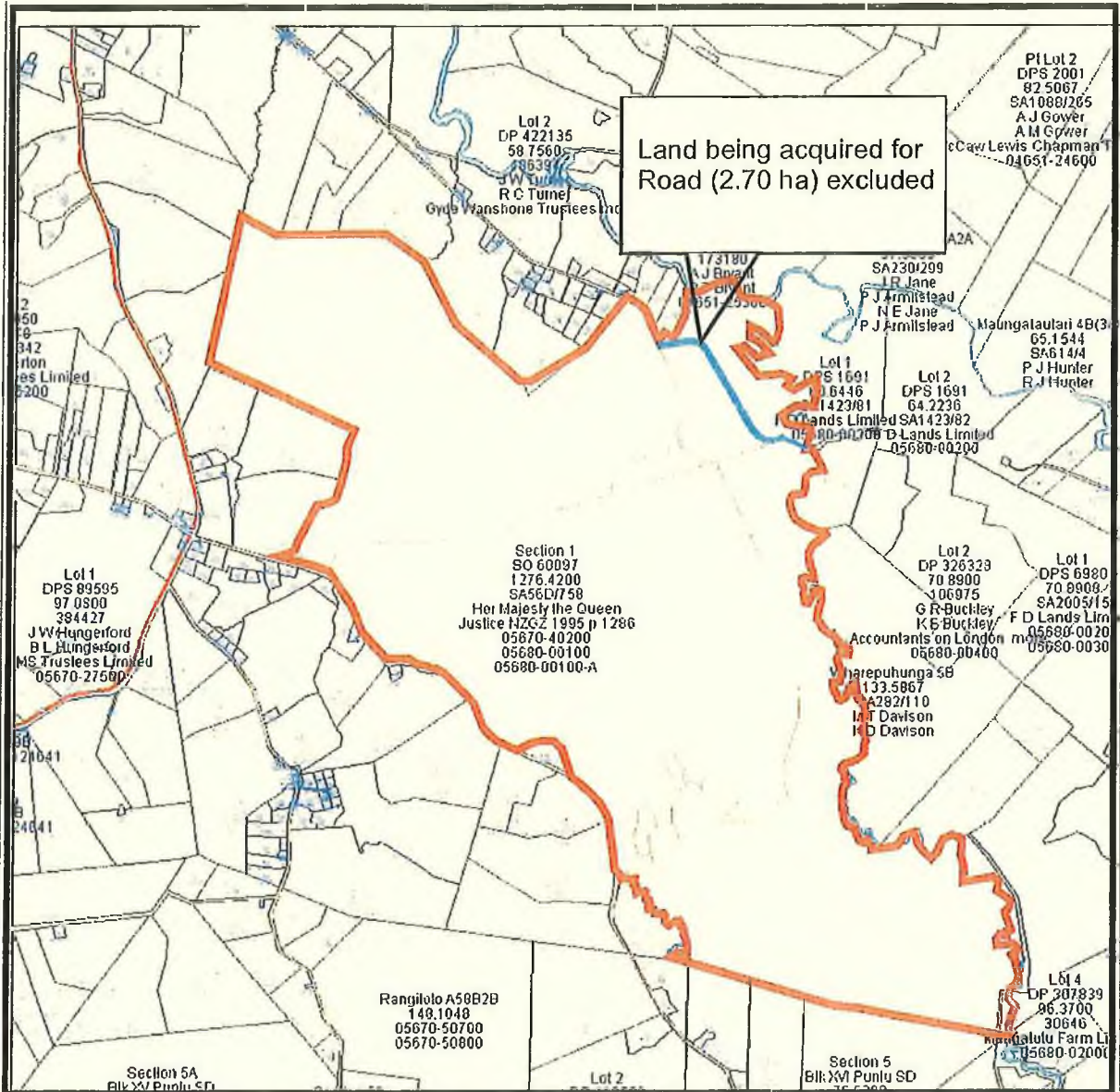
