The following items shall be incorporated as part of the Bid Documents. Items noted in bold are changes to the bid documents:

- 1. Bid Date is September 24, 2019 at 2:00 PM at the Maintenance Facility a 246 Education Drive. The Bidder is responsible for the bid arrival by this time. Electronic and FAX submittals are not accepted.
- 2. Bid bonds are not required for bids under \$500,000 and P & P Bonds are not required for contracts under \$300,000.
- 3. The project consists of roof replacements at the gymnasiums at Dana and Etowah Elementary Schools. Both roofs are barrel vault roofs at approximately 7,550 sf each.
- 4. A notice to proceed will be issued for September 30, 2019 and the substantial completion date is December 31, 2019. Extensions to this schedule are specified on the Bid Form. The extensions are modified as follows:
 - The precipitation forecast is revised from 40% to 30%
 - There is no tear-off. The existing roof will remain and will be overlaid.

The intent is once the contractor mobilizes on site, work will continue without unapproved delays.

- 5. The work will be coordinated with the student drop-off / pick up schedule and testing schedule.
- 6. Base bid shall be lump sum bid
 - Base bid is broken down with a separate cost between each roof
 - There are 3 alternates
 - There are 2 unit prices
- 7. The scope of the project was reviewed.
 - The existing roof deck is exposed wood boards at least 1-1/2" thick. Fasteners lengths shall be coordinated with the roof deck thickness so as to not penetrate through the deck
 - The roof is barrel vault shape and is over a gym
 - The existing roofing systems will remain and the specified TPO system will be installed as an overlay system. Both existing membranes are PVC with 1" of

fiberboard underlayment at Dana and 1/2" of fiberboard underlayment at Etowah. Attached is the Dana roof core report as requested.


- The gutters and downspouts will be replaced
- The wood fascia board at the eaves at Dana will be replaced including the metal fascia cladding
- The adjacent lower roofs are required to be protected. Contractor responsible for leaks, repairs, and damages
- The gyms will be occupied during reroofing work. Contractors will be responsible to dry mop the existing gym floor as needed to maintain clean conditions.
- Contractor responsible for securing roof water tight for overnight

8. Additional items:

- Delete the brackets noted on details 1,3/A301
- The gutters hangers can be either aluminum or stainless steel details 1.3/A301
- Provide splashblocks at the 3 downspouts on the adjacent roof at Dana
- Coordinate the 3 downspouts at the existing locations on the front side at Etowah
- 9. The sites were visited.




