

# Overview

This document describes the installation procedures for the following IBM Storwize<sup>®</sup> control enclosures. It also contains information to help you plan the system configuration. This information applies to the following machine type and model (MTM) numbers.

# Unpacking and verifying the contents

Before you start the installation process, ensure that the following items are available.

- Philips screw driver
- Box knife
- Flat-blade screw driver (optional)
- Three Ethernet cables

The control enclosure and the following related parts are included in one box. The enclosed inventory sheet lists the part numbers of the items that were ordered. Items, such as drives and networking adapters, are preinstalled inside each node canister.

- Control enclosure with the following components preinstalled:
  - Two node canisters with optional networking adapters, small form-factor pluggable transceivers (SFPs), and memory
  - Two power supply units (PSUs). The system supports AC or DC power supply units.
  - A combination of drives and drive blanks

The number of drives and drive blanks varies, according to the system model and the number of drives that were ordered. For example, if 12 SFF drives were ordered, the drives and 12 drive blanks are preinstalled in the 24-drive SFF control enclosure.

- Rail kit, which includes the left and right rails and springs, 8 securing M5 screws, and locating pins.
- Cables, if they were ordered, for the type of networking adapter that is installed in each node canister.
- Two power cables.



# Installing support rails for the system

Before you install a control enclosure, you must first install the support rails. The same rails are used for the control enclosures and the 2U expansion enclosures.

### Procedure

1. Locate the assembly kit (two rails, springs, and screws) that must be installed in the rack cabinet.



**Note:** For Network Equipment-Building System (NEBS) compliant installations, follow the requirements that are described in <u>Guidelines for NEBS compliance</u> on page 14.

2. Install a spring on the rail.



- a. Push one looped end of a spring over one stud on the inside of the rail.b. Stretch the spring slightly and push the other looped end of the spring onto the other stud on the inside of the rail.
- 3. On the front of the rack cabinet, identify two standard rack units (2U) of space in the rack where you want to install the support rails.
- 1 Upper rail-mounting bracket pin
- 2 Lower rail-mounting bracket pin
- **3** Rack mounting screw hole
- **4.** Ensure that the appropriate bracket pins are installed in the front and rear bracket of each rail.


Each rail comes with four medium pins preinstalled (two in the front bracket and two in the rear bracket). Large and small pins are provided separately. Use the pins that are appropriate for the mounting holes in your rack.

Mounting holes	Bracket pins
Round, unthreaded	Use the preinstalled medium pins.
Round, threaded	Unscrew the medium pins and replace them with the smaller pins that are supplied with the rails.
Square	Unscrew the medium pins and replace them with the large pins that are supplied with the rails.

5. At each end of the rail, grasp the tab and pull *firmly* to open the hinge bracket.



- 6. Align the holes in the rail bracket with the holes on the front and rear rack cabinet flanges. Ensure that the rails are aligned on the inside of the rack cabinet.
- 7. On the rear of the rail, press the two bracket pins into the holes in the rack flanges.
- 8. Close the rear hinge bracket to secure the rail to the rack cabinet flange.



- 9. On the front of the rail, press the two bracket pins into the holes in the rack flanges.
- **10.** Close the front hinge bracket to secure the rail to the rack cabinet flange.
- **11.** Repeat Step 2 on page 2 through Step **10** on page 2 to secure the opposite rail to the rack cabinet.
- **12.** Repeat the procedure to install the rails for each additional control enclosure.

# **Installing enclosures**

Following your enclosure location plan, install the control enclosure (and optionally, one or more 2U expansion enclosures).

### Before you begin


#### CAUTION:




- This part or unit is heavy but has a weight smaller than 18 kg (39.7 lb). Use care when lifting, removing, or installing this part or unit. (C008)
- If drives are installed, at least three people are required to lift a control enclosure into the rack.
  - Load the rack from the bottom up to ensure rack stability. Empty the rack from the top down.

### Procedure

1. On either side of the drive assemblies, remove the enclosure end caps. Grasp the handle and pull the bottom of the end cap free. Then, clear the tab on the top of the enclosure.




- 2. Align the enclosure with the front of the rack cabinet.
- 3. Carefully lift and slide the enclosure into the rack along the rails until it is fully inserted.



**Note:** The rails are not designed to hold an enclosure that is partially inserted. Always fully insert the enclosure in the rack.

- 4. Secure the enclosure with a screw in each of the rack mounting screw holes.
- 5. Reinstall the left and right end caps.



- **a.** Ensure that the serial number of the end cap matches the serial number on the rear of the enclosure.
- **b.** Fit the slot on the top of the end cap over the tab on the chassis flange.
- c. Rotate the end cap down until it snaps into place.
- **d.** Ensure that the inside surface of the end cap is flush with the chassis.

**Note:** Indicator windows on the left end cap align with the status LEDs (light-emitting diodes) on the edge of the enclosure.

## **Connecting SAS cables**

This task applies if you are installing one or more SAS-attached 2U expansion enclosures to your system. For information about 5U expansion enclosures, see IBM Knowledge Center (https://ibm.biz/BdqxdY).

#### About this task

The following table summarizes the supported SAS chains and enclosures for each system. Before you connect SAS cables, read SAS cabling guidelines on page 4. Follow the guidelines to ensure that your configuration is valid.



### Procedure

- 1. Using the supplied SAS cables, complete the following steps to connect the control enclosure to the expansion enclosure.
  - a) Connect SAS port 1 of the left node canister in the control enclosure to SAS port 1 of the left expansion canister in the first expansion enclosure.
  - b) Connect SAS port 1 of the right node canister in the control enclosure to SAS port 1 of the right expansion canister in the first expansion enclosure.
- 2. On Storwize V5030E systems, complete the following steps to add a second expansion chain.
  - a) Connect SAS port 2 of the left node canister in the control enclosure to SAS port 1 of the left expansion canister in the second expansion enclosure.
  - b) Connect SAS port 2 of the right node canister in the control enclosure to SAS port 1 of the right expansion canister in the second expansion enclosure.
- 3. If more expansion enclosures are installed, connect each one to the previous expansion enclosure in a chain.

### Results

The following figures show SAS connections between 2U expansion enclosures and each system. SAS chain one (1) is below the control enclosure. If the system supports a second SAS chain, SAS chain two (2) is above the controle enclosure.




## SAS cabling guidelines

Review the following guidelines to ensure that your SAS connections and configuration are valid.

### **Orienting the connector**

When you insert SAS cables, make sure that the connector is oriented correctly.

- The orientation of the connector must match the orientation of the port before you push the connector into the port. The cable connector and socket are keyed and must be aligned when the cable is inserted.
- The blue pull tab must be **below** the connector.



- Insert the connector gently until it clicks into place. If you feel resistance, the connector might be oriented incorrectly. Do not force it.
- When inserted correctly, the connector can be removed only by pulling the tab.
- When both ends of a SAS cable are inserted correctly and power is connected, the green LEDs next to the SAS ports are lit.

### Guidelines

Review the following guidelines when you attach the cables to the SAS ports in 2U expansion enclosures.

- Ensure that cables are installed in an orderly way to reduce the risk of cable damage when replaceable units are removed or inserted.
- Do not connect a cable between a port on the left node canister and a port on the right node canister.
- Attach cables serially between enclosures; do not skip an enclosure.
- No more than 10 expansion enclosures can be chained to SAS port 1 of a node canister. The expansion enclosures in this chain must be installed below the control enclosure.
- For Storwize V5030E systems, no more than 10 expansion enclosures can be chained to SAS port 2 of a node canister. The expansion enclosures in this chain must be installed above the control enclosure.

If an odd number of expansion enclosures is attached to a control enclosure, SAS chain 1 must contain one more expansion enclosure than SAS chain 2 of the node canister.

- A port on the node canister must connect to one port on an expansion canister. Cables that split the connector into separate physical connections are not supported.
- Attach cables serially between enclosures; do not skip an enclosure.
- The last enclosure in a chain must not have cables in port 2 of canister 1 and port 2 of canister 2.

## **Connect networking cables**

To provide connectivity for the system, you must connect networking cables to the appropriate ports on the control enclosure.

Ethernet ports on each node canister provide system management connections and iSCSI host connectivity. The onboard 10 Gbps Ethernet ports use RJ-45 connections. The 10 Gbps ports operate at 1 Gbps when connected to a 1 Gbps switch. The technician port provides access to initialization and service assistant functions.

### Storwize V5010E onboard ports

Use the figure and the following table to identify the location and purpose of the onboard ports on the back of the Storwize V5010E system.

		After the system initializes, the technician port on port 2 is disabled. Port 2 can then be connected to the Ethernet switch for host iSCSI connectivity, IP replication, or to act as a second management port.

**Ethernet Port 2:** Do not connect onboard port 2 to an Ethernet switch until the system initialization or service is complete. After the system initializes, the technician port is automatically disabled; port 2 can then be connected to the Ethernet switch.

To use the technician port again, disconnect port 2 from the Ethernet switch. Enter the following command to re-enable the technician port:

satask chserviceip -techport enable

Before you reconnect port 2 to an Ethernet switch, disable the technician port. To do so, enter the following command:

satask chserviceip -techport disable

#### Storwize V5030E onboard ports


Use the figure and the following table to identify the location and purpose of the onboard ports on the back of the Storwize V5030E system.

### **Connecting Ethernet cables**

1. Connect Ethernet port 1 of each node canister to the IP network that provides the connection to the system management interfaces.



Ethernet port 1 can be used for iSCSI connectivity to the system by hosts on the network. If the Storwize V5030E system contains another control enclosure, ensure that port 1 of each node canister is connected to the same network to provide access if the configuration node fails.

2. On Storwize V5030E systems, you can optionally connect Ethernet port 2 of each node canister to a second IP network to provide a redundant connection to the system management interfaces.



Port 2 can also be used for iSCSI connectivity to the system by hosts on the network. If the system contains more than one control enclosure, ensure that port 2 of every node canister is connected to the same network to provide access if the configuration node fails.


### **Connecting other networking cables**

Each node canister in a control enclosure has one PCIe slot that can support one of the following optional networking adapters. The following figures show examples of the supported networking connections for each system.

**1.** Ensure that the appropriate networking adapters are installed in the PCIe slot of each node canister.

2. Ensure that the appropriate number and type of networking cables are connected to the ports on each node canister. Both node canisters must have the same number of cables connected.



# Powering on the system

After you install all hardware components, you must power on the system and check its status. Each control enclosure has two power supply units (PSUs). To provide redundancy in a power failure, connect the power cords to separate power circuits.



**Attention:** Do not power on the system with any open drive bays or host interface adapter slots. Open bays or PCIe slots disrupt the internal air flow, causing the drives to receive insufficient cooling. Filler panels must be installed in all empty drive bays and PCIe slots.

- 1. Ensure that the circuit breakers or switches of the power sources are turned on.
- 2. Ensure that each power cable is secured to each PSU on the back of the node. To do so, route each power cable through the retainer.

The cable retainer has a curved opening that faces the rear of the PSU. After you plug the power cable in to the PSU, slip the power cable behind the retainer. Pull the cable back into the retainer opening to secure it. Then, route each power cable through the cable retainer.



For PSU 1, hook the power cable underneath the cable retainer so the cable can extend to the left.

For PSU 2, make a loop to secure the cable under the retainer and extend the power cable to the right side of the node.

To remove a power cable, push the cable forward to unhook it from the cable retainer. Then, unplug the cable from the PSU.

- 3. Connect the PSUs of the control enclosure and each expansion enclosure to their power sources.
- 4. Check the status LED indicators to verify the status of the enclosure. The control enclosure is ready and running without critical errors when the LEDs indicate the following status.

## **Connecting a DC power supply**

A control enclosure that is DC powered contains two DC power supply units (PSUs). Each unit must be connected to a suitable -48V DC power source. To provide redundancy in a power circuit failure, connect the two PSUs to different DC power sources.

**Note:** The connection to the DC power source must be made by trained service personnel. Ensure that the connection is made in accordance with all the requirements of the equipment that is being used.

Use the supplied cables to connect the DC PSUs to the power sources. Use only the IBM supplied DC power cables to connect the unit to a DC power source. The supplied power must meet the following input requirements.

Requirement	Min	Мах

**Important:** Each PSU cable must be protected by a 20A circuit breaker that is separate from the DC power distribution unit. Read the documentation that is supplied with the DC power distribution unit and circuit breaker. Follow the instructions for connecting the circuit breaker to the power distribution unit and for connecting the DC power cable to the circuit breaker.

One end of the cable ends in a plug that fits the DC PSU. At the other end of the cable, the individual wires end with a 6 mm diameter ring terminal that is designed to fit an M6 stud. Provide adequate strain relief after you attach the ring terminals to the power source. The following table lists the wire colors.

If you need to replace the ring terminals with a different connector, choose a suitably sized and rated UL-listed connector that is appropriate for the wire gauge and available current. Install the ring terminals according to the instructions provided by the manufacturer.

Color	Function
Blue	Return
Green / Yellow	Ground
Brown	-48V

The DC power cables are 4 m long. They must be contained in one rack and must not extend outside the rack. Connect each cable to the DC power source before you connect it to the PSU. The PSU does not have a power switch. When power is connected, the outlets and the enclosure become live. Ensure that the cables are securely attached to the enclosure.

# Initializing the system

Storwize V5010E systems contain one I/O group (control enclosure). Storwize V5030E systems can contain two I/O groups (two control enclosures). To set up and initialize a new system, complete the following procedure and run the initialization tool. If you are adding a second Storwize V5030E control enclosure, go to Adding a Storwize V5030E control enclosure to an existing system on page 10.

## Before you begin

- Ensure that a supported browser is installed on a notebook computer.
  - Browser security features might prompt you to accept the self-signed certificate that the system issues.
  - You might need to remove old certificates that are stored in the browser before it accepts the request.
  - The web browser might display a warning about a potential security risk. It is safe to accept the risk and continue.
     See Browser considerations on page 10 for more information.
- Ensure that an Ethernet cable is available to connect the notebook computer to the technician port.
- After the technician port physical connection is completed (that is, connected both ends), it can take up to 45 seconds before the
  port is fully able to process requests. Submitting requests before this interval might result in 404 error responses.
- Do not connect the technician port to a switch. If a switch is detected, the technician port connection might shut down, causing a 746 node error.
- See Ethernet cable standards on page 11 for more information.

**Note:** If you are unable to connect to the system through the technician port, you can use the service assistant tool or the service CLI to initialize the system. To do so, complete the following steps.

### Procedure


**1.** Configure an Ethernet port on the notebook computer to enable Dynamic Host Configuration Protocol (DHCP) configuration of its IP address and DNS settings. If you do not have DHCP, use the following information to manually configure the notebook computer.

Static IPv4 Address	Subnet Mask	Gateway	DNS
192.168.0.2	255.255.255.0	192.168.0.1	192.168.0.1

2. Locate the Ethernet port that is labeled T on the rear of the node canister. On Storwize V5010E systems, Ethernet port 2 also serves as the technician port. Storwize V5030E systems have a dedicated technician port.

3. Connect an Ethernet cable between the port of the notebook computer and the technician port. The cable must be long enough to connect easily to the computer.



After the connection is made, the system automatically configures the IP and DNS settings for the notebook computer, if DHCP is available. If it is not available, the system uses the values that you provided in step 1 on page 8.

4. After the Ethernet port of the notebook computer is connected, open a supported browser and go to address http://install. The browser is automatically directed to the initialization tool.

If you do not have DCHP, open a supported browser and go to static IP address 192.168.0.1.

- **5.** Follow the instructions in the initialization tool to configure the system with a name and management IP address. Use the information that you provided in Management and service address worksheet on page 12.
- 6. If you experience a problem during the process due to a change in system states, wait 5 10 seconds. Then, either reopen the SSH connection or reload the service assistant.
- 7. After you complete the initialization process, disconnect the cable between the notebook computer and the technician port.
  - On Storwize V5010E systems, continue to step 8 on page 9.
- On Storwize V5030E systems, go to step 10 on page 9.
- 8. On Storwize V5010E systems, connect the notebook computer to the network.



Ethernet port 1 remains connected to the network, as shown. Ethernet port 2 no longer acts as the technician port.

9. Optional: On Storwize V5010E systems, connect onboard Ethernet port 2 to the network.



After the system initializes, the technician port is automatically disabled. Ethernet port 2 can then be connected to the Ethernet switch.

#### **10.** Enter the management IP address in a web browser to access the management GUI for the first time.

a) Log in with the following credentials to start the initial setup process.

### Using an alternative method to initialize the node

**11.** If you are unable to connect to the system through the technician port, you can use the service assistant tool or the service CLI to initialize the system. To do so, complete the following steps.

- **a.** Access the command line by using the credentials that are listed in Step 10 on page 9.
- **b.** Enter the following CLI command to create the system:

mkcluster -clusterip x.x.x.x -mask m.m.m.m -gw g.g.g.g -name name

## Adding a Storwize V5030E control enclosure to an existing system

If the system was set up on another Storwize V5030E control enclosure, do not install it again on this control enclosure. Instead, use the management GUI to add the control enclosure to the system. You cannot add a second control enclosure to a Storwize V5010E system.

### Procedure

- **1.** Install the support rails for the new control enclosure, as described in Installing support rails for the system on page 1.
- **2.** Install the new control enclosure in the rack, as described in Installing enclosures on page 3.
- 3. Connect the node canisters to the storage area network (SAN) or, if applicable to your system, to a 25 Gbps (or faster) Ethernet.
- 4. Configure the zoning on the SAN switches to allow Fibre Channel (FC) ports to connect to each other.
- 5. Start the management GUI on the existing system.
  - a) In the management GUI, select **Monitoring > System**.
  - b) On the System Overview page, select Add Enclosure.

When a new enclosure is cabled correctly to the system, the **Add Enclosure** action automatically displays on the **System - Overview** page. If this action does not appear, review the installation instructions to ensure that the new enclosure is cabled correctly.

- c) Complete the instructions in the Add Enclosures wizard until the control enclosure is added to the system.
- d) You can also add an enclosure by selecting **Add Enclosure** from the **System Actions** menu.
- 6. If two control enclosures are in the system, you must set up a quorum disk or application outside of the system. If the control enclosures lose communication with each other, the quorum disk prevents both I/O groups from going offline. For more information, see the "Configuring quorum" topic in the IBM Knowledge Center.

In addition, review the following considerations about browser security features and certificates.

- The web browser might display a warning about a potential security risk. It is safe to accept the risk and continue.
- After the technician port physical connection is completed (that is, connected both ends), it can take up to 45 seconds before the port is fully up and able to process requests. Submitting requests before this interval might result in 404 error responses.
- If the http://service request causes a 404 error or does not produce a response, you might need to use URL https:// 192.168.0.1 to connect to the system.

## **Installation worksheets**

Worksheets can help you plan and install the system. Complete the worksheets for each system that you are installing.

## Network cable connection worksheet

Use the following tables to plan and record the cable connections for each control enclosure in your system.

#### **Ethernet connections**

Each node canister in the control enclosure can contain up to six Ethernet ports. Review the following information about the ports. Then, record information about each Ethernet port connection for each node canister in the following table.

• Each control enclosure has two onboard Ethernet ports, which are labeled port 1 and port 2.

Ethernet port 1 of each node canister connects over an Ethernet cable to an enabled port on your Ethernet switch or router. Ethernet port 1 is used for accessing the management GUI, the service assistant GUI for the node canister, and iSCSI host attachment.

Optionally, you can attach an Ethernet cable from Ethernet port 2 on the canister to your Ethernet network. On Storwize V5010E systems, Ethernet port 2 also serves as the technician port. You must first disable port 2 from acting as a technician port before you can use it to access other functions. Storwize V5030E systems have a dedicated technician port.

- Ethernet ports 3 and 4 are present if an optional 2-port 25 Gbps Ethernet adapter (RoCE or iWARP) is installed. This adapter is used for iSCSI connections.
- Ethernet ports 3, 4, 5 and 6 are present if the optional 4-port 10 Gbps Ethernet adapter is installed. The 10 Gbps Ethernet host interface adapter can be used for iSCSI connections only.

### Ethernet cable standards

The following table describes Ethernet cable standards. Ethernet cables are not supplied as part of your order. Ensure the cables that are used meet the minimum standards for the Ethernet port type.
