Hyperconvergence, using the Simplivity platform has been adopted as an enterprise computing platform. OIT issued an RFP for this platform in 2018 and as a result, CyberNorth was awarded the contract. As requirements for increased growth in services, a corresponding growth in the infrastructure is also required. Also, as a result of the backup redesign, CyberNorth and OIT identified Cohesity as the backup solution. Cohesity, running on HPE's hyperconverged platform was determined to be the best fit. This will reduce the overall on-prem storage, as well as costs to our customers.

Due to the continuing need for increased capacity, making this contract a Master Agreement will allow the flexibility in acquiring the growth of the HPE hyperconverged platform and Cohesity.

Future requirements for these products will be executed as a Delivery Order. All agreements for services initiated during the duration of this Contract and whose performance and payment time frames extend past the end date of the then-current term of the contract shall remain in effect for performance and payment purposes only, limited to

the time frame and services established per each written agreement. No new agreements may be executed after the Contract has expired.

All other terms and conditions are consistent with those in Contract #18B-20181114*1658.
