- 1) Financial bid in the above format (on the Letter head of the bidder) along with one set of this tender document, duly signed and stamped by the bidder along with other required documents to be created in a single PDF file format and the said file must be password protected and to be submitted (along with password) by email at <a href="mailto:etender@mdim.ac.in">etender@mdim.ac.in</a> by 14/07/2020 on or before 3:00 pm.
- 2) All bids in which any of the prescribed conditions is not fulfilled or any condition is put forth or conditional bids by the bidder(s) shall be summarily rejected.
- 3) Payment: 100% payment will be released after successful delivery, installation/set up, necessary training and activation of the above license issued in the name of MANAGEMENT DEVELOPMENT INSTITUTE MURSHIDABAD.
- 4) Bidder's Criteria:
  - a) The bidders must be either original software developer (OSD) or its authorized educational partners/ channel partners/ solution providers.

- b) If bids are submitted by the authorized educational partners/channel partners/ solution providers, they are essentially required to submit valid authorization certificate/ LSP/ MAF from the OSD, failing which their bid(s) shall be rejected.
- 5) Validity: The quoted price of the bidders should valid up to 30 days from the date of opening of bids.
- 6) Delivery: The above licenses in whole must be issued and activated within 10 (ten) days w.e.f. the order issue date.

# 7) Support & Training:

- a) Set up/installation of Microsoft Team and other available application software in the package like Intune, Yammer, MS Forms etc. with necessary training must be provided by the agency.
- b) Any other technical help related to the above mentioned software license during the contract/renewal period as per requirement of the Institute should be provided by the bidder.
- c) The bidder should provide remote & telephonic support and as well as onsite support should be provided by the bidder in case troubleshot not resolved through remote/telephonic support.
- d) No additional cost will be paid by the Institute for the above mentioned points i.e. 7.a, 7.b & 7.c
- 8) LD Clause: If the bidder fails to deliver the required licenses in the above mentioned period, the penalty @1% per week of the total order value subject to the maximum of 10% of the total order value will be deducted. Alternatively the Order will be cancelled.
- 9) The bidder should not be blacklisted/ debarred or involved in any corrupt & fraudulent practices by any Central/ State Govt./ PSUs/ Quasi-Govt. Organisations/ Autonomous Body/ Private Organisation in India.
- 10) Sub contract is strictly not allowed, if found that sub-contracting have been done then the order will be summarily cancelled and no payment will be made to the vendor.
