The total number of prime and subcontracting dollars awarded, increased by almost \$1.7B or 29.8%. This increase is a testament to the growing availability of opportunities for small businesses at NASA.

Small Business Makes a BIG Difference: Launching Equity in Procurement is an opportunity for industry to learn how to do business with the Agency; and to engage with NASA prime contractors.


