RE: PETITION OF ALCHEMYBET LTD. TO CONTINUE TO CONDUCT INTERNET GAMING RELATED BUSINESS PURSUANT TO N.J.S.A. 5:12-92a(1) AND N.J.A.C. 13:69J-1.2B (PRN 0541801)

The Division of Gaming Enforcement ("Division") has completed its review of PRN 0541801, which seeks authorization for Alchemybet Ltd. ("Alchemybet"), an applicant for casino service industry enterprise ("CSIE") licensure, to continue to conduct internet gaming related business transactions with the following:

1. Resorts Digital Gaming, LLC (holder of Internet Gaming Permit NJIGP 17-008), pursuant to an April 25, 2017 Software as a Service Content License Agreement and a March 17, 2017 Equipment Colocation and Hosting Agreement, which were previously filed with the Division (previously PRN 2371704).
2. Marina District Development Company, LLC d/b/a Borgata Hotel Casino and Spa (holder of Internet Gaming Permit NJIGP 17-001) and Pala Interactive, LLC, a CSIE applicant, pursuant to a March 28, 2017 Software as a Service and Content License Agreement, which was previously filed with the Division (previously PRN 2561701).
3. Caesars Interactive Entertainment New Jersey, LLC (holder of Internet Gaming Permit NJIGP 17-007), pursuant to an April 5, 2017 Service and Content License Agreement, which was previously filed with the Division (previously PRN 1291702).
4. Golden Nugget Atlantic City, LLC (holder of Internet Gaming Permit NJIGP 17-002) and Rush Street Interactive, LLC, a CSIE applicant, pursuant to a March 24, 2017 Service and Content License Agreement, which was previously filed with the Division (previously PRN 0101802).

5. Golden Nugget Atlantic City, LLC, NYX Digital Gaming Americas (LLC), a CSIE applicant, and Spin Games, LLC, a CSIE licensee, pursuant to an October 24, 2017 Software as a Service and Content License Agreement, which was previously filed with the Division (previously PRN 3621701).

Therefore, pursuant to N.J.S.A. 5:12-92a(1) and N.J.A.C. 13:69J-1.2B, and for good cause shown, internet gaming related business transactions between the petitioner and the above casinos are deemed to be approved for a term to expire on August 25, 2018, subject to the continued approval of all product submissions by the Division's Technical Service Bureau as authorized by the issuance of an Approval Letter by the Director and subject further to the representations contained within the petition. This approval is further subject to each product submission's approval as required by the Division's Technical Service Bureau. It is further provided that any new business transacted pursuant to this approval be reported to the Division within the time frames set forth in N.J.A.C. 13:69J-1.2B(a)1iv. Further, petitioners must maintain and make available for inspection, upon demand by the Division, any records regarding the business transacted. Moreover, any changes to the current agreements must be reported to the Division within five (5) business days. The Division may reconsider the granting of this approval at any time.
