Dear Chairman Burns:

I am appointing Mr. Scott T. Anderson as the new State Liaison Officer to the U.S. Nuclear Regulatory Commission (NRC) from the State of Utah. Mr. Anderson is the Director of the newly created Utah Division of Waste Management and Radiation Control within the Department of Environmental Quality and is in a position within State government to convey to my office and other State agencies important and time-sensitive information provided by the NRC. Mr. Anderson is also in a position within Utah State government to be able to keep your agency informed of important radioactive materials regulatory, legislative and public interest issues as they occur within the state.

As the Governor-appointed State Liaison Officer, Mr. Anderson will also function as my State employee representative, as provided for in 10 CFR Part 73.59(e) of your regulations, for receipt of Safeguards Information (SGI) and Safeguards Information-Modified Handling (SGI-M) that may be transmitted by the NRC. Mr. Anderson has been informed of the protection requirements for SGI and SGI-M and will establish the controls necessary to maintain compliance with 10 CFR Parts 73.21 through 73.23 of your regulations. The Division of Waste Management and Radiation Control has instituted the necessary physical protection resources for properly storing SGI and SGI-M.


