





- Affix the ROK COA on server chassis prior to distribution





Deliver the Server

- Preinstall is Optional!
- Don't forget: Customers need to have the right number of CALs and Additional Licenses.
- Add CALs and Additional Licenses for Server ROK Products.

Because OEM licenses are tied to the hardware, VMs can't be moved between servers	OEM licenses never come with reassignment rights	OEM licenses don't come with downgrade rights	Software Assurance (SA) is not available with OEM licenses	A CAL is CAL, and they are backward compatible
While OS licenses are generally tied to the server hardware, VMs can be moved freely to other properly licensed servers	Windows Server 2016 Standard Additional Licenses can be reassigned to another server with a Standard Base license. Windows Datacenter has dedicated SKUs which include Reassignment Rights - customers can transfer their licenses once every 90 days	An end-user can downgrade an OEM license to previous Windows Server versions; Lenovo provides downgrade kits (Media + activation code= to the 2 previous Windows Server versions - often referred to as n-2 (WS 2019 → WS 2016 → WS 2012 R2)	A reseller or customer can attach SA to an OEM license within 90 days of purchase as long as it is the most current version. (→ SA attach is not possible for Windows Sever 2016 licenses anymore).	OEM CALs work with VL licenses and are also OEM/distribution model agnostic. Windows Server CALs are backward compatible but not upward.
