- (c) The Government may accept any item or group of items quoted, unless quoter qualifies the quote by specific limitations.
- (d) The Government intends to make an award based on initial submissions. Consequently, vendors are highly encouraged to quote their best nonprice and pricing quotes in their initial submissions. However, the Government reserves the right to communicate with any or all contractors submitting a quote, if it is determined advantageous to the Government to do so.
