Subject: Amendment- Delete unsupported uses: alfalfa, apples, apricots, asparagus, avocados, beans, beans (succulent), beets, carrots, cherries, clover, cotton, cucumber, eggplant, flax, grapes, guavas, lentils, mangos, melons, mushrooms, nectarines, okra, onion (dry bulb), peaches, pears, peas, pecans, peppers, pineapples, plums including prunes, pumpkins, quinces, safflower, soybeans, squash, strawberries, sudangrass, sugar beets, summer squash, sunflower, tomato, tobacco, ornamental plants, beef cattle, goats, hogs, horses, mules, sheep, and military use on human skin/clothing in response to EPA's GDE Revocation Notice dated January 15, 1999

Your submission dated February 22, 1999

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- 1. Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
  - a. In the Environmental Hazards, replace the second sentence with:
    "Do not discharge effluent containing this product into lakes,
    streams, ponds, estuaries, oceans, or other waters, unless in
    accordance with the requirements of a National Pollutant
    Discharge Elimination System (NPDES) permit and the permitting
    authority has been notified in writing prior to discharge.".

- b. In the second paragraph under the heading DIRECTIONS FOR USE, delete the crossed out word "See".
- c. In the DIRECTIONS FOR USE, delete items "(2)" and "(3)" and their associated text. Also, delete the remaining number "(1)", since there will only be one entry.
- d. In the STORAGE section delete the mark after "damaged" and the crossed out capital "S" before "stop".
- 3. Submit three (3) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.

#### STORAGE AND DISPOSAL
