The following amendment submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable:

• to revise the "first aid" per PR Notice 2001-1

Conditions

Revise the label as follows:

- 1. Under the "Environmental Hazards" Statement revise the first sentence to read: "This pesticide is toxic to fish and aquatic organisms".
- 2. Delete "Statement of Practical Treatment" and replace the heading with "FIRST AID".
- Please cite the source product or delete the use patterns for "Hand sanitizing" and "Shoe Bath Sanitizer".

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling

For disinfection remove gross filth or heavy soil. Apply IODIS with a cloth, mop or mechanical coarse spray device. When applied with a mechanical coarse spray device, surface must be sprayed until thoroughly wetted. Treated surfaces must remain wet for 10 minutes. Fresh solution should be prepared daily or more often if the solution becomes diluted or soiled.

IODIS is a proven "one-step" cleaner-disinfectant-sanitizer-deodorizer in the presence of moderate amounts of organic soil and 400 ppm hard water.

Disinfection-Hospitals, Veterinary Clinics, Other Health Care Institutions, Institutions, Industry, Schools, Farm Premises and Poultry Houses:

Remove gross fith or heavy soil. Apply 1/2 oz. per gallon IODIS to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, tile, porcelain and bed frames. Allow surfaces to remain wet for at least 10 minutes. For heavily soiled areas, a preliminary cleaning is required.

For farms and poultry use, prior to disinfection, all poultry, other animals and their feeds must be removed from the premises. This includes emptying all troughs, racks and other feeding and water appliances. Remove all litter and droppings from floors, walls and other surfaces occupied or traversed by poultry or other animals.

After 10 minutes disinfection, ventilate buildings, coop and other closed spaces. Do not house poultry, or other animals or employ equipment until treatment has been absorbed, set or dried.

Sanitizing—Meat and food processing equipment and utensils: Remove heavy soils by flushing, scraping, or mopping. Wash with 1 oz. per gallon of IODIS (or other good cleaner). Rinse with clean water and sanitize surfaces with 1 oz. IODIS per 5 gallons of water (25 ppm titratable iodine). Surface should remain in contact with solution for 1-2 minutes. Drain well and air dry. No potable water rinse is required.

Sanitizing Food Grade Egg Shells: To sanitize clean shell eggs intended for food or food products, spray with a solution of 1 ounce of product in 5 gallons of water (providing 25 ppm active). The solution must be equal to or warmer than the eggs, but not to exceed 130°F. Wet eggs thoroughly and allow to drain. Eggs that have been freshly washed may be sainitized with this compound only if the eggs are rinsed prior to application of the compound. A subsequent potable water rinse is not required. Eggs must be reasonably dry before casing or breaking. The solution must not be reused for sanitizing eggs.

Hand Sanitizing ~ in food handling and meat cutting operations. Rinse and immerse hands in a 1 oz. IODIS per 5 gals, of water solution (25 ppm titratable iodine).

Sanitizing Poultry Drinking Water - Add 1 ounce of IODIS per 10 gallons of drinking water (12.5 ppm titratable iodine).

Shoe Bath Sanitizer-To prevent tracking harmful organisms into animal areas, scrape shoes and place in a 3 oz. per gallon solution of IODIS for 30 seconds prior to entering area.

STATEMENT OF PRACTICAL TREATMENT

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes; remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye; call a poison control center or doctor for treatment advice. IF ON SKIN OR CLOTHING: Take off contaminated clothing; rinse skin immediately with plenty of water for 15-20 minutes; call a poison control center or doctor for treatment advice.

IF INHALED: Move person to fresh air.
